A BILL TO BE ENTITLED

2 AN ACT TO APPOINT MEMBERS OF THE PUBLIC TO THE BOARD OF
3 DIRECTORS OF THE NORTH CAROLINA PARTNERSHIP FOR CHILDREN,
4 INC., UPON THE RECOMMENDATION OF THE MAJORITY AND MINORITY
5 LEADERS OF THE SENATE AND THE HOUSE OF REPRESENTATIVES.

6 Whereas, G.S. 143B-168.12(a)(1)j. authorizes the General Assembly to
7 appoint a member of the public to the Board of Directors of the North Carolina
8 Partnership for Children, Inc., upon recommendation of the Majority Leader of the
9 Senate; and

10 Whereas, the Majority Leader of the Senate recommends that the General
11 Assembly appoint Charles Morris from Cumberland County to this position; and

12 Whereas, G.S. 143B-168.12(a)(1)k. authorizes the General Assembly to
13 appoint a member of the public to the Board of Directors of the North Carolina
14 Partnership for Children, Inc., upon recommendation of the Majority Leader of the
15 House of Representatives; and

16 Whereas, the Majority Leader of the House of Representatives recommends
17 that the General Assembly appoint Mary B. Harris of Chatham County to this position;
18 and

19 Whereas, G.S. 143B-168.12(a)(1)l. authorizes the General Assembly to
20 appoint a member of the public to the Board of Directors of the North Carolina
21 Partnership for Children, Inc., upon recommendation of the Minority Leader of the
22 Senate; and

23 Whereas, the Minority Leader of the Senate recommends that the General
24 Assembly appoint Samuel Scott Page of Rockingham County to this position; and

25 Whereas, G.S. 143B-168.12(a)(1)m. authorizes the General Assembly to
26 appoint a member of the public to the Board of Directors of the North Carolina
27 Partnership for Children, Inc., upon recommendation of the Minority Leader of the
28 House of Representatives; and

1 Whereas, the Minority Leader of the House of Representatives recommends
2 that the General Assembly appoint Richard Perkins of Rowan County to this position;
3 Now, therefore,

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.(a)** Charles Morris from Cumberland County is appointed to
6 the Board of Directors of the North Carolina Partnership for Children, Inc., upon the
7 recommendation of the Majority Leader of the Senate for a term beginning January 2,
8 2005, and ending January 1, 2008.

9 **SECTION 1.(b)** Mary B. Harris of Chatham County is appointed to the
10 Board of Directors of the North Carolina Partnership for Children, Inc., upon the
11 recommendation of the Majority Leader of the House of Representatives for a term
12 beginning January 2, 2005, and ending January 1, 2008.

13 **SECTION 1.(c)** Samuel Scott Page of Rockingham County is appointed to
14 the Board of Directors of the North Carolina Partnership for Children, Inc., upon the
15 recommendation of the Minority Leader of the Senate for a term beginning January 2,
16 2005, and ending January 1, 2008.

17 **SECTION 1.(d)** Richard Perkins of Rowan County is appointed to the
18 Board of Directors of the North Carolina Partnership for Children, Inc., upon the
19 recommendation of the Minority Leader of the House of Representatives for a term
20 beginning January 2, 2005, and ending January 1, 2008.

21 **SECTION 2.** This act is effective when it becomes law.
