A BILL TO BE ENTITLED

2 AN ACT TO AUTHORIZE THE ADDITION OF CARVERS CREEK STATE PARK  
3 TO THE STATE PARKS SYSTEM, AND TO AUTHORIZE THE ADDITION OF  
4 A STATE PARK IN THE HICKORY NUT GORGE/CHIMNEY ROCK AREA TO  
5 THE STATE PARKS SYSTEM.

6       Whereas, Section 5 of Article XIV of the Constitution of North Carolina  
7 states that it shall be a proper function of the State of North Carolina to acquire and  
8 preserve park, recreational, and scenic areas, and in every other appropriate way to  
9 preserve as a part of the common heritage of this State, its open lands and places of  
10 beauty; and

11       Whereas, the 1987 General Assembly enacted the State Parks Act, which  
12 declares that the State of North Carolina offers unique archaeological, geologic,  
13 biological, scenic, and recreational resources, and that these resources are part of the  
14 heritage of the people of the State, which should be preserved and managed by the  
15 people for their use and for the use of their visitors and descendants; and

16       Whereas, Carvers Creek and surrounding lands in Cumberland County  
17 include rolling hills, ravines, and narrow stream bottoms; support many rare plant and  
18 animal species; and possess biological, scenic, and recreational resources of statewide  
19 significance, and thus represent an excellent example of the natural features of the  
20 Sandhills Region of North Carolina; and

21       Whereas, the Hickory Nut Gorge/Chimney Rock area in and near western  
22 Rutherford County includes spectacular cliffs, rugged mountains, fissure caves, and  
23 waterfalls; supports many rare plant and animal species; and possesses biological,  
24 geological, scenic, and recreational resources of statewide significance; Now, therefore,  
25 The General Assembly of North Carolina enacts:

1           **SECTION 1.** The General Assembly authorizes the Department of  
2 Environment and Natural Resources to add Carvers Creek State Park to the State Parks  
3 System as provided by G.S. 113-44.14(b).

4           **SECTION 2.** The General Assembly authorizes the Department of  
5 Environment and Natural Resources to add a State park in the Hickory Nut  
6 Gorge/Chimney Rock area to the State Parks System as provided by G.S. 113-44.14(b).

7           **SECTION 3.** This act is effective when it becomes law.
