2	AN ACT TO ALLOW THE ISSUANCE OF OFF-PREMISES MALT BEVERAGE
3	AND UNFORTIFIED WINE PERMITS TO INCORPORATED
4	MUNICIPALITIES AFTER AN ELECTION ALLOWING THE SALE OF MIXED
5	BEVERAGES, AND TO AMEND THE LAW CONCERNING THE JANUARY 1,
6	2008, REQUIREMENT FOR CERTAIN ABC PERMITTEES TO RECYCLE
7	BEVERAGE CONTAINERS.
8	The General Assembly of North Carolina enacts:
9	SECTION 1. G.S. 18B-603(d)(3) reads as rewritten:
10	"(3) The Commission may issue off-premises malt beverage permits to any
11	establishment that meets the requirements under G.S. 18B-1001(2) in
12	any township or incorporated municipality which has voted to permit
13	the sale of mixed beverages, regardless of any other local act
14	concerning sales of those kinds of alcoholic beverages. The
15	Commission may also issue off-premises unfortified wine permits to
16	any establishment that meets the requirements under G.S. 18B-1001(4)
17	in any township or incorporated municipality which has voted to
18	permit the sale of mixed beverages, regardless of any other local act
19	concerning sales of those kinds of alcoholic beverages."
20	SECTION 2.(a) G.S. 18B-1006.1 reads as rewritten:
21	"§ 18B-1006.1. (Effective January 1, 2008) Additional requirement for certain
22	permittees to recycle beverage containers.
23	Holders of on-premises malt beverage permits, on-premises unfortified wine
24	permits, on-premises fortified wine permits, and mixed beverages permits shall
25	separate, store, and provide for the collection for recycling of all recyclable beverage
26	containers of all beverages sold at retail on the premises. A permittee has satisfied the
27	requirements of this subsection section if it implements a recycling program that meets
28	the minimum standards of the model recycling program developed by the Commission

pursuant to G.S. 130A-309.14(m). Failure to comply with the requirements of this 1 2 section shall not be grounds for revocation of a permit." 3 **SECTION 2.(b)** G.S. 18B-902 is amended by adding a new subsection to 4 read: 5 Each applicant for an on-premises malt beverage permit, on-premises "(h) 6 unfortified wine permit, on-premises fortified wine permit, or a mixed beverages permit 7 shall prepare and submit with the application a plan for the collection and recycling of 8 all recyclable beverage containers of all beverages to be sold at retail on the premises." 9 **SECTION 2.(c)** G.S. 18B-903 is amended by adding a new subsection to 10 read: 11 "(b2) Each person holding an on-premises malt beverage permit, on-premises 12 unfortified wine permit, on-premises fortified wine permit, or a mixed beverages permit 13 shall submit, along with the annual registration or renewal application, a current plan for 14 the collection and recycling of all recyclable beverage containers of all beverages sold 15 at retail on the premises." **SECTION 2.(d)** A permittee who is not able to find a recycler for its 16 17 beverage containers by January 1, 2008, may apply to the Alcoholic Beverage Control 18 Commission for a one-year stay of the requirement to implement a recycling program in 19 compliance with G.S. 18B-1006.1 as enacted by Section 1 of S.L. 2005-348. The 20 application shall be made in a form specified by the Commission and shall detail the 21 efforts made by the permittee to provide for the collection and recycling of beverage 22 containers and specify the impediments to implementation of a recycling plan. The 23 Commission shall submit all such applications to the Division of Pollution Prevention 24 and Environmental Assistance of the Department of Environment and Natural 25 Resources for review and certification. The Division of Pollution Prevention and 26 Environmental Assistance shall investigate each application and shall prepare a 27 summary of its investigation and submit the summary to the Commission along with a 28 notation indicating certification or denial of the application. A permittee whose 29 application for a stay is certified by The Division of Pollution Prevention and 30 Environmental Assistance shall not be required to comply with alcoholic beverage laws 31 and regulations concerning recycling requirements before January 1, 2009.

SECTION 3. This act is effective when it becomes law.
