A BILL TO BE ENTITLED

1 AN ACT TO APPROPRIATE FUNDS TO THE DEPARTMENT OF HEALTH AND
2 HUMAN SERVICES, DIVISION OF PUBLIC HEALTH, FOR PEDIATRIC
3 DIABETES EDUCATION AND PREVENTION SERVICES.

5 Whereas, diabetes is the second most common chronic disease of childhood,
6 and the current obesity epidemic has resulted in an unprecedented rise in Type 2
7 diabetes among children, a trend that is entirely preventable; and

8 Whereas, the North Carolina Department of Health and Human Services
9 reports that as many as 26% of North Carolina children ages 12-19 are overweight,
10 compared to 15% nationally; and

11 Whereas, North Carolina health care providers have found an increasing
12 number of children presenting at outpatient clinics, emergency departments, and
13 inpatient pediatric units with undiagnosed and poorly managed diabetes; and

14 Whereas, the economic impact in North Carolina of obesity and Type 2
15 diabetes related to unhealthy lifestyles is estimated to be more than \$24 billion dollars;
16 and

17 Whereas, Wake County has developed a successful pediatric diabetes
18 screening, education and prevention program, through a collaborative partnership
19 among WakeMed Health & Hospitals, the triangle YMCAs, the Wake County Public
20 School System, and the Wake County Public Health Department, among others; and

21 Whereas, this Wake community-based program has screened over 1,200
22 children and diagnosed over 500 children with pre-diabetes, 73% of whom are now
23 enrolled in an education and exercise program that teaches at-risk children and their
24 families how to adopt healthy lifestyles with the goal of preventing Type 2 diabetes and
25 its complications; and

1 Whereas, within six months of enrollment in the Wake County prevention
2 program, 50% of the program participants have seen a decrease in weight, have normal
3 blood sugar levels, exercise more, and have developed healthier nutritional habits; and

4 Whereas, coordinated screening, educational outreach, and prevention
5 services help reduce the number of undiagnosed and poorly managed cases of pediatric
6 diabetes and thereby help reduce overall health care costs for North Carolina
7 communities; Now, therefore,

8 The General Assembly of North Carolina enacts:

9 **SECTION 1.** There is appropriated from the General Fund to the
10 Department of Health and Human Services, Division of Public Health, the sum of five
11 hundred thousand dollars (\$500,000) for the 2007-2008 fiscal year. These funds shall
12 be used to support the development and expansion of community-based pediatric
13 diabetes education and prevention programs. The Division of Public Health may use a
14 portion of these funds to contract with a third-party nonprofit provider to facilitate the
15 development or the expansion of the programs.

16 **SECTION 2.** This act becomes effective July 1, 2007.
