Sponsors: Committee on Rules, Calendar, and Operations of the House. Referred to: August 1, 2007 A JOINT RESOLUTION SETTING THE TIME FOR ADJOURNMENT OF THE 2007 GENERAL ASSEMBLY TO MEET IN 2008 AND LIMITING THE SUBJECTS THAT MAY BE CONSIDERED IN THAT SESSION. Be it resolved by the House of Representatives, the Senate concurring: **SECTION 1.** When the Senate and the House of Representatives adjourn on Thursday, August 2, 2007, they stand adjourned to reconvene on Tuesday, May 13, 2008, at 12:00 noon. **SECTION 2.** During the regular session that reconvenes on Tuesday, May 13, 2008, only the following matters may be considered: Bills directly and primarily affecting the State budget, including the (1) budget of an occupational licensing board, for fiscal year 2008-2009, provided that the bill must be submitted to the Bill Drafting Division of the Legislative Services Office no later than 4:00 P.M. Friday, May 16, 2008, and must be introduced in the House of Representatives or filed for introduction in the Senate no later than 4:00 P.M. Tuesday, May 27, 2008. Bills and resolutions introduced in 2007 and having passed third (2) reading in 2007 in the house in which introduced, received in the other house in accordance with Senate Rule 41 or House Rule 31.1(d) as appropriate, and not disposed of in the other house by tabling, unfavorable committee report, indefinite postponement, or failure to pass any reading, and which do not violate the rules of the receiving house. (3) Bills and resolutions implementing the recommendations of: Study commissions, authorities, and statutory commissions authorized or directed to report to the 2008 Session; The General Statutes Commission, the Courts Commission, or h. any commission created under Chapter 120 of the General Statutes that is authorized or directed to report to the General

Wednesday, May 28, 2008, and is accompanied by a certificate signed by the principal sponsor stating that no public hearing will be required or asked for by a member on the bill, the bill is noncontroversial, and that the bill is approved for introduction by each member of the House of Representatives and Senate whose district includes the area to which
