The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 166A-14 reads as rewritten:

## "§ 166A-14. Immunity and exemption.

- (a) All functions hereunder and all other activities relating to emergency management are hereby declared to be governmental functions. Neither the State nor any political subdivision thereof, nor, except in cases of willful misconduct, gross negligence or bad faith, any emergency management worker worker, firm, partnership, association, or corporation complying with or reasonably attempting to comply with this Article or any order, rule or regulation promulgated pursuant to the provisions of this Article or pursuant to any ordinance relating to any emergency management measures enacted by any political subdivision of the State, shall be liable for the death of or injury to persons, or for damage to property as a result of any such activity.
- (a1) The immunity provided to firms, partnerships, associations, or corporations, under subsection (a) of this section is subject to all of the following conditions:
  - (1) The immunity applies only when the firm, partnership, association, or corporation is acting without compensation or with compensation

limited to no more than actual expenses, and one of the following 1 2 applies: 3 Emergency management services are provided at any place in a. this State during a state of disaster or state of emergency 4 5 declared by the Governor pursuant to this Article or 6 G.S. 14-288.15, and the services are provided under the 7 direction and control of the Secretary of the Department of 8 Crime Control and Public Safety pursuant to G.S. 166A-5, 9 166A-6, and 143B-476, or the Governor. 10 Emergency management services are provided during a local b. 11 state of emergency declared pursuant to Article 36A of Chapter 12 14 of the General Statutes, and the services are provided under the direction and control of the governing body of any 13 municipality under G.S. 14-288.12 and G.S. 166A-8, the 14 15 governing body of any county under G.S. 14-288.13 and G.S. 166A-8, or the chair of any board of county commissioners 16 17 under G.S. 14-288.14 and G.S. 166A-8. 18 The firm, partnership, association, or corporation is engaged in <u>c.</u> 19 planning, preparation, training, or exercises with the Division of 20 Emergency Management, the Division of Public Health, or the 21 governing body of each county or municipality under G.S. 166A-7 and G.S. 166A-8 related to the performance of 22 23 emergency management services or measures. 24 The immunity shall not apply to any firm, partnership, association, or (2) 25 corporation, or to any employee or agent thereof, whose act or omission caused in whole or in part the actual or imminent disaster or 26 27 emergency or whose act or omission necessitated emergency 28 management measures. 29 To the extent that any firm, partnership, association, or corporation has <u>(3)</u> 30 liability insurance, that firm, partnership, association, or corporation 31 shall be deemed to have waived the immunity to the extent of the 32 indemnification by insurance for its negligence. 33 The rights of any person to receive benefits to which the person would 34 otherwise be entitled under this Article or under the Workers' Compensation Law or 35 under any pension law, and the right of any such person to receive any benefits or 36 compensation under any act of Congress shall not be affected by performance of 37 emergency management functions. 38 Any requirement for a license to practice any professional, mechanical or 39 other skill shall not apply to any authorized emergency management worker who shall, 40 in the course of performing the worker's duties as such, practice such professional, 41 mechanical or other skill during a state of disaster. 42 As used in this section, the term "emergency management worker" shall 43 include any full or part-time paid, volunteer or auxiliary employee of this State or other
