17	<u>(</u> .	Reimbursement percentage. – The percentage of the actual amount			
18		expended during the previous fiscal year by a county for claims filed			
19		with that county's veterans service program that is to be reimbursed by			
20		the Department.			
21	<u>(b)</u> <u>T</u>	The Department shall contribute to each county an amount on a matching			
22	basis for any fiscal year for the maintenance and operation of a county veterans service				
23	program. The amount of the contribution shall be two thousand dollars (\$2,000) or the
