A BILL TO BE ENTITLED

1  
2 AN ACT TO CHANGE THE NC GREEN BUSINESS FUND FROM A  
3 GRANT-MAKING FUND TO A NO-INTEREST LOAN-MAKING FUND AND  
4 TO APPROPRIATE FUNDS TO THE DEPARTMENT OF COMMERCE FOR  
5 THE NC GREEN BUSINESS FUND.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** Part 2B of Article 10 of Chapter 143B of the General Statutes  
8 reads as rewritten:

9 "Part 2B. NC Green Business Fund.

10 "**§ 143B-437.4. NC Green Business Fund established as a special revenue fund.**

11 (a) Establishment. – The NC Green Business Fund is established as a special  
12 revenue fund in the Department of Commerce, and the Department shall be responsible  
13 for administering the Fund.

14 (b) Purposes. – Moneys in the NC Green Business Fund shall be allocated  
15 pursuant to this subsection. The Department of Commerce shall make ~~grants-no-interest~~  
16 loans from the Fund to private businesses with less than 100 employees, nonprofit  
17 organizations, local governments, and State agencies to encourage the expansion of  
18 small to medium size businesses with less than 100 employees to help grow a green  
19 economy in the State. Moneys in the NC Green Business Fund shall be used for projects  
20 that will focus on the following three priority areas:

- 21 (1) To encourage the development of the biofuels industry in the State.  
22 The Department of Commerce may make ~~grants-no-interest loans~~  
23 available to maximize development, production, distribution, retail  
24 infrastructure, and consumer purchase of biofuels in North Carolina,  
25 including ~~grants-no-interest loans~~ to enhance biofuels workforce  
26 development.

1 (2) To encourage the development of the green building industry in the  
2 State. The Department of Commerce may make ~~grants~~no-interest  
3 loans available to assist in the development and growth of a market for  
4 environmentally conscious and energy efficient green building  
5 processes. ~~Grants~~No-interest loans may support the installation,  
6 certification, or distribution of green building materials; energy audits;  
7 and marketing and sales of green building technology in North  
8 Carolina, including ~~grants~~no-interest loans to enhance workforce  
9 development for green building processes.

10 (3) To attract and leverage private-sector investments and entrepreneurial  
11 growth in environmentally conscious clean technology and renewable  
12 energy products and businesses, including ~~grants~~no-interest loans to  
13 enhance workforce development in such businesses.

14 **"§ 143B-437.5. Green Business Fund Advisory Committee.**

15 The Department of Commerce may establish an advisory committee to assist in the  
16 development of the specific selection criteria and the ~~grant-making~~loan-making process  
17 of the NC Green Business Fund.

18 **"§ 143B-437.6. Agreements required.**

19 Funds may be disbursed from the NC Green Business Fund only in accordance with  
20 agreements entered into between the Department of Commerce and an eligible  
21 ~~grantee~~loan recipient. Each agreement must contain the following provisions:

- 22 (1) A description of the acceptable uses of ~~grant~~loan proceeds. The  
23 agreement may limit the use of funds to specific purposes or may  
24 allow the funds to be used for any lawful purposes.
- 25 (2) A provision allowing the Department of Commerce to inspect all  
26 records of the business that may be used to confirm compliance with  
27 the agreement or with the requirements of this Part.
- 28 (3) A provision establishing the method for determining compliance with  
29 the agreement.
- 30 (4) A provision establishing a schedule for disbursement of loan funds  
31 under the agreement.
- 32 (5) A provision requiring recapture of ~~grant~~loan funds if a ~~grantee~~loan  
33 recipient subsequently fails to comply with the terms of the agreement.
- 34 (6) Any other provision the State finds necessary to ensure the proper use  
35 of State funds.

36 **"§ 143B-437.7. Program guidelines.**

37 The Department of Commerce shall develop guidelines related to the administration  
38 of the NC Green Business Fund and to the selection of projects to receive allocations  
39 from the Fund, including project evaluation measures. At least 20 days before the  
40 effective date of any guidelines or nontechnical amendments to guidelines, the  
41 Department of Commerce must publish the proposed guidelines on the Department's  
42 Web site and provide notice to persons who have requested notice of proposed  
43 guidelines. In addition, the Department must accept oral and written comments on the  
44 proposed guidelines during the 15 business days beginning on the first day that the

1 Department has completed these notifications. For the purpose of this section, a  
2 technical amendment is either of the following:

- 3 (1) An amendment that corrects a spelling or grammatical error.
- 4 (2) An amendment that makes a clarification based on public comment  
5 and could have been anticipated by the public notice that immediately  
6 preceded the public comment.

7 **"§ 143B-437.8. Reports.**

8 ~~Grants made to non-State entities through the NC Green Business Fund shall be~~  
9 ~~subject to the oversight and reporting requirements of G.S. 143C-6-23.~~ The Department  
10 of Commerce shall conduct an annual audit review of each NC Green Business Fund  
11 loan recipient to assess project quality assurance. The Department of Commerce shall  
12 publish a report on the commitment, disbursement, and use of funds allocated from the  
13 NC Green Business Fund at the end of each fiscal year. The report is due no later than  
14 September 1 and must be submitted to the following:

- 15 (1) The Joint Legislative Commission on Governmental Operations.
- 16 (2) The chairs of the House of Representatives and Senate Finance  
17 Committees.
- 18 (3) The chairs of the House of Representatives and Senate Appropriations  
19 Committees.
- 20 (4) The Fiscal Research Division of the General Assembly."

21 **SECTION 2.** There is appropriated from the General Fund to the  
22 Department of Commerce the sum of two million dollars (\$2,000,000) for the  
23 2008-2009 fiscal year for the NC Green Business Fund to provide no-interest loans to  
24 private businesses with less than 100 employees, nonprofit organizations, local  
25 governments, and State agencies to encourage the expansion of small- to medium-sized  
26 businesses with less than 100 employees to help grow a green economy in the State.

27 **SECTION 3.** Section 1 of this act is effective when it becomes law. Section  
28 2 of this act becomes effective July 1, 2008.
