A BILL TO BE ENTITLED

2 AN ACT TO PROVIDE FOR A PUBLIC ALERT TO BE ISSUED WHEN A  
3 PERSON WITH DEMENTIA OR OTHER COGNITIVE IMPAIRMENT IS  
4 REPORTED MISSING.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 143B-499.1 reads as rewritten:

7 "**§ 143B-499.1. Dissemination of missing persons data by law-enforcement**  
8 **agencies; statewide alert for persons with dementia reported as missing.**

9 (a) A law-enforcement agency, upon receipt of a missing person report by a  
10 parent, spouse, guardian, or legal custodian, shall immediately make arrangements for  
11 the entry of data about the missing person or missing child into the national missing  
12 persons file in accordance with criteria set forth by the FBI/NCIC, immediately inform  
13 all of its on-duty law-enforcement officers of the missing person report, initiate a  
14 statewide broadcast to all appropriate law-enforcement agencies to be on the lookout for  
15 the individual, and transmit a copy of the report to the Center.

16 (b) If the report involves a missing child and the report meets the criteria  
17 established in G.S. 143B-499.7(b), as soon as practicable after receipt of the report, the  
18 law enforcement agency shall notify the Center and the National Center for Missing and  
19 Exploited Children of the relevant data about the missing child.

20 (c) If the report involves a missing person who is believed to be suffering from  
21 dementia or other cognitive impairment, for the protection of the missing person from  
22 potential abuse or other physical harm, neglect, or exploitation, the Center shall issue  
23 an alert providing for rapid dissemination of information statewide regarding the  
24 missing person. The Center shall make every effort to disseminate the information as  
25 quickly as possible when the missing person is 18 years of age or older, and the person's  
26 status as missing has been reported to a law enforcement agency.

1        The Center shall adopt guidelines and develop procedures for issuing an alert for  
2 missing persons believed to be suffering from dementia or other cognitive impairment  
3 and shall provide education and training to encourage radio and television broadcasters  
4 to participate in the alert. The guidelines and procedures shall ensure that specific health  
5 information about the missing person is not made public through the alert or otherwise.

6        The Center shall consult with the Department of Transportation and develop a  
7 procedure for the use of overhead permanent changeable message signs to provide  
8 information on the missing adult meeting the criteria of this subsection when  
9 information is available that would enable motorists to assist in the recovery of the  
10 missing person. The Center and the Department of Transportation shall develop  
11 guidelines for the content, length, and frequency of any message to be placed on an  
12 overhead permanent changeable message sign."

13                **SECTION 2.** This act is effective when it becomes law.
