Short Title: Wake School Board Elections.

A BILL TO BE ENTITLED

AN ACT TO REQUIRE MEMBERS OF THE WAKE COUNTY BOARD OF
EDUCATION TO RESIDE IN THE DISTRICTS THEY REPRESENT, BUT TO
PROVIDE THAT THE VOTERS OF THE ENTIRE COUNTY SHALL ELECT
ALL MEMBERS, AND TO MOVE THOSE ELECTIONS TO THE
EVEN-NUMBERED YEAR, TO BE ELECTED IN NOVEMBER ON A
PLURALITY BASIS.

8 The General Assembly of North Carolina enacts:

9 SECTION 1. Section 7 of Chapter 717, Session Laws of 1975, as amended
10 by Sections 2 and 3 of Chapter 321, Session Laws of 1977, and as rewritten by Section
11 3 of Chapter 742 of the 1981 Session Laws, reads as rewritten:

"Sec. 7.(a) In <u>1981, 2008</u> and biennially thereafter, members of the Wake County Board of Education shall be elected by the nonpartisan <u>election and runoff plurality</u> election method in accordance with <u>G.S. 163 279(a)(4)</u>, <u>G.S. 163 293</u>, and <u>G.S. G.S. 163-279(a)(1)</u>, <u>163-163-292</u>, and <u>163-294.2</u>, except that only persons who are registered to vote in the district shall be permitted to file a notice of candidacy for election in that district. Such election shall be governed by the provisions of Chapter 163 of the General Statutes.

(b) The qualified voters of each district shall elect a person who resides in that
 district for the seat apportioned to that district. Only the qualified voters of the district
 may vote in that election. Members shall reside in and represent the districts, but the
 qualified voters of the entire county shall elect all members of the board."

SECTION 2. Section 6 of Chapter 717, Session Laws of 1975, as amended
 by Section 1 of Chapter 321, Session Laws of 1977, and as rewritten by Section 3 of
 Chapter 742 of the 1981 Session Laws, reads as rewritten:

"Sec. 6. All terms of office of members of the Wake County Board of Education
shall begin on the first Monday in December following their election. Districts 1, 2, 7,
and 9 shall elect a member in <u>19812010</u> and quadrennially thereafter for a four-year

1	term. Districts 3, 4, 5, 6, and 8 shall elect a member in 1981 for a two-year term and in
2	1983-2008 and quadrennially thereafter for a four-year term."
3	SECTION 3. The terms of office of members of the Wake County Board of
4	Education elected in 2003 for terms to expire in 2007 are extended until the first
5	Monday in December of 2008. The terms of office of members of the Wake County
6	Board of Education elected in 2005 for terms to expire in 2009 are extended until the
7	first Monday in December of 2010.
8	SECTION 4. This act is effective when it becomes law.
