3 The General Assembly of North Carolina enacts:

4 **SECTION 1.** G.S. 97-80 is amended by adding three new subsections to 5 read:

The Commission may conduct a hearing to determine whether an employee is 6 "(i) 7 competent to represent himself or herself at any proceeding under this Article. Prior to 8 the hearing under this subsection, the Commission shall appoint a guardian ad litem and 9 may order the employee to undergo a diagnostic evaluation by a State, local, regional, 10 or area mental health, public health, social service, or developmental disability agency. 11 If the Commission finds by clear and convincing evidence that the employee is not 12 competent to represent himself or herself at any proceeding under this Article, the 13 Commission may appoint a guardian ad litem and counsel to represent the employee in 14 any other proceedings under this Article. The Commission may by rule adopt standards 15 and procedures to implement this subsection. The Commission may determine that a party is an indigent if it finds that a 16 (i) 17 party is financially unable to secure legal representation and to provide all other necessary expenses of representation in any proceeding under this Article. When the 18 19 Commission determines a party is indigent under this subsection, the Commission shall 20 request the Office of Indigent Defense Services to appoint an attorney to represent the 21 indigent party, and the Commission may order the payment of the attorney's fees from 22 the Indigent Persons' Attorney Fee Fund in accordance with rules adopted by the Office 23 of Indigent Defense Services. The Commission may by rule adopt standards and 24 procedures to implement this subsection. 25 The Commission may resolve disputes regarding attorneys' fees between two (k) 26 or more attorneys representing the same party in a claim under this Article, and the 27 Commission may by order apportion the award of attorneys' fees among these 28 attorneys." 29 **SECTION 2.** G.S. 97-84 reads as rewritten:

## "§ 97-84. Determination of disputes by Commission or deputy. 1

2 The Commission or any of its members shall hear the parties at issue and their 3 representatives and witnesses, and shall determine the dispute in a summary manner. 4 The award, together with a statement of the findings of fact, rulings of law, and other 5 matters pertinent to the questions at issue shall be filed with the record of the 6 proceedings, within 180 days of the close of the hearing record hearing, unless time is 7 extended for good cause by order of the Chairman of the Commission, and a copy of the 8 award shall immediately be sent to the parties in dispute. The parties may be heard by a 9 deputy, in which event the hearing shall be conducted in the same way and manner 10 prescribed for hearings which are conducted by a member of the Industrial Commission, 11 and said deputy shall proceed to a complete determination of the matters in dispute, file 12 his written opinion within 180 days of the close of the hearing record hearing, unless 13 time is extended for good cause by order of the Chairman of the Commission, and the 14 deputy shall cause to be issued an award pursuant to such determination." 15

**SECTION 3.** G.S. 97-88.2 is amended by adding a new subsection to read:

16 "(b1) Persons performing investigations under subdivision (1) of subsection (b) of 17 this section have the authority to make arrests and obtain and serve warrants in 18 accordance with rules adopted by the Commission."

19 **SECTION 4.** This act is effective when it becomes law and applies to claims 20 for compensation filed on or after that date.
