5 **SECTION 1.** G.S. 7A-60(a1) reads as rewritten:

6 "(a1) The counties of the State are organized into prosecutorial districts, and each  
7 district has the counties and the number of full-time assistant district attorneys set forth

40           **SECTION 2.** There is appropriated from the General Fund to the Judicial  
41 Department the sum of eight hundred thirty thousand one hundred seventy-six dollars  
42 (\$830,176) to establish eight additional assistant district attorney positions for  
43 Prosecutorial District 26.
