2	AN ACT TO APPROPRIATE FUNDS TO IMPLEMENT THE	
3	RECOMMENDATIONS OF THE STROKE ADVISORY COUNCIL OF THE	
4	JUSTUS-WARREN HEART DISEASE AND STROKE PREVENTION TASK	
5	FORCE.	
6	Whereas, the Stroke Advisory Council was established by the Justus-Warren	
7	Heart Disease and Stroke Prevention Task Force to advise the Task Force regarding the	
8	development of a statewide system of stroke care; and	
9	Whereas, North Carolina is one of only four states funded by the Centers for	
10	Disease Control and Prevention (CDC) to operate a stroke registry within the Paul	
11	Coverdell National Stroke Registry initiative; and	
12	Whereas, the North Carolina Collaborative Stroke Registry has received	
13	commendations from the CDC for stroke care performance measures and the sustained	
14	improvement in quality that has been achieved by participating NC registry hospitals;	
15	and	
16	Whereas, monitoring care for stroke patients is an essential component of any	
17	system of care in this State; and	
18	Whereas, timely and appropriate stroke treatment is essential to improving	
19	stroke patient outcomes; and	
20	Whereas, it is critical to engage community groups in high need areas to	
21	assist in disseminating and reinforcing awareness messages and materials; Now,	
22	therefore,	
23	The General Assembly of North Carolina enacts:	
24	SECTION 1. The General Assembly supports the recommendations of the	
25	Stroke Advisory Council, as approved by the Justus-Warren Heart Disease and Stroke	
26	Prevention Task Force. To this end, certain of the Stroke Advisory Council's

(1) The Justus-Warren Heart Disease and Stroke Prevention Task Force shall work with health care providers across the State to establish a system of regionally distributed and locally determined stroke care networks for the State.

(2) The Stroke Advisory Council shall include in its comprehensive plan for 2008 a process for identifying and disseminating information about Joint Commission on Accreditation of Healthcare Organizations (JCAHO) certified primary stroke centers in order to assist in the configuration and operation of regional systems of stroke care.

SECTION 2.(a) There is appropriated from the General Fund to the Department of Health and Human Services, Division of Public Health, the sum of four hundred thousand dollars (\$400,000) for the 2007-2008 fiscal year and the sum of four hundred thousand dollars (\$400,000) for the 2008-2009 fiscal year. These funds shall be used to match existing federal funds for the NC Collaborative Stroke Registry to increase North Carolina hospital participation in the registry, particularly those hospitals in high stroke/low resource areas of the State.

19 SECTION 2.(b) There is appropriated from the General Fund to the 20 Department of Health and Human Services, Division of Public Health, the sum of one 21 hundred fifty thousand dollars (\$150,000) for the 2007-2008 fiscal year and the sum of 22 one hundred fifty thousand dollars (\$150,000) for the 2008-2009 fiscal year. These 23 funds shall be allocated to the Heart Disease and Stroke Prevention Branch to contract 24 with Area Health Education Centers (AHEC) to work with the North Carolina 25 Collaborative Stroke Registry to develop and carry out professional workforce 26 development, training, and communications initiatives among hospitals, emergency 27 medical services responders, 911 operators, and other stakeholders.

SECTION 2.(c) There is appropriated from the General Fund to the Department of Health and Human Services, Division of Public Health, the sum of three hundred thousand dollars (\$300,000) for the 2007-2008 fiscal year and the sum of three hundred thousand dollars (\$300,000) for the 2008-2009 fiscal year. These funds shall be allocated to the Heart Disease and Stroke Prevention Branch for the development and implementation of public awareness campaigns and communication strategies on stroke signs and symptoms and the importance of immediate response.

35 SECTION 2.(d) There is appropriated from the General Fund to the 36 Department of Health and Human Services, Division of Public Health, the sum of ten 37 thousand dollars (\$10,000) for the 2007-2008 fiscal year and the sum of ten thousand 38 dollars (\$10,000) for the 2008-2009 fiscal year. These funds shall be allocated to the 39 Heart Disease and Stroke Prevention Branch to conduct a follow-up survey and gap 40 analysis designed to provide a current assessment of stroke prevention and treatment 41 services in the State. The purpose of these funds is to assist in the development of a 42 comprehensive stroke care system plan.

43 **SECTION 2.(e)** There is appropriated from the General Fund to the 44 Justus-Warren Heart Disease and Stroke Prevention Task Force the sum of fifty

- 1 thousand dollars (\$50,000) for the 2007-2008 fiscal year and the sum of fifty thousand
- dollars (\$50,000) for the 2008-2009 fiscal year. These funds shall be allocated for
 operations of the Stroke Advisory Council.
- 4 **SECTION 3.** Section 2 of this act becomes effective July 1, 2007. The 5 remainder of this act is effective when it becomes law.
