**H 98. LICENSE RENEWAL/DEPLOYING RESERVISTS.** Filed 2/10/09. *TO AUTHORIZE A MEMBER OF THE RESERVE COMPONENTS OF THE ARMED FORCES TO RENEW A DRIVERS LICENSE UPON RECEIPT OF DEPLOYMENT ORDERS AND TO ALLOW A THIRTY-DAY GRACE PERIOD FOR AN EXPIRED LICENSE UPON RELEASE FROM ACTIVE DUTY.*

Enacts a new GS 20-4.01(33c) to add a definition for the *Reserve components of the Armed Forces of the United States*. Amends GS 20-7(f) to authorize the Division of Motor Vehicles to (1) renew a drivers license, without limitation on the time period before expiration, if the applicant is a member of a reserve component of the US Armed Forces and provides orders showing deployment on active duty stationed outside the state and (2) consider an expired license valid for 30 days after the release date of a reserve component member, upon showing proof of that date, if the license expired while the reserve component member was deployed on active duty outside the state, unless the license was rescinded, revoked, or otherwise invalidated under some other provision of law. Makes a conforming change. Makes technical and conforming changes to GS 20-7(r). Requires the Revisor of Statutes to change *armed forces* to *Armed Forces* throughout GS 20. Effective for all licenses expiring on or after the date the act becomes law.

**H 98. LICENSE RENEWAL/DEPLOYING RESERVISTS.** Filed 2/10/09. House committee substitute makes the following changes to 1st edition. Allows for renewal of drivers licenses as provided in the act for members of the U.S. Armed Forces, as well as members of a reserve component of the Armed Forces, if on active duty and at a duty station outside North Carolina.

**H 98. LICENSE RENEWAL/ACTIVE MILITARY DUTY (NEW).** Filed 2/10/09. House committee substitute makes the following changes to 2nd edition. Changes title to *AN ACT TO AUTHORIZE A MEMBER OF THE ARMED FORCES OR OF RESERVE COMPONENTS OF THE ARMED FORCES TO RENEW A DRIVERS LICENSE UPON RECEIPT OF DEPLOYMENT ORDERS AND TO ALLOW A THIRTY-DAY GRACE PERIOD FOR AN EXPIRED LICENSE UPON RELEASE FROM ACTIVE DUTY.* Makes technical and conforming changes to GS 20-7(f) as indicated in new title.

**H 98. LICENSE RENEWAL/ACTIVE MILITARY DUTY.** Filed 2/10/09. Senate committee substitute makes the following changes to 3rd edition. Provides in proposed GS 20-7(f)(3b)b. that a person who is a member of a reserve component of the US Armed Forces (was, a member of the US Armed Forces or a member of a reserve component) whose license bears an expiration date that occurred while the person was on active duty outside the state is considered to have a valid license until 60 (was, 30) days after the date of release from active duty upon showing proof of the release date, unless the license was rescinded, revoked, or otherwise invalidated under some other provision of law. Prohibits a license from being considered valid more than 18 months after the date of expiration. Makes a conforming change to the title.
