H 201. ADD DIVISION OF LESS TO CCPS (=S 139). Filed 2/17/09. *TO CLARIFY THAT THE DIVISION OF LAW ENFORCEMENT SUPPORT SERVICES IS A DIVISION OF THE DEPARTMENT OF CRIME CONTROL AND PUBLIC SAFETY, TO ASSIGN DUTIES TO THE DIVISION, AND TO MAKE CORRESPONDING CHANGES TO CHAPTERS 20 AND 105 OF THE GENERAL STATUTES TO ALLOW LAW ENFORCEMENT SUPPORT SERVICES TO TRANSFER MOTOR VEHICLES TO LAW ENFORCEMENT AGENCIES WITHOUT HAVING TO BECOME A MOTOR VEHICLE DEALER OR PAY HIGHWAY USE TAXES.*

H 201. ADD DIVISION OF LESS TO CCPS. Filed 2/17/09. House committee substitute makes the following changes to 1st edition. Amends proposed GS 143B-508 to authorize the Law Enforcement Support Services Division to provide assistance as may be necessary or appropriate to carry out assigned duties and responsibilities (was, provide assistance as the Governor or Secretary of Crime Control and Public Safety may direct). Makes technical changes.

H 201. ADD DIVISION OF LESS TO CCPS. Filed 2/17/09. House committee substitute makes the following changes to 2nd edition. Amends GS 20-73(b) to create an exemption from requirements to obtain a new certificate of title for the Department of Crime Control and Public Safety, Division of Law Enforcement Support Services, or the Department of Environment and Natural Resources, Division of Forest Resources, when receiving, titling, or transferring any vehicle acquired under 10 U.S.C. § 381 or any similar acquisition and transfer program administered by the Division of Law Enforcement Support Services or the Division of Forest Resources. Makes organizational changes to proposed GS 105-187.6(a)(10).

H 201. ADD DIVISION OF LESS TO CCPS. Filed 2/17/09. Senate committee substitute makes the following changes to 3rd edition. Adds to proposed amended GS 20-287 an exemption for the Department of Environment and Natural Resources, Division of Forest Resources, when receiving, titling, or transferring any vehicle acquired under provisions of Title 10, Section 285, of the US Code, or any similar acquisition and transfer program administered by the Division of Law Enforcement Support Services, from licensing requirements for any new or used motor vehicle dealer, motor vehicle sales representative, manufacturer, factory branch, factory representative, distributor, distributor branch, distributor representative, or wholesaler engaging in business in the state. Makes a conforming change to the title.

Clarifies in proposed GS 105-187.6(a)(10) that a *qualified recipient* includes a fire department (was, volunteer fire department).

H 201. ADD DIVISION OF LESS TO CCPS. Filed 2/17/09. Senate committee substitute makes the following changes to 4th edition. Makes organizational changes to proposed amended GS 20-73 and provides that the statute's titling requirements do not apply to a state agency that assists the US Department of Defense in purchasing or transferring a vehicle to a unit of local government, a volunteer fire department, or a volunteer rescue squad (was, specifically exempted the Department of Crime Control and Public Safety, Division of Law Enforcement Support Services, or the Department of Environment and Natural Resources, Division of Forest Resources, when receiving, titling, or transferring any vehicle acquired under certain programs administered by those divisions). Modifies proposed amended GS 105-187.6(a) by (1) deleting the exemption from the highway use tax for a vehicle transfer to a *qualified state agency* under specific circumstances and (2) creating an exemption from the tax for a transfer to a state agency from a unit of local government, volunteer fire department, or volunteer rescue squad to enable

the state agency to transfer the vehicle to another unit of local government, volunteer fire department, or volunteer rescue squad.

Deletes amendment to GS 20-287, which exempted the Department of Crime Control and Public Safety, Division of Law Enforcement Support Services or the Department of Environment and Natural Resources, Division of Forest Resources, when receiving, titling, or transferring any vehicle acquired under certain programs administered by those divisions, from licensing requirements for motor vehicle dealers, motor vehicle sales representatives, factory branches, factory representatives, distributors, distributor branches, distributor representatives, and wholesalers.

Makes technical changes.

Changes the title to *AN ACT TO FACILITATE THE TRANSFER OF MOTOR VEHICLES FROM THE UNITED STATES DEPARTMENT OF DEFENSE TO LOCAL GOVERNMENT UNITS, VOLUNTEER FIRE DEPARTMENTS, AND VOLUNTEER RESCUE SQUADS AND TO CLARIFY THAT THE DIVISION OF LAW ENFORCEMENT SUPPORT SERVICES IS A DIVISION OF THE DEPARTMENT OF CRIME CONTROL AND PUBLIC SAFETY.*

AN ACT TO FACILITATE THE TRANSFER OF MOTOR VEHICLES FROM THE UNITED STATES DEPARTMENT OF DEFENSE TO LOCAL GOVERNMENT UNITS, VOLUNTEER FIRE DEPARTMENTS, AND VOLUNTEER RESCUE SQUADS AND TO CLARIFY THAT THE DIVISION OF LAW ENFORCEMENT SUPPORT SERVICES IS A DIVISION OF THE DEPARTMENT OF CRIME CONTROL AND PUBLIC SAFETY.
