**H 465. USE OF FUNDS RECEIVED FROM PARKING METERS.** Filed 3/5/09. *TO ALLOW THE CITY OF RALEIGH TO ALLOW ACTIVATION OF PARKING METERS BY CREDIT CARD OR OTHER ELECTRONIC MEANS AND TO USE PROCEEDS COLLECTED FROM PARKING METERS FOR PARKING PROGRAMS AND PROVIDING PARKING FACILITIES.*

Amends GS 160A-301(a) to allow the City of Raleigh to have parking meters that are activated by credit cards or electronic means (as well as by coins or tokens); have parking zones requiring a different amount of money to activate the meter for different time periods based on the zone in which the meter is located; and to use the proceeds from parking meters to operate the parking program or provide parking facilities (was, for enforcing and administering traffic and parking ordinances and regulations).

**H 465. USE OF FUNDS RECEIVED FROM PARKING METERS.** Filed 3/5/09. House amendment makes the following changes to 3rd edition. Limits activation of parking meters by credit card and use of proceeds for parking programs and facilities to the City of Raleigh and the Town of Chapel Hill. The 3rd edition was applicable to the City of Wilmington and the Towns of Wrightsville Beach, Carolina Beach, and Kure Beach as well.

**H 465. EXTEND ECONOMIC DEVELOPMENT DEADLINE (NEW).** Filed 3/5/09. Senate committee substitute deletes all the provisions of the 4th edition and replaces it with *AN ACT TO ALLOW THE CITY OF RALEIGH TO EXTEND AN ECONOMIC DEVELOPMENT DEADLINE FOR THE CONSTRUCTION OF ECONOMIC DEVELOPMENT PROJECTS.* Amends GS 158-7.1(d2) to extend the five-year period for the construction of an economic development project up to an additional two years after (1) a public hearing is held and (2) there is a finding that extraordinary economic conditions prevented the completion of the project within the five-year period. Limits the application of this act to the City of Raleigh.
