H 1309. RESIDENTIAL TREATMENT FACIL./TBI. Filed 4/8/09. *TO DIRECT THE COMMISSION FOR MENTAL HEALTH, DEVELOPMENTAL DISABILITIES, AND SUBSTANCE ABUSE SERVICES TO ADOPT RULES PROVIDING FOR THE LICENSURE AND ACCREDITATION OF RESIDENTIAL TREATMENT FACILITIES FOR PERSONS WITH TRAUMATIC BRAIN INJURY.*

Amends GS 122C-26 as title indicates. Provides that the Commission for Mental Health, Developmental Disabilities, and Substance Abuse Services may adopt temporary rules to carry out the provisions of this act.

H 1309. RESIDENTIAL TREATMENT FACIL./TBI. Filed 4/8/09. Senate committee substitute makes the following changes to 1st edition. Allows the Commission for Mental Health, Developmental Disabilities, and Substance Abuse Services to adopt temporary rules to carry out the act *until July 1, 2010* (was, may adopt temporary rules). Makes a conforming change.

H 1309. TBI RESIDENTIAL TREATMENT FACIL/TBI COUNCIL (NEW). Filed 4/8/09. Senate committee substitute makes the following changes to 2nd edition. Changes the name of the NC Traumatic Brain Injury Advisory Council to the NC Brain Injury Advisory Council (Council) and provides that the Council is to review traumatic and other acquired brain injuries in the state. Changes the membership of the Council from 29 members to 23 members and 10 ex officio nonvoting members. Makes the members appointed by the Secretary of Health and Human Services ex officio members and increases the total number from eight to nine members by appointing two (was, one) members from the Division of Health Service Regulation. Also makes one of the members appointed by the Superintendent of Public Instruction an ex officio member. Provides that the terms for ex officio nonvoting members do not expire.

Increases the number of members appointed by the Governor from 11 to 14 to now include (1) four (was, three) family members of persons with brain injury and requires that geographic representation be considered, (2) the Executive Director of the NC Protection and Advocacy System, and (3) a stroke survivor as recommended by the American Heart Association. Also amends other members to be appointed by the Governor, as well as those appointed by the General Assembly upon the recommendation of the President Pro Tem. of the Senate and of the Speaker of the House to change the qualifications of those individuals.

Requires that the initial Council chair be designated by the Secretary of the Department of Health and Human Services and requires that subsequent chairs be elected by the Council. Provides that the appointments become effective at the expiration of the term of the member serving on the Council before the effective date of the act. Makes a conforming change to the title.
