H 1429. CLARIFY THE NEW NC DROUGHT RESPONSE. Filed 4/9/09. *TO MAKE CERTAIN CLARIFICATIONS REGARDING THE IMPROVEMENTS TO DROUGHT PREPAREDNESS AND RESPONSE IN NORTH CAROLINA MADE BY THE 2008 SESSION OF THE GENERAL ASSEMBLY.*

Amends GS 143-350(7) to clarify that a “water shortage emergency” is defined as a shortage presenting an “imminent and severe” threat (previously only “imminent” threat). Repeals GS 143-355.2(a)(4), which prohibited the approval of any water shortage plan containing provisions that metered or regulated private drinking water wells. Amends GS 143-355.2(h), GS 143-355.3(b)(2), and GS 143-355.3(b)(3) to clarify that each of those subsections does not authorize a unit of government, public water supply system, or private water supply system to regulate water use from a well located outside of its jurisdiction, a well not connected to its system, or any other private well.

H 1429. CLARIFY THE NEW NC DROUGHT RESPONSE. Filed 4/9/09. House amendment makes the following changes to 1st edition. Amendment #3 deletes Section 1, which proposed changes to GS 143-350(7) to modify the definition of *water shortage emergency* to include a severe threat to public health, safety, and welfare or to the environment. Renumbers the remaining sections of the bill accordingly. Amendment #4 rewrites GS 143-355.2(h) to provide that nothing in the subsection is to be deemed to void or alter cross-jurisdictional agreements.

H 1429. MORTGAGE GUARANTY INSURER SUNSET EXTENDED (NEW). Filed 4/9/09. Senate committee substitute deletes all provisions of 2nd edition and replaces it with *AN ACT TO EXTEND THE EFFECTIVE DATE FOR COMMISSIONER OF INSURANCE DISCRETION TO WAIVE THE MINIMUM POLICYHOLDERS POSITION REQUIREMENT UNDER CERTAIN CIRCUMSTANCES FOR MORTGAGE GUARANTY INSURERS.* Rewrites GS 58-10-125(l), as title indicates, to prohibit the commissioner from granting a waiver that would extend beyond July 1, 2015 (was, July 1, 2014). Makes conforming change to SL 2009-254.

SL 2010-40 (H 1429). MORTGAGE GUARANTY INSURER SUNSET EXTENDED. AN ACT TO EXTEND THE EFFECTIVE DATE FOR COMMISSIONER OF INSURANCE DISCRETION TO WAIVE THE MINIMUM POLICYHOLDERS POSITION REQUIREMENT UNDER CERTAIN CIRCUMSTANCES FOR MORTGAGE GUARANTY INSURERS.
