H 1921. WAKE E-MAIL ADDRESS LISTS/ELECTRONIC ACCESS. Filed 5/20/10. *TO PROVIDE THAT A LIST OF THE E-MAIL ADDRESSES OF PERSONS SUBSCRIBING TO E-MAIL LISTS KEPT BY WAKE COUNTY AND CERTAIN LOCAL GOVERNMENTS WITHIN THAT COUNTY ARE OPEN TO PUBLIC INSPECTION BUT ARE NOT REQUIRED TO BE PROVIDED IN ELECTRONIC FORMAT, AND TO PROVIDE THAT THE LOCAL GOVERNMENT MAY USE THAT LIST ONLY FOR THE PURPOSE THAT IT WAS SUBSCRIBED TO.*

As title indicates. List also may be used to notify subscribers of public health or public safety emergency. Act applies to Wake County government and to municipal governments of Raleigh, Apex, Cary, Fuquay-Varina, Garner, Holly Springs, Knightdale, Morrisville, Rolesville, Wake Forest, Wendell, and Zebulon.

H 1921. WAKE E-MAIL ADDRESS LISTS/ELECTRONIC ACCESS. Filed 5/20/10. House committee substitute makes the following changes to 2nd edition. Exempts Wake County government and the specified municipal governments in Wake County from provisions in the Public Records Act that require providing copies of e-mail lists of individual subscribers (was, not required to provide the e-mail lists in electronic format). Makes a conforming change to the title.
