S 6. BEACH PLAN AND INS. RATE AND DEDUCTIBLE STAY. Filed 1/28/09. *TO IMPOSE A TEMPORARY STAY ON INCREASED SURCHARGES AND DEDUCTIBLES FOR CERTAIN POLICIES UNDER THE BEACH PLAN AND ON PROPERTY INSURANCE RATE INCREASES FOR CERTAIN HOMEOWNER'S POLICIES ACROSS THE STATE.*

Suspends rate increases, surcharges, and deductible increases for property insurance under the Beach Plan that were approved by the Department of Insurance on November 21, 2008, for policies on a homeowner or applicant's permanent residence. Prohibits surcharge or deductible increases for these same coverages on or after the effective date of the act. Provides that rate increases approved by the Commissioner of Insurance on December 18, 2008, do not apply to homeowner's coverage of \$150,000 or less for a homeowner's principal residence. Requires refunds of premiums made in violation of this act. Effective when act becomes law and applies to policies issued or renewed on or after that date. Expires May 1, 2011.

SL 2009-5 (S 6). CONTINUING CROSSBOW PERMIT/DEALERS AND MANUFACTURERS. *AN ACT TO PROVIDE THAT A CORPORATION THAT IS A MANUFACTURER, WHOLESALE DEALER, OR RETAIL DEALER OF CROSSBOWS MAY OBTAIN A CONTINUING PERMIT FOR THE PURCHASE OR RECEIPT OF CROSSBOWS UPON APPLICATION TO THE SHERIFF OF THE COUNTY IN WHICH THE CORPORATION IS LOCATED, AND TO PROVIDE THAT THE RECORD-KEEPING REQUIREMENT FOR SALES OF CROSSBOWS DOES NOT APPLY TO A MANUFACTURER OF CROSSBOWS AND DOES NOT APPLY TO A WHOLESALE DEALER OF CROSSBOWS WHEN THE SALES ARE TO OTHER WHOLESALE DEALERS OR RETAIL DEALERS.* Summarized in *Daily Bulletin* 1/28/09, 2/17/09, and 2/18/09. S 6. ABC RULES/PRIVATE CLUBS (NEW). Filed 1/28/09. Senate committee substitute makes the following changes to 1st edition. Deletes all provisions of the previous edition and replaces it with *AN ACT TO CLARIFY THE AUTHORITY OF THE ABC COMMISSION TO ADOPT RULES CONCERNING PRIVATE CLUBS.* Amends GS 18B-1008 by deleting the provision authorizing the ABC Commission to adopt a rule requiring that a private club have a waiting period for membership not to exceed 30 days.

S 6. ABC RULES/PRIVATE CLUBS. Filed 1/28/09. House committee substitute makes the following changes to 2nd edition. Directs the Alcohol Beverage Commission (Commission) to examine on a continuing basis the record of violations and noncompliance with Commission rules for ABC establishments operating as private clubs. Requires a report to the Joint Legislative Corrections, Crime Control, and Juvenile Justice Oversight Committee prior to the convening of the 2011 Regular Session that includes the period from July 1, 2009, through December 31, 2010. Also makes a technical change to proposed amended GS 18B-1008.
