S 220. GENERAL STATUTES COMM. TECHNICAL CORRECTIONS. Filed 2/18/09. House committee substitute makes the following changes to 1st edition.

Amends GS 7A-39.14(e) to clarify that the statute does not authorize more than 15 (was, 12) justices and judges to serve on the Court of Appeals at any given time.

Amends GS 58-50-180(b)(3)e., GS 58-65-133(d), GS 115C-102.15(b)(9), GS 115C-102.15(b)(15), GS 143-548(a)(1), and GS 143B-434.1(c)(9) to substitute the *North Carolina Citizens for Business and Industry* with the *North Carolina Chamber*.

Deletes repetitive language in GS 143-299.1A(c), which states that nothing in the statute limits the assertion of the public duty doctrine as a defense on the part of a unit of local government or its officers, employees, or agents.

Recodifies (1) GS 115B-5A as GS 115B-5.1; (2) Article 29B of GS Chapter 115C, as enacted by SL 2009-212, as Article 29C of GS Chapter 115C; and (3) GS 115C-407.5 through GS 115C-407.8, as enacted by SL 2009-212, as GS 115C-407.9 through GS 115C-407.12.

Directs the Revisor of Statutes to substitute the term *judgement* with the term *judgment* wherever the word appears in the General Statutes, including specified statutes.

Amends GS 15A-268(f) and GS 15A-268(b)(3)d.3., as amended by SL 2009-203, to substitute the term *governmental entity* with *custodial agency*. Amends Section 7(a) of SL 2009-203 to substitute the designation of the *President of the North Carolina Association of Clerks of Superior Court* with the *President of the Conference of Clerks of the Superior Court* as a member of the Joint Select Study Committee on the Preservation of Biological Evidence.

Amends GS 18C-103(7a), as enacted by SL 2009-357, to make *lottery potential contractor* synonymous with *potential contractor*. Makes clarifying changes to GS 18C-114(a)(8), GS 18C-114(a)(11)c., and GS 18C-151(f), all as enacted by SL 2009-357, and GS 114-19.16.

Amends GS 22A-1 to replace the phrase *handicapped person* with *person with a disability*.

Amends GS 115D-5.1 to clarify that the State Board of Community Colleges (Board) must report to the Joint Legislative Education Oversight Committee on the total amount of funds received by a company under the Customized Training (was, CIT) Program. Also deletes that the Board may adopt rules and guidelines that allow the Focused Industrial Training Program to use funds appropriated for the program to support training projects for the various branches of the US Armed Forces.

Amends Section 2 of SL 2009-19 to add that GS 160A-200(b) (provision naming specific cities and towns to which the statute applied) is repealed. Clarifies that a municipality *newly covered by GS 160A-200 on account of this act* may adopt an ordinance under GS 160A-200 when the act becomes law, but that the ordinance may not be effective until October 1, 2009. Deletes the language that (1) provided that the repeal of any local act does not affect the rights or liabilities of a municipality that arose during the time that act was in effect or under an ordinance adopted under such an act and (2) allowed an ordinance to remain in effect under such acts, until amended or repealed by the municipality, if the ordinance would be permitted under GS 160A-200, as enacted by SL 2009-19.

Makes technical corrections to GS 7A-343.2; GS 14-144; GS 14-202.5(b)(1); GS 14-208.18(a); GS 58-89A-75; GS 90-21.5(a); GS 90-270.78(a)(3); GS 90-634(b1); GS 120C-102(d); GS 122A-5(24); GS 130A-295.02(j); GS 138A-13(e); GS 143-138(b); GS 143-215.94H(a)(2); GS 143-215.94T(c); GS 143B-437.63; GS 148-84; GS 163-278.66(a); GS 163-278.99A(a); GS 7A-38.6(a); GS 7A-307(a); GS 14-90(a)(3), as amended by SL 2009-348; GS 20-183.2(a1); GS 58-72-50; GS 62-133.5(h)(2), as enacted by SL 2009-238; GS 115C-102.6B(b); GS 115C-324; GS 115C-525(c); GS 115D-5(s); GS 122C-55(a6), as enacted by SL 2009-65; GS 136-44.50(b)(4);

GS 138A-24(f); the title of SL 2009-307; and, if House Bill 1523 becomes law, GS 53-244.040(d), as enacted by that act.

S 220. GENERAL STATUTES COMM. TECHNICAL CORRECTIONS. Filed 2/18/09. House amendment makes the following changes to the 2nd edition. Repeals GS 143B-437.63 as amended *if* Senate Bill 509, 2009 Regular Session, becomes law. Amends GS 53-244.030(20) as enacted by SL 2009-374 to define *mortgage lender* as a person engaged in the mortgage business as defined in sub-subdivision b. (was, sub-subdivision a.) of subdivision (1) of the statute. Amends GS 115C-102.6B(b) to correct a citation. Recodifies GS 130A-128A as enacted by SL 2009-67 as GS 130A-128.1. Amends GS 135-45.2(c)(12) to correct a citation. Clarifies that GS 53-244.040(d) as enacted by SL 2009-374 (was, as enacted by that act) is amended *if* House Bill 1523, 2009 Regular Session becomes law. Provides that *if* Senate Bill 40, 2009 Regular Session, becomes law, the lead-in language for Section 3.1 of that bill is amended by adding the words "Section 1 of" before the words "Chapter 322." Provides that *if* Senate Bill 660, 2009 Regular Session, and Senate Bill 514, 2009 Regular Session, both become law, then GS 7A-292(15) as enacted by Section 2 of Senate Bill 660 is recodified as GS 7A-292(16).
