S 1030. AFTER-SCHOOL CHILD CARE PROGRAMS. Filed 3/26/09. *CLARIFYING THE MEANING OF PUBLIC SCHOOL BUILDINGS AS RELATED TO AFTER-SCHOOL CHILD CARE PROGRAMS AND ESTABLISHING PROCEDURES FOR APPROVING EDUCATION CRITERIA FOR AFTER-SCHOOL CHILD CARE PROGRAM COORDINATORS AND GROUP LEADERS.*

Directs the Department of Health and Human Services to include playgrounds and athletic fields in the definition of school building in administering after-school child care programs. Directs the Division of Child Development to establish procedures to approve educational criteria for after-school program personnel, including general education coursework that should be considered.

S 1030. AFTER-SCHOOL CHILD CARE PROGRAMS. Filed 3/26/09. House committee substitute makes the following changes to 2nd edition. Exempts playgrounds and athletic fields that are (1) at school buildings used to serve school aged children in after school child care programs and (2) that do not meet the current star rating standards from evaluation under the star rating system and requires that the issue be noted on information made available regarding the program's rating.

S 1030. AFTER-SCHOOL CHILD CARE PROGRAMS. Filed 3/26/09. House committee substitute makes the following changes to 3rd edition. Requires that referenced playgrounds and athletic fields that do not meet the licensure standards set by the North Carolina Child Care Commission have that information noted on the after-school child care program's licensure and rating information (was, playgrounds and athletic fields that did not meet current star rating standards were exempted from evaluations of those locations under the star rating system and the exemption status was to be noted on the information available regarding the program's rating).
