7	ordinance, regulate the operation of golf carts on any public street or highway within	the city
8	limits, or on any property owned or leased by the city.	
9	(b) By ordinance, a city may require the registration of golf carts, charge a fee	for the
10	registration, specify who is authorized to operate golf carts, and specify the required equ	ipment,
11	load limits, and the hours and methods of operation of golf carts.	
12	(c) This section applies to the County of New Hanover, to the County of Lenoir	for the
13	community of Deep Run only, to the Cities of Locust, Saluda, and Wilmington, to the To	owns of
