16	activities that will increase their constituencies' opportunities to become

19 20	targeted community. SECTION 2. There is appropriated from the General Fund to the Rural Econom	nic
20 21	Development Center, Inc., the sum of one million three hundred forty-seven thousand for	
22	hundred ten dollars (\$1,347,410) in fiscal year 2009-2010 and the sum of one million thr	
23	hundred forty-seven thousand four hundred ten dollars (\$1,347,410) in fiscal year 2010-20	
24	for community development grants to support development projects and activities within t	
25	State's minority communities. Any new or previously funded community developme	nt
26	corporation as defined in this section is eligible to apply for funds. The Rural Center sha	
27	establish performance-based criteria for determining which community developme	
28	corporation will receive a grant and the grant amount. Of the funds appropriated in this act, t	
29 20	Rural Center shall allocate one million two hundred forty-seven thousand four hundred t	
30 31	dollars (\$1,247,410) in each fiscal year for direct grants to local community developme corporations to support operations and project activities and shall allocate one hundr	
31	thousand dollars (\$100,000) in each fiscal year to be used to cover expenses and provi	
33	technical assistance in administering this section.	40
