EFFECTIVE DATE: This bill is effective July 1, 2009.					

BILL SUMMARY:

This bill amends GS 20-79.4(b) to add a special registration plate that bears the emblem of Wake Forest University Baptist Medical Center's Brenner Children's Hospital. This bill also amends GS 20-79.7 to establish a special plate fee of \$30. The bill distributes \$10 of the fee amount to the Special Registration Plate Account and \$20 to the Collegiate and Cultural Attraction Plate Account (CCAPA). It amends GS 20-81.12 to direct the Division of Motor Vehicles to make a quarterly transfer of the money in the CCAPA earned from the sale of the Brenner Children's Hospital plates to the NC Baptist Hospital's Special Purpose-Pediatric Unit Fund to provide funding for the Brenner Children's Hospital. It also provides that the development of the plate is contingent on receiving at least 300 plate applications. Finally, it makes a technical change to GS 20-79.4(b)(15b).

ASSUMPTIONS AND METHODOLOGY: This bill assumes the usual \$100 startup cost associated with producing a special plate. While a minimum of 300 applications are required, the expenditures and revenues cannot be accurately determined at this time.

In order to produce the special plate, the DMV will need artwork from the Brenner Children's Hospital and will require six weeks to create a sample plate. Manufacturing can begin once the sample plate is approved.
