4		SECTION 1. No resolution of consideration, resolution of intent, or annexation		
5		ordinance may be adopted under Part 2 or 3 of Article 4A of Chapter 160A of the General		
6	Statutes from the date this act becomes law until July 1, 2012. If any annexation proceeding has			
7	been initiated under those Parts prior to the date this act becomes effective but the annexation			
8	ordinance has not yet been adopted, any provision of law requiring any action or notice by the			
9	municipality or	municipality or any person within a certain period of time is tolled during the suspension of		
10	authority provided by this section. Nothing in this section shall prohibit municipalities from			
11	developing policies, planning, collecting data, or developing materials with respect to potential			
12	future annexations under Part 2 or 3 of Article 4A of Chapter 160A of the General Statutes.			
13	SECTION 2.(a) An annexation ordinance adopted under Part 2 or 3 of Article 4A			
14	of Chapter 160A of the General Statutes that has an effective date on or after the day this act			
15	becomes law shall not become effective until July 1, 2012, unless one of the following applies:

SECTION 3. Any annexation litigation under Parts 2 or 3 of Article 4A of Chapter
160A of the General Statutes pending in any court of this State shall be stayed upon enactment
of this act.

4 **SECTION 4.** If any municipality has adopted its budget ordinance for the 5 2010-2011 fiscal year prior to the date this act becomes effective and the total amount of 6 assessed valuation estimated in that budget ordinance has been reduced because of this act, the 7 municipality may amend the budget ordinance to account for this act, including establishment 8 of a different tax rate.

9 SECTION 5. If any provision of this act or its application is held invalid, the 10 invalidity does not affect other provisions or applications of this act that can be given effect 11 without the invalid provisions or application, and to this end the provisions of this act are 12 severable.

13 **SECTION 6.** This act is effective when it becomes law and expires on June 30, 14 2012.
