1 A HOUSE RESOLUTION HONORING THE LIFE AND MEMORY OF MONA  
2 CORNWELL, FORMER EMPLOYEE OF ASHEVILLE-BUNCOMBE TECHNICAL  
3 COMMUNITY COLLEGE.

4 Whereas, Mona Cornwell was born in Morganton, North Carolina, and graduated  
5 from A.C. Reynolds High School and the University of North Carolina at Asheville; and

6 Whereas, Mona Cornwell devoted 18 years to Asheville-Buncombe Technical  
7 Community College beginning in 1994, as a Desktop Publishing Specialist and later as the  
8 Director of Community Relations and Marketing; and

9 Whereas, Mona Cornwell was tireless in her efforts to ensure the passage of a sales  
10 tax referendum in 2011 to provide new and renovated buildings for Asheville-Buncombe  
11 Technical Community College to ensure students will be able to train for 21st century jobs in  
12 21st century facilities, and thereby improving the economic outlook for the community; and

13 Whereas, Mona Cornwell helped lead the local campaign for the 2000 Higher  
14 Education Bond Referendum that brought \$14 million to Asheville-Buncombe Technical  
15 Community College; and

16 Whereas, Mona Cornwell was a good steward of taxpayer resources by developing  
17 low-cost or no-cost ways of publishing college events and by creating a communication and  
18 marketing plan for Asheville-Buncombe Technical Community College's 50th anniversary by  
19 leveraging the college's existing resources; and

20 Whereas, in response to tragedies involving law enforcement and people with  
21 mental illness, Mona Cornwell researched Crisis Intervention Team training, and by working  
22 with the Asheville-Buncombe Technical Community College leadership, the Buncombe  
23 County Sheriff's Department, the Asheville Police Department, and the local chapter of the  
24 National Alliance on Mental Illness, and others, was able to help create and implement a Crisis  
25 Intervention Team program for local law enforcement officers, school resource officers,  
26 emergency medical technicians, and others; and

27 Whereas, Mona Cornwell was always willing to come early and stay late, willingly  
28 took on new assignments, and consistently treated everyone with respect and dignity; and

29 Whereas, Mona Cornwell received numerous honors and awards, including  
30 receiving the Asheville-Buncombe Technical Community College Staff Member of the Year  
31 and Meritorious Service awards in 2012, as well as the BB&T Staff Member of the Year  
32 Award for the North Carolina Community College System from the State Board of Community  
33 Colleges in 2012; and

34 Whereas, Mona Cornwell died April 2, 2013; and

35 Whereas, Mona Cornwell is survived by her husband, David Cornwell, two sons,  
36 Neal and Graham Cornwell, and her mother, Jo Ellen Lipe; Now, therefore,



1 Be it resolved by the House of Representatives:

2           **SECTION 1.** The House of Representatives honors the life and memory of Mona  
3 Cornwell and expresses its gratitude for her service to Asheville-Buncombe Technical  
4 Community College, her community, and the State of North Carolina.

5           **SECTION 2.** The House of Representatives extends its sympathy to the family of  
6 Mona Cornwell for the loss of their family member.

7           **SECTION 3.** The Principal Clerk shall transmit a certified copy of this resolution  
8 to the family of Mona Cornwell.
