4	The General Assembly of North Carolina enacts:
5	SECTION 1. G.S. 15A-1343(b) reads as rewritten:
6	"(b) Regular Conditions. – As regular conditions of probation, a defendant must:
7	
8	(3a) Not to abscond, by willfully avoiding supervision or by willfully making the
9	defendant's whereabouts unknown to the supervising probation officer.
10	officer, if the defendant is placed on supervised probation.
11	
12	SECTION 2. G.S. 15A-1368.4(e)(14) is repealed.
13	SECTION 3. G.S. 15-205 reads as rewritten:
14	"§ 15-205. Duties and powers of the probation officers.
15	A probation officer shall investigate all cases referred to him for investigation by the judges
16	of the courts or by the Secretary of Public Safety. Such officer shall keep informed concerning
17	the conduct and condition of each person on probation under his supervision by visiting,
18	requiring reports, and in other ways, and shall report thereon in writing as often as the court or
19	the Secretary of Public Safety may require. Such officer shall use all practicable and suitable
20	methods, not inconsistent with the conditions imposed by the court or the Secretary of Public
21	Safety, to aid and encourage persons on probation to bring about improvement in their conduct
22	and condition, and shall within the first 30 days of a person's probation take such person to a
23	prison unit maintained by the Division of Adult Correction of the Department of Public Safety
24	for a tour thereof so that he may better appreciate the consequences of probation revocation.
25	condition. Such officer shall keep detailed records of his work; shall make such reports in
26	writing to the Secretary of Public Safety as he may require; and shall perform such other duties
27	as the Secretary of Public Safety may require. A probation officer shall have, in the execution
28	of his duties, the powers of arrest and, to the extent necessary for the performance of his duties,
29	the same right to execute process as is now given, or that may hereafter be given by law, to the
30	sheriffs of this State."
31	SECTION 4. G.S. 15A-1344(d2) reads as rewritten:
32 33	"(d2) Confinement in Response to Violation. – When a defendant under supervision for a follow conviction has violated a condition of probation other than $C \ge 15A + 1242(b)(1)$ or
33 34	felony conviction has violated a condition of probation other than G.S. $15A-1343(b)(1)$ or G.S. $15A-1343(b)(3a)$ the court may impose a 00 day period of confinement period of
34 35	G.S. 15A-1343(b)(3a), the court may impose a 90 day period of confinement. period of confinement of 90 consecutive days. The court may not revoke probation unless the defendant
36	has previously received a total of two periods of confinement under this subsection. A

defendant may receive only two periods of confinement under this subsection. If the time remaining on the maximum imposed sentence on a defendant under supervision for a felony conviction is 90 days or less, then the term of confinement is for the remaining period of the sentence. Confinement under this section shall be credited pursuant to G.S. 15-196.1.

5 When a defendant under supervision for a misdemeanor conviction has violated a condition 6 of probation other than G.S. 15A-1343(b)(1) or G.S. 15A-1343(b)(3a), the court may impose a 7 period of confinement of up to 90 <u>consecutive</u> days. The court may not revoke probation unless 8 the defendant has previously received a total of two periods of confinement under this 9 subsection. A defendant may receive only two periods of confinement under this subsection. 10 Confinement under this section shall be credited pursuant to G.S. 15-196.1.

If a defendant is arrested for violation of a condition of probation and is lawfully confined to await a hearing for the violation, then the judge shall first credit any confinement time spent awaiting the hearing to any confinement imposed under this subsection; any excess time shall be credited to the activated sentence. The period of confinement imposed under this subsection on a defendant who is on probation for multiple offenses shall run concurrently on all cases related to the violation. Confinement shall be immediate unless otherwise specified by the court.

18 A defendant shall serve any confinement imposed under this subsection in the correctional19 facility where the defendant would have served an active sentence."

20 21 **SECTION 5.** G.S. 143B-1159 is repealed. **SECTION 6.** G.S. 15A-1340.17(e) reads as rewritten:

"(e) Maximum Sentences Specified for Class B1 through Class E Felonies for Minimum Terms up to 339 Months. — Unless provided otherwise in a statute establishing a punishment for a specific crime, for each minimum term of imprisonment in the chart in subsection (c) of this section, expressed in months, the corresponding maximum term of imprisonment, also expressed in months, is as specified in the table below for Class B1 through Class E felonies. The first figure in each cell of the table is the minimum term and the second is the maximum term.
