3 The General Assembly of North Carolina enacts:

5 **PART I. REPEAL THE SMALL BUSINESS CONTRACTOR ACT AND THE SMALL**
6 **BUSINESS CONTRACTOR AUTHORITY**

7 **SECTION 1.** Part 20 of Article 10 of Chapter 143B of the General Statutes is
8 repealed.

9
10 **PART II. PROVIDE THAT THE COMMITTEE ON DROPOUT PREVENTION**
11 **SHALL TERMINATE ON JULY 1, 2013**

12 **SECTION 2.** Section 7.32(e) of S.L. 2007-323, as rewritten by Section 7.14(a) of
13 S.L. 2008-107 and Section 7.19(e) of S.L. 2010-31, reads as rewritten:

14 "**SECTION 7.32.(e)** Report. – The Committee shall report to the Joint Legislative
15 Commission on Dropout Prevention and High School Graduation created in subsection (f) of
16 this section by December 1, 2007, on the grants awarded under subsection (d) of this section.
17 The Committee shall terminate July 1, 2013."

19 **PART III. ELIMINATE THE STATE EDUCATION COMMISSION ESTABLISHED**
20 **IN CHAPTER 116C OF THE GENERAL STATUTES**

21 **SECTION 3.(a)** G.S. 116C-1 reads as rewritten:

22 "**§ 116C-1. Education Cabinet created.**

23 (a) The Education Cabinet is created. The Education Cabinet shall be located
24 administratively within, and shall exercise its powers within existing resources of, the Office of
25 the Governor. However, the Education Cabinet shall exercise its statutory powers
26 independently of the Office of the Governor.

27 (b) The Education Cabinet shall consist of the Governor, who shall serve as chair, the
28 President of The University of North Carolina, the State Superintendent of Public Instruction,
29 the Chairman of the State Board of Education, the President of the North Carolina Community
30 Colleges System, the Secretary of Health and Human Services, and the President of the North
31 Carolina Independent Colleges and Universities. The Education Cabinet may invite other
32 representatives of education to participate in its deliberations as adjunct members.

33 (c) The Education Cabinet shall be a nonvoting body that:

34 (1) Works to resolve issues between existing providers of education.

35 (2) ~~Sets the agenda for the State Education Commission.~~

- 1 (3) Develops a strategic design for a continuum of education programs, in
- 2 accordance with G.S. 116C-3.
- 3 (4) Studies other issues referred to it by the Governor or the General Assembly.
- 4 (d) The Office of the Governor, in coordination with the staffs of The University of
- 5 North Carolina, the North Carolina Community College System, and the Department of Public
- 6 Instruction, shall provide staff to the Education Cabinet."

7 **SECTION 3.(b)** G.S. 116C-2 is repealed.

9 **PART IV. ELIMINATE THE STATE EDUCATION COMMISSION ESTABLISHED IN**
10 **ARTICLE 26 OF CHAPTER 143 OF THE GENERAL STATUTES**

11 **SECTION 4.** Article 26 of Chapter 143 of the General Statutes is repealed.

12
13 **PART V. PROVIDE THAT THE NATIONAL HERITAGE AREA DESIGNATION**
14 **COMMISSION SHALL TERMINATE JULY 1, 2013**

15 **SECTION 5.** Section 18.10 of S.L. 2001-491 reads as rewritten:

16 "**SECTION 18.10.** Notwithstanding G.S. 158-8.1, the Western North Carolina Regional
17 Economic Development Commission shall develop a regional heritage tourism plan and shall
18 present the plan to the 2002 Regular Session of the 2001 General Assembly no later than May
19 1, 2002. The National Heritage Area Designation Commission created pursuant to Section 18.4
20 of this act shall terminate July 1, 2013."

22 **PART VI. REPEAL THE GOVERNOR'S MANAGEMENT COUNCIL**

23 **SECTION 6.** Part 24 of Article 9 of Chapter 143B of the General Statutes is
24 repealed.

26 **PART VII. REPEAL THE BOARD OF DIRECTORS OF THE NORTH CAROLINA**
27 **CENTER FOR NURSING**

28 **SECTION 7.** G.S. 90-171.71 is repealed.

29
30 **PART VIII. REPEAL THE BOARD OF CORRECTIONS**

31 **SECTION 8.(a)** G.S. 143B-711 reads as rewritten:

32 "**§ 143B-711. Division of Adult Correction of the Department of Public Safety –**
33 **organization.**

34 The Division of Adult Correction of the Department of Public Safety shall be organized
35 initially to include the Post-Release Supervision and Parole Commission, ~~the Board of~~
36 ~~Correction,~~the Section of Prisons of the Division of Adult Correction, the Section of
37 Community Corrections, the Section of Alcoholism and Chemical Dependency Treatment
38 Programs, and such other divisions as may be established under the provisions of the Executive
39 Organization Act of 1973."

40 **SECTION 8.(b)** G.S. 143B-715 is repealed.

42 **PART IX. EFFECTIVE DATE**

43 **SECTION 9.** This act is effective when it becomes law.
