## A BILL TO BE ENTITLED

1 2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE THE 3 FOLLOWING SPECIAL REGISTRATION PLATES: UNITED STATES ARMY SPECIAL FORCES, MORROW MOUNTAIN STATE PARK, "KICK CANCER FOR 4 5 KIDS," THE BIG ROCK BLUE MARLIN TOURNAMENT, AND THE NORTH CAROLINA TROOPERS ASSOCIATION; TO ELIMINATE THE SPECIAL LICENSE 6 7 PLATE FEE FOR DISTINGUISHED FLYING CROSS AND AIR MEDAL RECIPIENT 8 SPECIAL REGISTRATION PLATES; TO AUTHORIZE THE ORDER OF THE LONG 9 LEAF PINE SPECIAL REGISTRATION PLATE TO BE ON A FULL COLOR 10 BACKGROUND: TO REDUCE THE NUMBER OF APPLICATIONS TO PRODUCE MILITARY COLLEGE PLATES; AND TO INCREASE THE FEE FOR THE KAPPA 11 12 ALPHA PSI SPECIAL REGISTRATION PLATE.

SECTION 1. G.S. 20-63(b1) reads as rewritten:

15 "(b1) The following special registration plates do not have to be a "First in Flight" plate or 16 "First in Freedom" plate as provided in subsection (b) of this section. The design of the plates 17 that are not "First in Flight" plates or "First in Freedom" plates must be developed in accordance with G.S. 20-79.4(a3). For special plates authorized in G.S. 20-79.7 on or after July 18 19 1, 2013, the Division may not issue the plate on a background under this subsection unless it receives at least 200 applications for the plate in addition to the applications required under 20 G.S. 20-79.4 or G.S. 20-81.12. the required number of applications set forth in 21 22 G.S. 20-79.3A(a).

19	SECTION 5. The Revisor of Statutes is authorized to alphabetize, number, and
20	renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special
21	registration plates are listed in alphabetical order and numbered accordingly.
22	<b>SECTION 6.</b> This act is effective when it becomes law.
