1 A BILL TO BE ENTITLED  
2 AN ACT PROVIDING FOR AN ELECTION IN THE VILLAGE OF HATTERAS ON THE  
3 QUESTION OF ALLOWING THE HATTERAS VILLAGE COMMUNITY CENTER  
4 DISTRICT TO EXPAND THE USES OF AD VALOREM TAX FUNDS COLLECTED  
5 BY THE COUNTY ON BEHALF OF THE DISTRICT FOR THE CONSTRUCTION  
6 AND MAINTENANCE OF MULTIUSE PATHWAYS AROUND THE VILLAGE.

7 The General Assembly of North Carolina enacts:

8 **SECTION 1.(a)** The Board of County Commissioners of Dare County is hereby  
9 authorized to call an election to be conducted by the Board of Elections of Dare County in  
10 Hatteras voting precinct as described in this subsection for the purpose of submitting to the  
11 voters therein the single issue of authorizing the Hatteras Village Community Center District to  
12 expand the uses of the ad valorem tax authorized in Chapter 212 of the Session Laws of 1981 to  
13 include funding the construction and maintenance of multiuse pathways around the village of  
14 Hatteras.

15 The area of the district is more specifically described as follows: All of the Hatteras  
16 Voting Precinct bounded on the west by Hyde County, on the north by Avon Voting Precinct,  
17 on the east by Frisco Voting Precinct, and on the south by the Atlantic Ocean, all as shown on  
18 the map in the office of the Board of Elections of Dare County, North Carolina, entitled  
19 "ELECTION PRECINCT BOUNDARIES – DARE COUNTY" dated July 13, 1978, signed by  
20 Orman L. Mann, Chairman, Dare County Board of Elections, which said map is incorporated  
21 herein by reference.

22 **SECTION 1.(b)** The election provided for in this section shall be conducted in  
23 accordance with Chapter 163 of the General Statutes. The Board of Elections of Dare County  
24 shall determine and declare the results of the election and certify the same to the Board of  
25 County Commissioners of Dare County, and the same shall thereupon be spread upon the  
26 minutes of the Board.

27 **SECTION 1.(c)** The ballot shall contain the date of the election, the words  
28 "Hatteras Village", and shall further be in the following form:

29 "[ ] FOR allowing the Hatteras Village Community Center District to expand the  
30 uses of the ad valorem tax authorized in Chapter 212 of the Session Laws of  
31 1981 to include funding the construction and maintenance of multiuse  
32 pathways around the village of Hatteras."

33 "[ ] AGAINST allowing the Hatteras Village Community Center District to  
34 expand the uses of the ad valorem tax authorized in Chapter 212 of the  
35 Session Laws of 1981 to include funding the construction and maintenance  
36 of multiuse pathways around the village of Hatteras."

1 The ballot shall contain the facsimile signature of the Chairman of the Board of  
2 Elections of Dare County.

3 **SECTION 1.(d)** If a majority of the qualified voters voting at the election shall  
4 vote in favor of allowing the Hatteras Village Community Center District to expand the uses of  
5 the ad valorem tax to include funding the construction and maintenance of multiuse pathways  
6 around the village of Hatteras, the Board of County Commissioners of Dare County shall, upon  
7 receipt of the certified copy of the results of the election from the Board of Elections, adopt a  
8 resolution to that effect and shall file a copy of the resolution with the Clerk of the Superior  
9 Court of Dare County.

10 **SECTION 2.(a)** Sections 4 and 5 of Chapter 212 of the Session Laws of 1981 read  
11 as rewritten:

12 "Sec. 4. If a majority of the qualified voters voting at said election shall vote in favor of  
13 creating the Hatteras Village Community Center District and the levying of a tax as aforesaid  
14 for the operation, maintenance and repair of a community center building, as provided by this  
15 act, the Board of County Commissioners of Dare County shall upon receipt of the certified  
16 copy of the results of said election from the Board of Elections adopt a resolution creating the  
17 Hatteras Township Community Center District, and shall file a copy of the said resolution so  
18 adopted with the Clerk of the Superior Court of Dare County. Upon creation and establishment  
19 of the Hatteras Village Community Center District, the Board of County Commissioners of  
20 Dare County be and it is hereby authorized and directed to levy and collect an ad valorem tax  
21 on all taxable property in said district in such amount as it may deem necessary, not exceeding  
22 fifteen cents (15c) on each one hundred dollar (\$100.00) taxable valuation of property in said  
23 district from year to year, and shall cause the same to be kept in a separate and special fund, to  
24 be used only for the maintenance, operation and repair of a community center within said  
25 ~~district, district~~ and for the construction and maintenance of multiuse pathways around the  
26 village of Hatteras, as provided by Section 5 of this act.

27 "Sec. 5. The Hatteras Village Community Center District shall constitute a political  
28 subdivision of the State of North Carolina, and shall be a body corporate and politic, exercising  
29 public power. The Hatteras Village Community Center District is authorized to establish,  
30 operate and maintain the community center for the use and benefit of all the residents of the  
31 district by: providing suitable facilities for public meetings; for public agencies providing  
32 services to the public; providing recreational park and playground facilities; providing facilities  
33 for meetings of civic and fraternal organizations; and providing facilities for the general use of  
34 residents of the district in all matters relating to the improvement of the general health and  
35 welfare of said district and all matters of community interest. The Hatteras Village Community  
36 Center District is also authorized to fund the construction and maintenance of multiuse  
37 pathways around the village of Hatteras.

38 The district and its governing body shall have the following powers:

40 (7) To fund the construction and maintenance of multiuse pathways around the  
41 village of Hatteras."

42 **SECTION 2.(b)** This section becomes effective only if a majority of the qualified  
43 voters voting at the election provided for in Section 1 of this act vote in favor of allowing the  
44 Hatteras Village Community Center District to expand the uses of the ad valorem tax to include  
45 funding the construction and maintenance of multiuse pathways around the village of Hatteras.

46 **SECTION 3.** This act is effective when it becomes law.
