| 5  | <b>SECTION 1.</b> G.S. 20-63(b1)(47) is reenacted as it existed immediately before its              |
| 6  | repeal.   |
| 7  | <b>SECTION 2.</b> G.S. 20-79.4(b)(6) is reenacted as it existed immediately before its              |
| 8  | repeal.   |
| 9  | SECTION 3.(a) The Alpha Phi Alpha Fraternity special registration plate listed as                   |
| 10 | expired in G.S. 20.79.7(a1) and (b) is reenacted as it existed immediately before its repeal.       |
| 11 | SECTION 3.(b) The additional fee amount for the Alpha Phi Alpha Fraternity                          |
| 12 | special registration plate listed under G.S. 20.79.7(a1), as reenacted by this section, is modified |
| 13 | to thirty dollars (\$30.00). The Revisor of Statutes shall reorganize the table accordingly.        |
| 14 | SECTION 3.(c) The distribution of fees for the Alpha Phi Alpha Fraternity special                   |
| 15 | registration plate listed under G.S. 20.79.7(b), as reenacted by this section, is modified to ten   |
| 16 | dollars (\$10.00) for the Special Registration Plate Account (SRPA) and twenty dollars (\$20.00)    |
| 17 | for the Collegiate and Cultural Attraction Plate Account (CCAPA). The Revisor of Statutes shall     |
| 18 | reorganize the table accordingly.   |
| 19 | <b>SECTION 4.</b> G.S. 20-81.12(b39) is reenacted as it existed immediately before its              |
| 20 | repeal and reads as rewritten:  |
| 21 | "(b39) Alpha Phi Alpha Fraternity. – The Division must receive 300 or more applications for         |
| 22 | the Alpha Phi Alpha Fraternity plate before the plate may be developed. The Division shall          |
| 23 | transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from   |
| 24 | the sale of the Alpha Phi Alpha Fraternity plates to the Association of North Carolina Alphamen     |
| 25 | (ANCA) Educational Foundation Education Consortium of North Carolina, Inc., for scholarships        |
| 26 | for the benefit of African-American males in ANCA-attending accredited North Carolina               |
| 27 | colleges and universities."   |
| 28 | <b>SECTION 5.</b> This act becomes effective July 1, 2018.  |
