1 A BILL TO BE ENTITLED  
2 AN ACT TO PROVIDE DISASTER RELIEF FROM HURRICANE DORIAN AND OTHER  
3 NAMED STORMS.

4 The General Assembly of North Carolina enacts:

15 **SECTION 4.1.** Sections 4.2, 4.3, 5.21, 5.22, and 5.23 of S.L. 2018-136 apply to this  
16 act and are incorporated by reference.

18 **EACH APPROPRIATION AND ALLOCATION IS MAXIMUM AND CONDITIONAL**

19 **SECTION 4.2.** The appropriations and allocations made in this act are for maximum  
20 amounts necessary to implement this act. Savings shall be effected where the total amounts  
21 appropriated or allocated are not required to implement this act.

23 **APPROPRIATION OF FEDERAL FUNDS**

24 **SECTION 4.3.** Appropriation/Federal Funds. – Funds received on or after  
25 September 4, 2019, for federal disaster assistance programs for State disasters as a result of  
26 Hurricane Dorian are appropriated in the amounts provided in the notifications of award from  
27 the federal government or any entity acting on behalf of the federal government to administer  
28 federal disaster recovery funds. The Office of State Budget and Management and affected State  
29 agencies shall report all notifications of award to the Joint Legislative Commission on  
30 Governmental Operations and the Fiscal Research Division of the General Assembly.

32 **LEGISLATIVE REVIEW OF FEDERAL FUNDING AND REMAINING UNMET**  
33 **NEEDS**

34 **SECTION 4.4.** It is the intent of the General Assembly to review the funds  
35 appropriated by Congress for disaster relief and to consider actions needed to address any



1 remaining unmet needs. It is also the intent of the General Assembly to review the adequacy of  
2 the measures funded by this act at that time.

4 **PART V. EFFECTIVE DATE**

5 **SECTION 5.1.** Except as otherwise provided, this act is effective when it becomes  
6 law.
