1 A BILL TO BE ENTITLED
2 AN ACT TO AMEND THE MEMBERSHIP OF THE GENERAL STATUTES COMMISSION
3 TO REPEAL THE APPOINTING AUTHORITY OF THE CHARLOTTE SCHOOL OF
4 LAW, WHICH HAS CLOSED; TO PROVIDE FOR THE TERMS OF MEMBERS TO
5 BEGIN ON SEPTEMBER 1 RATHER THAN JUNE 1; AND TO HARMONIZE TWO
6 PROVISIONS DEALING WITH VACANCIES AND HOLDOVER MEMBERS, AS
7 RECOMMENDED BY THE GENERAL STATUTES COMMISSION.

8 The General Assembly of North Carolina enacts:

9 SECTION 1. G.S. 164-14 reads as rewritten:

10 "§ 164-14. **Membership; appointments; terms; vacancies.**

11 (a) The Commission shall consist of ~~14~~¹³ members, who shall be appointed as follows:

12 (1) One member, by the president of the North Carolina State ~~Bar~~;Bar.

13 (2) One member, by the General Statutes ~~Commission~~;Commission.

14 (3) One member, by the dean of the school of law of the University of North
15 ~~Carolina~~;Carolina.

16 (4) One member, by the dean of the school of law of Duke ~~University~~;University.

17 (5) One member, by the dean of the school of law of Wake Forest
18 ~~University~~;University.

19 (6) One member, by the Speaker of the House of Representatives of each General
20 Assembly from the membership of the ~~House~~;House.

21 (7) One member, by the President Pro Tempore of the Senate of each General
22 Assembly from the membership of the ~~Senate~~;Senate.

23 (8) Two members, by the ~~Governor~~;Governor.

24 (9) One member, by the dean of the school of law of North Carolina Central
25 ~~University~~;University.

26 (10) One member by the president of the North Carolina Bar
27 ~~Association~~;Association.

28 (11) One member, by the dean of the school of law of Campbell University.

29 (12) One member, by the dean of the school of law of Elon University.

30 ~~(13) One member, by the dean of the Charlotte School of Law (NC), Inc.~~

31 (b) ~~Appointments of original members of the Commission made by the president of the~~
32 ~~North Carolina State Bar, the president of the North Carolina Bar Association, and the deans of~~
33 ~~the schools of law of Duke University, the University of North Carolina, and Wake Forest~~
34 ~~University shall be for one year. Appointments of original members of the Commission made by~~



1 the Speaker of the House of Representatives, the President of the Senate, and the Governor shall
2 be for two years.

3 (c) ~~After the appointment of the original members of the Commission, appointments~~
4 Appointments by the president of the North Carolina State Bar, the General Statutes Commission,
5 and the deans of the schools of law of North Carolina Central University, Duke University, Elon
6 University, the University of North Carolina, and Wake Forest University shall be made in the
7 even-numbered years, and appointments made by the Speaker of the House of Representatives,
8 the President Pro Tempore of the Senate, the president of the North Carolina Bar Association,
9 the deans ~~dean~~ of the School of Law ~~school of law~~ of Campbell University and the Charlotte
10 School of Law (NC), Inc., University, and the Governor shall be made in the odd-numbered
11 years. ~~Such appointments~~ Appointments shall be made for two-year terms beginning ~~June first~~
12 September 1 of the year when ~~such~~ the appointments are to become effective and expiring ~~May~~
13 ~~31~~ August 31 two years thereafter. ~~All such appointments shall be made not later than May 31 of~~
14 ~~the year when such appointments are to become effective.~~

15 (d) If any appointment provided for by this section is not made prior to June first of the
16 year when it should become effective, a vacancy shall exist with respect thereto, and the vacancy
17 shall then be filled by appointment by the Governor. If any member of the Commission dies or
18 resigns during the term for which he was appointed, his successor for the unexpired term shall
19 be appointed by the person who made the original appointment, as provided in G.S. 164-14, or
20 by the successor of such person; and if such vacancy is not filled within 30 days after the vacancy
21 occurs, it shall then be filled by appointment by the Governor. In any case where an appointment
22 authorized to be made by G.S. 164-14(c) has not been made on or before July 31 of the year in
23 which it was due to be made, a vacancy shall exist with respect to that appointment and the
24 General Statutes Commission at its next meeting shall by majority vote fill the vacancy by
25 appointment. a member of the Commission resigns, dies, or ceases to be a member for any other
26 reason, a vacancy exists with respect to that appointment and the original appointing authority
27 shall appoint a new member to fill the unexpired term.

28 This subsection does not apply when a member is continuing to serve under subsection (f) of
29 this section.

30 (e) All appointments shall be reported to the secretary of the Commission.

31 (f) Notwithstanding the expiration of the term of the appointment, the terms of members
32 of the General Statutes Commission shall continue until the appointment of a successor has been
33 made and reported to the secretary of the Commission."

34 **SECTION 2.** The repeal of G.S. 164-14(a)(13) by Section 1 of this act becomes
35 effective August 31, 2019. The remainder of this act is effective when it becomes law. The terms
36 of the current members of the General Statutes Commission are extended to August 31 of the
37 year in which they would otherwise expire.
