Short Title: Death by Distribution. (Public) Sponsors: Referred to: March 28, 2019 1 A BILL TO BE ENTITLED 2 AN ACT TO CREATE THE OFFENSES OF DEATH BY DISTRIBUTION OF CERTAIN 3 CONTROLLED SUBSTANCES AND AGGRAVATED DEATH BY DISTRIBUTION OF 4 CERTAIN CONTROLLED SUBSTANCES. 5 Whereas, the General Assembly finds that the number of deaths resulting from 6 opioid-related overdoses has drastically increased over the past 20 years; and 7 Whereas, the General Assembly finds that the number of deaths resulting from 8 opioid-related overdoses is unlikely to be reduced so long as the drug continues to be made 9 available through illegal distribution by drug dealers; and 10 Whereas, the General Assembly finds that the legal distribution of opioids should only be through a prescription issued for a legitimate medical purpose by an individual 11 practitioner acting in the usual course of his or her professional practice; and 12 Whereas, it is the intent of the General Assembly to strengthen the laws to act as a 13 14 greater deterrent to persons who want to illegally distribute opioids and further exacerbate the opioid epidemic; Now, therefore, 15 The General Assembly of North Carolina enacts: 16 17 **SECTION 1.** Article 6 of Chapter 14 of the General Statutes is amended by adding 18 a new section to read: 19 "§ 14-18.4. Death by distribution of certain controlled substances; aggravated death by 20 distribution of certain controlled substances; penalties. Legislative Intent. - The General Assembly recognizes that deaths due to the opioid 21 (a) epidemic are devastating families and communities across North Carolina. The General 22 Assembly finds that the opioid crisis is overwhelming medical providers engaged in the lawful 23 24 distribution of controlled substances and is straining prevention and treatment efforts. Therefore, 25 the General Assembly enacts this law to encourage effective intervention by the criminal justice 26 system to hold illegal drug dealers accountable for criminal conduct that results in death. Death by Distribution of Certain Controlled Substances. - A person is guilty of death 27 (b) by distribution of certain controlled substances if all of the following requirements are met: 28 29 The person unlawfully sells or delivers at least one certain controlled (1)30 substance to the victim. The ingestion of the certain controlled substance or substances causes the 31 (2)32 death of the user. The commission of the offense in subdivision (1) of this subsection was the 33 (3) proximate cause of the victim's death. 34 The person did not act with malice. 35 (4)
