Short Title: Delay NC HealthConnex for Certain Providers. (Public)

5 HEALTHCONNEX.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.(a)** G.S. 90-414.4(a1)(1) reads as rewritten:

8 "(1) ~~The Except as otherwise provided in this section, the~~ following providers of
9 Medicaid services that have an electronic health record system shall begin
10 submitting demographic and clinical data by June 1, 2018:

- 11 a. Hospitals as defined in G.S. 131E-176(13).
12 b. Physicians licensed to practice under Article 1 of Chapter 90 of the
13 General Statutes.
14 c. Physician assistants as defined in 21 NCAC 32S.0201.
15 d. Nurse practitioners as defined in 21 NCAC 36.0801."

16 **SECTION 1.(b)** G.S. 90-414.4(a1)(3) reads as rewritten:

17 "(3) The following entities shall submit encounter and claims data, as appropriate,
18 in accordance with the following time line:

- 19 a. Prepaid Health Plans, as defined in S.L. 2015-245, by the
20 commencement date of a capitated contract with the Division of
21 Health Benefits for the delivery of Medicaid and NC Health Choice
22 services as specified in S.L. 2015-245.
23 b. Local management entities/managed care organizations, as defined in
24 G.S. 122C-3, by June 1, 2020.
25 c. The following providers by June 1, 2021:
26 1. Psychiatrists licensed to practice under Article 1 of Chapter 90
27 of the General Statutes.
28 2. Licensed psychologists, as defined in G.S. 90-270.2(6).
29 3. Licensed psychological associates, as defined in
30 G.S. 90-270.2(7).
31 4. Licensed professional counselors, as defined in
32 G.S. 90-330(a)(2).
33 5. Substance abuse professionals, as defined in
34 G.S. 90-113.31A(26).
35 6. Licensed clinical social workers, as defined in G.S. 90B-3(6a).

- 1 7. Licensed clinical social worker associates, as defined in
- 2 G.S. 90B-3(6b).
- 3 8. Fee-based pastoral counselors, as defined in G.S. 90-382(4).
- 4 9. Licensed marriage and family therapists, as defined in
- 5 G.S. 90-270.47(3).
- 6 10. Providers of one or more of the following services for
- 7 individuals with intellectual or developmental disabilities:
- 8 I. "In-lieu-of" services.
- 9 II. 1915(b)(3) services.
- 10 III. North Carolina Innovations Waiver services.
- 11 IV. Services paid for with single-stream funding.
- 12 11. Adult care homes, as defined in G.S. 131D-2.1.
- 13 12. Family care homes, as defined in G.S. 131D-2.1.
- 14 13. Home care agencies, as defined in G.S. 131E-136(2).
- 15 14. Home health agencies, as defined in G.S. 131E-136(4)."

16 **SECTION 2.** This act is effective when it becomes law.
