33	2019, and shall expire on June 30, 2022. If at the time of the appointment, the Board has not		
34	begun to issue any licenses to operate a massage and bodywork therapy establishment, the		
35	appointee shall be a current owner of a massage and bodywork therapy establishment.		
36	<b>SECTION 3.</b> This act is effective when it becomes law.
