2 AN ACT TO UPDATE STATUTES RELATING TO THE PROVISION OF SERVICES WITH
3 PEOPLE FIRST LANGUAGE BY CHANGING THE PHRASE "MENTAL
4 RETARDATION" TO "INTELLECTUAL DISABILITY" OR "INTELLECTUAL OR
5 OTHER DEVELOPMENTAL DISABILITY" AND TO MAKE FURTHER PEOPLE
6 FIRST LANGUAGE, TECHNICAL, AND CLARIFYING AMENDMENTS IN THOSE
7 STATUTES, AS RECOMMENDED BY THE GENERAL STATUTES COMMISSION.

8 The General Assembly of North Carolina enacts:

10 **PART I. PEOPLE FIRST LANGUAGE AMENDMENTS TO CHAPTER 122C OF THE**
11 **GENERAL STATUTES**

12 **SECTION 1.** G.S. 122C-3 reads as rewritten:

13 **"§ 122C-3. Definitions.**

14 The following definitions apply in this Chapter:

- 15 (1) ~~"Area authority" means the Area authority.~~ – The area mental health,
16 developmental disabilities, and substance abuse authority.
- 17 (2) ~~"Area board" means the Area board.~~ – The area mental health, developmental
18 disabilities, and substance abuse board.
- 19 (2a) ~~"Area director" means the Area director.~~ – The administrative head of the area
20 authority program appointed pursuant to G.S. 122C-121.
- 21 (2b) ~~"Board of county commissioners" includes Board of county commissioners.~~ –
22 Includes the participating boards of county commissioners for multicounty
23 area authorities and multicounty programs.
- 24 (3) ~~"Camp Butner reservation" means the Camp Butner reservation.~~ – The
25 original Camp Butner reservation as may be designated by the Secretary as
26 having been acquired by the State and includes not only areas which are
27 owned and occupied by the State but also those which may have been leased
28 or otherwise disposed of by the State, and shall also include also includes
29 those areas within the municipal boundaries of the Town of Butner and that
30 portion of the extraterritorial jurisdiction of the Town of Butner consisting of
31 lands not owned by the State of North Carolina.
- 32 (4) ~~"City" has the same meaning as City.~~ – As defined in G.S. 153A-1(1).
- 33 (5) ~~"Catchment area" means the Catchment area.~~ – The geographic part of the
34 State served by a specific area authority or county program.

- 1 (6) ~~"Client" means an~~ Client. – An individual who is admitted to and receiving
2 service from, or who in the past had been admitted to and received services
3 from, a facility.
- 4 (7) ~~"Client advocate" means a~~ Client advocate. – A person whose role is to
5 monitor the protection of client rights or to act as an individual advocate on
6 behalf of a particular client in a facility.
- 7 (8) ~~"Commission" means the~~ Commission. – The Commission for Mental Health,
8 Developmental Disabilities, and Substance Abuse Services, established under
9 Part 4 of Article 3 of Chapter 143B of the General Statutes.
- 10 (8a) ~~"Commitment examiner" means a~~ Commitment examiner. – A physician, an
11 eligible psychologist, or any health professional or mental health professional
12 who is certified under G.S. 122C-263.1 to perform the first examination for
13 involuntary commitment described in G.S. 122C-263(c) or G.S. 122C-283(c)
14 as required by Parts 7 and 8 of this Article.
- 15 (9) ~~"Confidential information" means any~~ Confidential information. – Any
16 information, whether recorded or not, relating to an individual served by a
17 facility that was received in connection with the performance of any function
18 of the facility. "Confidential information" does not include statistical
19 information from reports and records or information regarding treatment or
20 services which is shared for training, treatment, habilitation, or monitoring
21 purposes that does not identify clients either directly or by reference to
22 publicly known or available information.
- 23 (9a) ~~"Core services" are services~~ Core services. – Services that are necessary for
24 the basic foundation of any service delivery system. Core services are of two
25 types: front-end service capacity such as screening, assessment, and
26 emergency triage, and indirect services such as prevention, education, and
27 consultation at a community level.
- 28 (10) ~~"County of residence" of a client means the~~ County of residence. – The county
29 of ~~his a client's~~ domicile at the time of his or her admission or commitment to
30 a facility. A county of residence is not changed because an individual is
31 temporarily out of his or her county in a facility or otherwise.
- 32 (10a) ~~"County program" means a~~ County program. – A mental health,
33 developmental disabilities, and substance abuse services program established,
34 operated, and governed by a county pursuant to G.S. 122C-115.1.
- 35 (11) ~~"Dangerous to self or others" means:~~ Dangerous to self or others. –
36 a. ~~"Dangerous to self" means that within~~ Dangerous to self. – Within the
37 relevant past: past, the individual has done any of the following:
38 1. The individual has acted in such a way as to ~~show:~~ show all of
39 the following:
40 I. ~~That he~~ The individual would be unable, without care,
41 supervision, and the continued assistance of others not
42 otherwise available, to exercise self-control, judgment,
43 and discretion in the conduct of ~~his~~ the individual's
44 daily responsibilities and social relations, or to satisfy
45 ~~his~~ the individual's need for nourishment, personal or
46 medical care, shelter, or self-protection and ~~safety;~~
47 ~~and safety.~~
48 II. ~~That there~~ There is a reasonable probability of ~~his~~ the
49 individual's suffering serious physical debilitation
50 within the near future unless adequate treatment is
51 given pursuant to this Chapter. A showing of behavior

- 1 that is grossly irrational, of actions that the individual
 2 is unable to control, of behavior that is grossly
 3 inappropriate to the situation, or of other evidence of
 4 severely impaired insight and judgment shall create a
 5 prima facie inference that the individual is unable to
 6 care for ~~himself; or himself or herself.~~
 7 2. The individual has attempted suicide or threatened suicide and
 8 that there is a reasonable probability of suicide unless adequate
 9 treatment is given pursuant to this ~~Chapter; or Chapter.~~
 10 3. The individual has mutilated himself or herself or has
 11 attempted to mutilate himself or herself and that there is a
 12 reasonable probability of serious self-mutilation unless
 13 adequate treatment is given pursuant to this Chapter.
 14 Previous episodes of dangerousness to self, when applicable, may be
 15 considered when determining reasonable probability of physical
 16 debilitation, suicide, or self-mutilation.
 17 b. ~~"Dangerous to others" means that within~~ Dangerous to others. –
 18 Within the relevant past, the individual has inflicted or attempted to
 19 inflict or threatened to inflict serious bodily harm on another, or has
 20 acted in such a way as to create a substantial risk of serious bodily
 21 harm to another, or has engaged in extreme destruction of property;
 22 and that there is a reasonable probability that this conduct will be
 23 repeated. Previous episodes of dangerousness to others, when
 24 applicable, may be considered when determining reasonable
 25 probability of future dangerous conduct. Clear, cogent, and convincing
 26 evidence that an individual has committed a homicide in the relevant
 27 past is prima facie evidence of dangerousness to others.
 28 (11a) ~~"Day/night service" means a~~ Day/night service. – A service provided on a
 29 regular basis, in a structured environment that is offered to the same individual
 30 for a period of three or more hours within a 24-hour period.
 31 (12) ~~"Department" means the~~ Department. – The North Carolina Department of
 32 Health and Human Services.
 33 (12a) ~~"Developmental disability" means a~~ Developmental disability. – A severe,
 34 chronic disability of a person ~~which;~~ that satisfies all of the following:
 35 a. Is attributable to a mental or physical impairment or combination of
 36 mental and physical ~~impairments;~~ impairments.
 37 b. Is manifested before the person attains age 22, unless the disability is
 38 caused by a traumatic head injury and is manifested after age ~~22;~~ 22.
 39 c. Is likely to continue ~~indefinitely;~~ indefinitely.
 40 d. Results in substantial functional limitations in three or more of the
 41 following areas of major life activity: self-care, receptive and
 42 expressive language, capacity for independent living, learning,
 43 mobility, ~~self-direction~~ self-direction, and economic ~~self-sufficiency;~~
 44 ~~and~~ self-sufficiency.
 45 e. Reflects the person's need for a combination and sequence of special
 46 interdisciplinary, or generic care, treatment, or other services which
 47 are of a lifelong or extended duration and are individually planned and
 48 ~~coordinated;~~ coordinated.
 49 f. ~~When applied to children from birth through four years of age, may be~~
 50 ~~evidenced as a developmental delay.~~

1 When applied to children from birth through four years of age, a
 2 developmental disability may be evidenced as a developmental delay.

3 (13) ~~"Division" means the Division.~~ – The Division of Mental Health,
 4 Developmental Disabilities, and Substance Abuse Services of the Department.

8 (13c) ~~"Eligible infants and toddlers" means children~~ Eligible infants and toddlers. –
 9 Children with or at risk for developmental delays or atypical development
 10 ~~until~~ until all of the following have occurred:

11 a. ~~They have reached their third birthday;~~ birthday.

12 b. Their parents have requested to have them receive services in the
 13 preschool program for children with disabilities established under
 14 Article 9 of Chapter 115C of the General Statutes; ~~and Statutes.~~

15 c. They have been placed in the program by the local educational agency.
 16 In no event shall a child be considered an eligible toddler after the beginning
 17 of the school year immediately following the child's third birthday, unless the
 18 Secretary and the State Board enter into an agreement under
 19 G.S. 115C-106.4(e) [G.S. 115C-107.1(e)]. ~~G.S. 115C-107.1(c).~~

20 The early intervention services that may be provided for these children
 21 and their families include early identification and screening, multidisciplinary
 22 evaluations, case management services, family training, counseling and home
 23 visits, psychological services, speech pathology and audiology, and
 24 occupational and physical therapy. All evaluations performed as part of early
 25 intervention services shall be appropriate to the individual child's age and
 26 development.

27 (13d) ~~"Eligible psychologist" means a~~ Eligible psychologist. – A licensed
 28 psychologist who has at least two years' clinical experience. After January 1,
 29 1995, "eligible psychologist" means a licensed psychologist who holds
 30 permanent licensure and certification as a health services provider
 31 psychologist issued by the North Carolina Psychology Board.

32 (14) ~~"Facility" means any~~ Facility. – Any person at one location whose primary
 33 purpose is to provide services for the care, treatment, habilitation, or
 34 rehabilitation of the mentally ill, the developmentally disabled, individuals
 35 with mental illnesses or intellectual or other developmental disabilities or
 36 substance abusers, and ~~includes;~~ includes all of the following:

37 a. ~~An "area facility",~~ facility," which is a facility that is operated by or
 38 under contract with the area authority or county program. For the
 39 purposes of this subparagraph, a contract is a contract, memorandum
 40 of understanding, or other written agreement whereby the facility
 41 agrees to provide services to one or more clients of the area authority
 42 or county program. Area facilities may also be licensable facilities in
 43 accordance with Article 2 of this Chapter. A State facility is not an
 44 area ~~facility;~~ facility.

45 b. A "licensable facility", ~~facility,"~~ which is a facility for one or more
 46 minors or for two or more adults that provides services to individuals
 47 who are mentally ill, developmentally disabled, have mental illnesses
 48 or intellectual or other developmental disabilities or are substance
 49 abusers for one or more minors or for two or more adults. ~~abusers.~~
 50 These services shall be day services offered to the same individual for
 51 a period of three hours or more during a 24-hour period, or residential

- 1 services provided for 24 consecutive hours or more. Facilities for
 2 individuals who are substance abusers include chemical dependency
 3 ~~facilities;facilities.~~
- 4 c. A "private ~~facility~~,"facility," which is a facility that is either a
 5 licensable facility or a special unit of a general hospital or a part of
 6 either in which the specific service provided is not covered under the
 7 terms of a contract with an area ~~authority~~;authority.
- 8 d. The psychiatric service of the University of North Carolina Hospitals
 9 at Chapel ~~Hill~~;Hill.
- 10 e. A "residential ~~facility~~,"facility," which is a 24-hour facility that is not
 11 a hospital, including a group ~~home~~;home.
- 12 f. A "State facility", which is a facility that is operated by the
 13 ~~Secretary~~;Secretary.
- 14 g. A "24-hour ~~facility~~,"facility," which is a facility that provides a
 15 structured living environment and services for a period of 24
 16 consecutive hours or more and includes hospitals that are facilities
 17 under this ~~Chapter~~;andChapter.
- 18 h. A Veterans Administration facility or part thereof that provides
 19 services for the care, treatment, habilitation, or rehabilitation of ~~the~~
 20 ~~mentally ill, the developmentally disabled, individuals with mental~~
 21 ~~illnesses or intellectual or other developmental disabilities~~ or
 22 substance abusers.
- 23 (15) "~~Guardian~~" means a ~~Guardian.~~ – A person appointed as a guardian of the
 24 person or general guardian by the court under Chapters 7A or 35A or former
 25 Chapters 33 or 35 of the General Statutes.
- 26 (16) "~~Habilitation~~" means ~~training~~;Habilitation. – ~~Training,~~ care, and specialized
 27 therapies undertaken to assist a client in maintaining his current level of
 28 functioning or in achieving progress in developmental skills areas.
- 29 (16a) "~~Health screening~~" means an ~~Health screening.~~ – An appropriate screening
 30 suitable for the symptoms presented and within the capability of the entity,
 31 including ancillary services routinely available to the entity, to determine
 32 whether or not an emergency medical condition exists. An emergency medical
 33 condition exists if an individual has acute symptoms of sufficient severity,
 34 including severe pain, such that the absence of immediate medical attention
 35 could reasonably be expected to result in placing the individual's health in
 36 serious jeopardy, serious impairment to bodily functions, or serious
 37 dysfunction of any bodily organ or part.
- 38 (16b) "~~Incapable~~" with ~~Incapable.~~ – ~~With respect to an individual has the same~~
 39 ~~definition set forth~~ ~~individual,~~ as defined in G.S. 122C-72(4). An adult
 40 individual who is incapable is not the same as an incompetent adult unless the
 41 adult individual has been adjudicated incompetent under Chapter 35A of the
 42 General Statutes.
- 43 (17) "~~Incompetent adult~~" means an ~~Incompetent adult.~~ – An adult individual who
 44 has been adjudicated incompetent under Chapter 35A of the General Statutes.
- 45 (17a) Intellectual disability. – A developmental disability characterized by
 46 significantly subaverage general intellectual functioning existing concurrently
 47 with deficits in adaptive behavior and manifested before age 22.
- 48 (18) "~~Intoxicated~~" means the ~~Intoxicated.~~ – ~~The condition of an individual whose~~
 49 ~~mental or physical functioning is presently substantially impaired as a result~~
 50 ~~of the use of alcohol or other substance.~~

- 1 (19) ~~"Law enforcement officer" means sheriff,~~ Law enforcement officer. – Sheriff,
 2 deputy sheriff, police officer, State highway patrolman, or an officer
 3 employed by a city or county under G.S. 122C-302.
- 4 (20) ~~"Legally responsible person" means:~~ Legally responsible person. – The
 5 following:
 6 a. ~~(i) when~~ When applied to an ~~adult,~~ adult who has been adjudicated
 7 incompetent, a ~~guardian;~~ guardian.
 8 b. ~~(ii) when~~ When applied to a minor, a parent, guardian, a person
 9 standing in loco parentis, or a legal custodian other than a parent who
 10 has been granted specific authority by law or in a custody order to
 11 consent for medical care, including psychiatric ~~treatment;~~ treatment.

- 45 (23) ~~"Mentally retarded with accompanying behavior disorder" means an~~
 46 ~~individual who is mentally retarded and who has a pattern of maladaptive~~
 47 ~~behavior that is recognizable no later than adolescence and is characterized by~~
 48 ~~gross outbursts of rage or physical aggression against other individuals or~~
 49 ~~property.~~
- 50 (23a) ~~"Minimally adequate services" means a~~ Minimally adequate services. – A
 51 level of service required for compliance with all applicable State and federal

- 1 laws, rules, regulations, and policies and with generally accepted professional
 2 standards and principles.
- 3 (24) ~~"Next of kin" means the~~ Next of kin. – ~~The individual designated in writing~~
 4 ~~by the client or his the client's~~ legally responsible person upon the client's
 5 ~~acceptance at a facility; provided that if facility. If no such designation has~~
 6 ~~been made, "next of kin" means the client's spouse or nearest blood relation~~
 7 ~~in accordance with G.S. 104A-1.~~
- 8 (25) ~~"Operating costs" means expenditures~~ Operating costs. – ~~Expenditures made~~
 9 ~~by an area authority in the delivery of services for mental health,~~

 11 ~~and includes the employment of legal counsel on a temporary basis to~~

- 49 (37) ~~"Substance abuser" means an Substance abuser.~~ – An individual who engages
50 in substance abuse.

(38) ~~"Targeted population" means those~~ Targeted population. – Those individuals who are given service priority under the State Plan.

(39) ~~"Uniform portal process" means a~~ Uniform portal process. – A standardized process and procedures used to ensure consumer access to, and exit from, public services in accordance with the State Plan."

SECTION 2. G.S. 122C-57 reads as rewritten:

"§ 122C-57. Right to treatment and consent to treatment.

(a) Each client who is admitted to and is receiving services from a facility has the right to receive age-appropriate treatment for ~~mental health, mental retardation, and substance abuse illness or disability~~, a mental illness, an intellectual or other developmental disability, substance abuse, or a combination thereof. Each client within 30 days of admission to a facility shall have an individual written treatment or habilitation plan implemented by the facility. The client and the client's legally responsible person shall be informed in advance of the potential risks and alleged benefits of the treatment choices.

...

(e) In the case of an involuntarily committed client, treatment measures other than those requiring express written consent as specified in subsection (f) of this section may be given despite the refusal of the client, the client's legally responsible person, a health care agent named pursuant to a valid health care power of attorney, or the client's refusal expressed in a valid advance instruction for mental health treatment in the event of an emergency or when consideration of side effects related to the specific treatment measure is given and in the professional judgment, as documented in the client's record, of the treating physician and a second physician, who is either the director of clinical services of the facility, or the director's designee, ~~either;~~ that any of the following is true:

- (1) The client, without the benefit of the specific treatment measure, is incapable of participating in any available treatment plan which will give the client a realistic opportunity of improving the client's ~~condition;~~ condition.
- (2) There is, without the benefit of the specific treatment measure, a significant possibility that the client will harm self or others before improvement of the client's condition is realized.

...."

SECTION 3. G.S. 122C-63 reads as rewritten:

"§ 122C-63. Assurance for continuity of care for individuals with ~~mental retardation~~ intellectual disabilities.

(a) Any individual with ~~mental retardation~~ an intellectual disability admitted for residential care or treatment for other than respite or emergency care to any residential facility operated under the authority of this Chapter and supported all or in part by ~~state appropriated~~ State-appropriated funds has the right to residential placement in an alternative facility if the client is in need of placement and if the original facility can no longer provide the necessary care or treatment.

(b) The operator of a residential facility providing residential care or treatment, for other than respite or emergency care, for individuals with ~~mental retardation~~ intellectual disabilities shall notify the area authority serving the client's county of residence of ~~his~~ the operator's intent to close a facility or to discharge a client who may be in need of continuing care at least 60 days prior to the closing or discharge.

The operator's notification to the area authority of intent to close a facility or to discharge a client who may be in need of continuing care constitutes the operator's acknowledgement of the obligation to continue to serve the client ~~until~~ until whichever of the following occurs first:

- (1) The area authority determines that the client is not in need of continuing ~~care;~~ care.
- (2) The client is moved to an alternative residential ~~placement;~~ or placement.

1 (3) Sixty days have ~~elapsed~~elapsed.
 2 ~~whichever occurs first.~~

3 In cases in which the safety of the client who may be in need of continuing care, of other
 4 clients, of the staff of the residential facility, or of the general public, is concerned, this 60-day
 5 notification period may be waived by securing an emergency placement in a more secure and
 6 safe facility. The operator of the residential facility shall notify the area authority that an
 7 emergency placement has been arranged within 24 hours of the placement. The area authority
 8 and the Secretary shall retain their respective responsibilities upon receipt of this notice.

9 (c) An individual who may be in need of continuing care may be discharged from a
 10 residential facility without further claim for continuing care against the area authority or the State
 11 ~~if~~if any of the following is true:

12 (1) After the parent or guardian, if the client is a minor or an adjudicated
 13 incompetent adult, or the client, if an adult not adjudicated incompetent, has
 14 entered into a contract with the operator upon the client's admission to the
 15 original residential ~~facility~~facility, the parent, guardian, or client who entered
 16 into the contract refuses to carry out the ~~contract~~or contract.

17 (2) After an alternative placement for a client in need of continuing care is located,
 18 the parent or guardian who admitted the client to the residential facility, if the
 19 client is a minor or an adjudicated incompetent adult, or the ~~client~~client, if the
 20 client is an adult not adjudicated incompetent, refuses the alternative
 21 placement.

22 (d) Decisions made by the area authority regarding the need for continued placement or
 23 regarding the availability of an alternative placement of a client may be appealed pursuant to the
 24 appeals process of the area authority and subsequently to the Secretary or the Commission under
 25 their rules. If the appeal process extends beyond the operator's 60-day obligation to continue to
 26 serve the client, the Secretary shall arrange a temporary placement in a ~~State facility for the~~
 27 ~~mentally retarded~~State developmental center pending the outcome of the appeal.

28 (e) The area authority that serves the county of residence of the client is responsible for
 29 assessing the need for continuity of care and for the coordination of the placement among
 30 available public and private facilities whenever the authority is notified that a client may be in
 31 need of continuing care. If an alternative placement is not available beyond the operator's 60-day
 32 obligation to continue to serve the client, the Secretary shall arrange for a temporary placement
 33 in a ~~State facility for the mentally retarded~~State developmental center. The area authority shall
 34 retain responsibility for coordination of placement during a temporary placement in a State
 35 ~~facility~~developmental center.

36 (f) The Secretary is responsible for coordinative and financial assistance to the area
 37 authority in the performing of its duties to coordinate placement so as to assure continuity of care
 38 and for assuring a continuity of care placement beyond the operator's 60-day obligation period.

39 (g) The area authority's financial responsibility, through local and allocated State
 40 resources, is limited ~~to~~to the following:

41 (1) Costs relating to the identification and coordination of alternative
 42 ~~placements~~placements.

43 (2) If the original facility is an area facility, maintenance of the client in the
 44 original facility for up to 60 ~~days~~and days.

45 (3) Release of allocated categorical State funds used to support the care or
 46 treatment of the specific client at the time of alternative placement if the
 47 Secretary requires the release.

48 (h) In accordance with G.S. 143B-147(a)(1) the Commission shall develop programmatic
 49 rules to implement this section, and, in accordance with G.S. 122C-112(a)(6), the Secretary shall
 50 adopt budgetary rules to implement this section."

51 **SECTION 4.** G.S. 122C-202 reads as rewritten:

1 **"§ 122C-202. Applicability of Article.**

2 This Article applies to all facilities unless expressly provided otherwise. Specific provisions
3 that are delineated by the disability of the client, whether ~~mentally ill, mentally retarded,~~
4 ~~developmentally disabled, or~~ the client has a mental illness, has an intellectual or other
5 developmental disability, or is a substance abuser, also apply to all facilities for that client's
6 disability. Provisions that refer to a specific facility or type of facility apply only to the designated
7 facility or facilities."

16 incompetency proceedings under those Chapters shall have no effect upon admission or
17 commitment proceedings under this Article."

18 **SECTION 6.** G.S. 122C-241 reads as rewritten:

21 intellectual or other developmental disabilities may be admitted to a facility for ~~the~~

24 admission is made as follows:

36 (b) Prior to admission to a 24-hour facility, the individual shall be examined and
37 evaluated by a physician or psychologist to determine whether the individual ~~is developmentally~~
38 ~~disabled.~~ has a developmental disability. In addition, the individual shall be examined and
39 evaluated by a qualified developmental disabilities professional no sooner than 31 days prior to
40 admission or within 72 hours after admission to determine whether the individual is in need of
41 care, habilitation, rehabilitation, ~~training~~training, or treatment by the facility. If the evaluating
42 professional determines that the individual will not benefit from an admission, the individual
43 shall not be admitted as a client.

44 (c) An admission to an area or State 24-hour facility of an individual from a single portal
45 area shall follow the procedures as prescribed in the area plan. When an individual from a single
46 portal area presents himself or herself or is presented for admission ~~to a State facility for the~~
47 ~~mentally retarded~~ directly to a State developmental center and is in need of an emergency
48 admission, he or she may be accepted for admission. The State ~~facility~~developmental center
49 shall notify the area authority within 24 hours of the admission and further planning of treatment
50 for the individual is the joint responsibility of the area authority and the State ~~facility~~
51 developmental center as prescribed in the area plan."

1 **SECTION 7.** G.S. 122C-261 reads as rewritten:

2 "**§ 122C-261. Affidavit and petition before clerk or magistrate when immediate**
3 **hospitalization is not necessary; custody order.**

4 (a) Anyone who has knowledge of an individual who ~~is mentally ill~~ has a mental illness
5 and is either (i) dangerous to self, as defined in G.S. 122C-3(11)a., or dangerous to others, as
6 defined in G.S. 122C-3(11)b., or (ii) in need of treatment in order to prevent further disability or
7 deterioration that would predictably result in dangerousness, may appear before a clerk or
8 assistant or deputy clerk of superior court or a magistrate and execute an affidavit to this effect,
9 and petition the clerk or magistrate for issuance of an order to take the respondent into custody
10 for examination by a commitment examiner. The affidavit shall include the facts on which the
11 affiant's opinion is based. If the affiant has knowledge or reasonably believes that the respondent,
12 in addition to ~~being mentally ill, is also mentally retarded,~~ having a mental illness, also has an
13 intellectual disability, this fact shall be stated in the affidavit. Jurisdiction under this subsection
14 is in the clerk or magistrate in the county where the respondent resides or is found.

15 (b) If the clerk or magistrate finds reasonable grounds to believe that the facts alleged in
16 the affidavit are true and that the respondent ~~is probably mentally ill~~ probably has a mental illness
17 and is either (i) dangerous to self, as defined in G.S. 122C-3(11)a., or dangerous to others, as
18 defined in G.S. 122C-3(11)b., or (ii) in need of treatment in order to prevent further disability or
19 deterioration that would predictably result in dangerousness, the clerk or magistrate shall issue
20 an order to a law enforcement officer or any other designated person under G.S. 122C-251(g) to
21 take the respondent into custody for examination by a commitment examiner. If the clerk or
22 magistrate finds that, in addition to ~~probably being mentally ill,~~ probably having a mental illness,
23 the respondent ~~is also probably mentally retarded,~~ also probably has an intellectual disability, the
24 clerk or magistrate shall contact the area authority before issuing a custody order and the area
25 authority shall designate the facility to which the respondent is to be taken for examination by a
26 commitment examiner. The clerk or magistrate shall provide the petitioner and the respondent,
27 if present, with specific information regarding the next steps that will occur for the respondent.

28 (c) If the clerk or magistrate issues a custody order, the clerk or magistrate shall also
29 make inquiry in any reliable way as to whether the respondent is indigent within the meaning of
30 G.S. 7A-450. A magistrate shall report the result of this inquiry to the clerk.

31 (d) If the affiant is a commitment examiner, all of the following apply:

33 (6) If the clerk or magistrate finds probable cause to believe that the respondent,
34 in addition to ~~being mentally ill, is also mentally retarded,~~ having a mental
35 illness, also has an intellectual disability, the clerk or magistrate shall contact
36 the area authority before issuing the order and the area authority shall
37 designate the facility to which the respondent is to be transported.

39 (f) Notwithstanding the provisions of this section, in no event shall an individual known
40 or reasonably believed to ~~be mentally retarded~~ have an intellectual disability be admitted to a
41 State psychiatric hospital, except as follows:the following:

42 (1) Persons described in ~~G.S. 122C-266(b);~~ G.S. 122C-266(b).

43 (2) Persons admitted pursuant to ~~G.S. 15A-1321;~~ G.S. 15A-1321.

44 (3) Respondents who are so extremely dangerous as to pose a serious threat to the
45 community and to other patients committed to non-State hospital psychiatric
46 inpatient units, as determined by the Director of the Division of Mental
47 Health, Developmental Disabilities, and Substance Abuse Services or ~~his~~
48 ~~designee;~~ and the Director's designee.

49 (4) Respondents who are so gravely disabled by both multiple disorders and
50 medical fragility or multiple disorders and deafness that alternative care is
51 inappropriate, as determined by the Director of the Division of Mental Health,

1 Developmental Disabilities, and Substance Abuse Services or ~~his~~ the
2 Director's designee.

3 Individuals transported to a State facility for ~~the mentally ill~~ individuals with mental illnesses
4 who are not admitted by the facility may be transported by appropriate law enforcement officers
5 or designated staff of the State facility in State-owned vehicles to an appropriate 24-hour facility
6 that provides psychiatric inpatient care.

7 No later than 24 hours after the transfer, the responsible professional at the original facility
8 shall notify the petitioner, the clerk of court, and, if consent is granted by the respondent, the next
9 of kin, that the transfer has been completed."

10 **SECTION 8.** G.S. 122C-262 reads as rewritten:

11 "**§ 122C-262. Special emergency procedure for individuals needing immediate**
12 **hospitalization.**

13 (a) Anyone, including a law enforcement officer, who has knowledge of an individual
14 who is subject to inpatient commitment according to the criteria of G.S. 122C-263(d)(2) and who
15 requires immediate hospitalization to prevent harm to self or others, may transport the individual
16 directly to an area facility or other place, including a State facility for ~~the mentally ill~~ individuals
17 with mental illnesses, for examination by a commitment examiner in accordance with
18 G.S. 122C-263(c).

19 (b) Upon examination by the commitment examiner, if the individual meets the inpatient
20 commitment criteria specified in G.S. 122C-263(d)(2) and requires immediate hospitalization to
21 prevent harm to self or others, the commitment examiner shall so certify in writing before any
22 official authorized to administer oaths. The certificate shall also state the reason that the
23 individual requires immediate hospitalization. If the commitment examiner knows or has reason

25 shall so state.

27 (d) Anyone, including a law enforcement officer if necessary, may transport the
28 individual to a 24-hour facility described in G.S. 122C-252 for examination and treatment

30 indigent and unable to pay for care at a private 24-hour facility, the law enforcement officer or
31 other designated person providing transportation shall take the respondent to a State facility for
32 ~~the mentally ill~~ individuals with mental illnesses designated by the Commission in accordance
33 with ~~G.S. 143B-147(a)(1)~~ G.S. 143B-147(a)(1)a, and immediately notify the clerk of superior
34 court of this action. The commitment examiner's certificate shall serve as the custody order and
35 the law enforcement officer or other designated person shall provide transportation in accordance

37 appropriate to the respondent's medical condition, the respondent may be temporarily detained

35 (a) Without unnecessary delay after assuming custody, the law enforcement officer or

37 shall take the respondent to a facility or other location identified by the LME/MCO in the
38 community crisis services plan adopted pursuant to G.S. 122C-202.2 that has an available
39 commitment examiner and is capable of performing a first examination in conjunction with a
40 health screening at the same location, unless ~~exigent circumstances require the respondent be~~
41 ~~transported to an emergency department~~ indicate the respondent appears to be suffering a medical
42 emergency in which case the law enforcement officer will seek immediate medical assistance for
43 the respondent. If a commitment examiner is not available, whether on-site, on-call, or via
44 telemedicine, at any facility or location, or if a plan has not been adopted, the person designated
45 to provide transportation shall take the respondent to an alternative non-hospital provider or
46 facility-based crisis center for a first examination in conjunction with a health screening at the
47 same location. If no non-hospital provider or facility-based crisis center for a first examination
48 in conjunction with a health screening at the same location for health screening and first
49 examination exists, the person designated to provide transportation shall take the respondent to
50 a private hospital or clinic, a general hospital, an acute care hospital, or a State facility for ~~the~~
51 mentally ill. individuals with mental illnesses. If a commitment examiner is not immediately

1 available, the respondent may be temporarily detained in an area facility, if one is available; if
2 an area facility is not available, the respondent may be detained under appropriate supervision in
3 the respondent's home, in a private hospital or a clinic, in a general hospital, or in a State facility
4 for ~~the mentally ill, individuals with mental illnesses,~~ but not in a jail or other penal facility. For
5 the purposes of this section, "non-hospital provider" means an outpatient provider that provides
6 either behavioral health or medical services.

7 ...

8 (c) The commitment examiner described in subsection (a) of this section shall examine
9 the respondent as soon as possible, and in any event within 24 hours after the respondent is
10 presented for examination. When the examination set forth in subsection (a) of this section is
11 performed by a commitment examiner, the respondent may either be in the physical face-to-face
12 presence of the commitment examiner or may be examined utilizing telemedicine equipment and
13 procedures. A commitment examiner who examines a respondent by means of telemedicine must
14 be satisfied to a reasonable medical certainty that the determinations made in accordance with
15 subsection (d) of this section would not be different if the examination had been done in the
16 physical presence of the commitment examiner. A commitment examiner who is not so satisfied
17 must note that the examination was not satisfactorily accomplished, and the respondent must be
18 taken for a face-to-face examination in the physical presence of a person authorized to perform
19 examinations under this section. As used in this section, "telemedicine" is the use of two-way
20 real-time interactive audio and video between places of lesser and greater medical capability or
21 expertise to provide and support health care when distance separates participants who are in
22 different geographical locations. A recipient is referred by one provider to receive the services
23 of another provider via telemedicine.

24 The examination shall include an assessment of at least all of the following with respect to
25 the respondent:

- 26 (1) Current and previous mental illness and ~~mental retardation~~ intellectual
27 disability including, if available, previous treatment history.
- 28 (2) Dangerousness to self, as defined in G.S. 122C-3(11)a. or others, as defined
29 in G.S. 122C-3(11)b.
- 30 (3) Ability to survive safely without inpatient commitment, including the
31 availability of supervision from family, ~~friends~~ friends, or others.
- 32 (4) Capacity to make an informed decision concerning treatment.

33 (d) After the conclusion of the examination the commitment examiner shall make the
34 following determinations:

- 35 (1) If the commitment examiner finds all of the ~~following~~ following, the
36 commitment examiner shall so show on the examination report and shall
37 recommend outpatient commitment:
 - 38 a. The respondent ~~is mentally ill~~ has a mental illness.
 - 39 b. The respondent is capable of surviving safely in the community with
40 available supervision from family, friends, or others.
 - 41 c. Based on the respondent's psychiatric history, the respondent is in need
42 of treatment in order to prevent further disability or deterioration that
43 would predictably result in dangerousness as defined by
44 G.S. 122C-3(11).
 - 45 d. The respondent's current mental status or the nature of the respondent's
46 illness limits or negates the respondent's ability to make an informed
47 decision to seek voluntarily or comply with recommended treatment.

48 ~~The commitment examiner shall so show on the examination report and shall~~
49 ~~recommend outpatient commitment.~~ In addition addition, the commitment
50 examiner shall show the name, address, and telephone number of the proposed
51 outpatient treatment physician or center in accordance with subsection (f) of

1 this section. The person designated in the order to provide transportation shall
2 return the respondent to the respondent's regular residence or, with the
3 respondent's consent, to the home of a consenting individual located in the
4 originating county, and the respondent shall be released from custody.

5 (2) If the commitment examiner finds that the respondent is ~~mentally ill~~ has a

(4) ~~To a~~ A training center or other private, nonprofit, charitable organization offering education, treatment, rehabilitation, or developmental programs to ~~the physically or mentally handicapped, individuals with physical disabilities or intellectual or other developmental disabilities,~~ and may otherwise assist such organizations; provided, however, such action ~~the organizations. Such action, however,~~ shall be with the concurrence of the county board of education; ~~and provided, further, that within~~ education. Within 30 days after receipt of the request for concurrence, the county board of education shall notify the board of county commissioners whether it concurs, and should it fail to so notify the board of county commissioners within such ~~this~~ period, it shall be deemed to have concurred.

(b) The ordinance making the appropriation shall state specifically what the appropriation is to be used for, and the board of commissioners shall require that the recipient account for the appropriation at the close of the fiscal year."

(7) Providing hospital facilities, including without limitation general, tuberculosis, mental, chronic disease, and other types of hospitals and related facilities such as laboratories, outpatient departments, nurses' homes and training facilities, and central service facilities operated in connection with hospitals; facilities for the provision of public health services, including related facilities such as laboratories, clinics, and administrative offices; facilities specially designed for the diagnosis, treatment, education, training, or custodial care of ~~the mentally retarded, individuals with intellectual or other developmental disabilities,~~ including facilities for training specialists and sheltered workshops for ~~the mentally retarded, individuals with intellectual or other developmental disabilities;~~ nursing homes; and in connection with the foregoing, laundries, nurses', doctors', or interns' residences, administrative buildings, research facilities, maintenance, storage, and utility facilities, auditoriums, dining halls, food service and preparation facilities, fire prevention facilities, mental and physical health care facilities, dental care facilities, nursing schools, mental teaching facilities, offices, parking facilities, and other supporting service structures.

(c) Each county ~~is authorized to~~ may borrow money and issue its bonds under this Article in evidence of the debt for the purpose of, in the case of subdivisions (1) through (4b) of this subsection, paying any capital costs of any one or more of the purposes and, in the case of subdivisions (5) and (6) of this subsection, to finance the cost of the purpose:

(6) Providing housing projects for persons of low or moderate income, including construction or acquisition of projects to be owned by a county, redevelopment commission, or housing authority and the provision of loans, grants, interest supplements, and other programs of financial assistance to ~~such~~ these persons.  20 moderate income, or low and moderate income, and developers of housing for

22 General Statutes or by city charters."

23 24 **PART III. SAVINGS PROVISION AND EFFECTIVE DATE**

25 **SECTION 33.** This act does not affect the coverage, eligibility, rights,
26 responsibilities, or provision of State or federal services or benefits for individuals who have
27 been diagnosed with mental retardation and whose diagnosis has not been changed to a diagnosis
28 of intellectual disability.

29 **SECTION 34.** Except as otherwise provided, this act becomes effective October 1,
30 2019, and applies to proceedings commenced or services rendered on or after that date.
