HOUSE BILL DRH30518-MGa-190

Short Title: PDT Pilot Program for Opioid Use Disorder. (Public)

1 A BILL TO BE ENTITLED
2 AN ACT ESTABLISHING A PILOT PROGRAM TO ASSESS THE EFFECTIVENESS OF
3 PRESCRIPTION DIGITAL THERAPEUTICS AUTHORIZED BY THE FEDERAL FOOD
4 AND DRUG ADMINISTRATION FOR THE TREATMENT OF OPIOID USE
5 DISORDER; AND APPROPRIATING FUNDS FOR THAT PURPOSE.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** It is the intent of the General Assembly to combat the opioid epidemic
8 in this State by expanding access to innovative evidence-based treatments for individuals with
9 opioid use disorder. To that end, the State Controller shall transfer the sum of one million eight
10 hundred fifty thousand dollars (\$1,850,000) in nonrecurring funds for the 2022-2023 fiscal year
11 from funds available in the Opioid Abatement Reserve established in Section 9F.1 of S.L.
12 2021-180 to the Opioid Abatement Fund in the Department of Health and Human Services. Funds
13 transferred under this section are appropriated to the Department of Health and Human Services,
14 Division of Mental Health, Developmental Disabilities, and Substance Abuse Services
15 (DMH/DD/SAS), to develop and administer a two-year pilot program to gauge the effectiveness
16 of prescription digital therapeutics (PDTs) authorized by the federal Food and Drug
17 Administration for the treatment of opioid use disorder. The funds appropriated in this section
18 shall not revert at the end of the 2022-2023 fiscal year but shall remain available to expend until
19 December 1, 2024, or upon the termination of the pilot program, whichever is sooner.

20 **SECTION 2.** The pilot program authorized by this act shall be subject to all of the
21 following requirements and limitations:

- 22 (1) The pilot program shall commence no later than December 1, 2022, and
23 terminate no later than December 1, 2024.
- 24 (2) The DMH/DD/SAS shall determine all of the following:
- 25 a. The number of sites at which the pilot program will be conducted;
26 provided, however, that the sites shall include regions that are
27 geographically diverse.
- 28 b. Eligibility requirements for pilot program participants.
- 29 c. The specific types of PDTs that will be prescribed and evaluated under
30 the pilot program; provided, however, that the selected PDTs must be
31 authorized by the federal Food and Drug Administration for the
32 treatment of opioid use disorder.
- 33 (3) The DMH/DD/SAS may use up to one hundred fifty thousand dollars
34 (\$150,000) of these allocated funds for administrative purposes.

35 **SECTION 3.** Within six months after the termination of the pilot program authorized
36 by this act, the DMH/DD/SAS shall submit a report to the Joint Legislative Oversight Committee



1 on Health and Human Services on the impact of the pilot program. The report shall include at
2 least all of the following components:

- 3 (1) A breakdown of all expenditures from the funds appropriated to the
4 DMH/DD/SAS for the pilot program authorized by this act.
- 5 (2) The number and location of pilot program sites.
- 6 (3) The number of pilot program participants selected to participate at each site
7 and a description of their individual opioid use disorder treatment plans prior
8 to and upon entering the pilot program.
- 9 (4) Identification of the specific PDTs prescribed to treat pilot program
10 participants and an evaluation of their effectiveness, as measured by
11 successful completion of their individual treatment goals.
- 12 (5) An explanation of whether and how the PDTs prescribed to pilot program
13 participants improved their access to treatment.
- 14 (6) A review of how satisfied program participants were with the PDTs prescribed
15 for their treatment.
- 16 (7) The impact of the pilot program on issues related to health equity and the
17 hospitalization of pilot program participants, as compared to the patient
18 population at large.
- 19 (8) An explanation of the successes and challenges of the pilot program.
- 20 (9) Any recommendations for future coverage of PDTs by State-funded
21 healthcare programs, along with a cost-benefit analysis for such coverage.
- 22 (10) Any other information the DMH/DD/SAS deems relevant in examining the
23 effectiveness of using PDTs to treat opioid use disorder.

24 **SECTION 4.** This act becomes effective July 1, 2022.
