#### STATE AGENCY OPERATIONAL NEEDS

15 **SECTION 1.2.(a)** There is appropriated from the General Fund to the Office of State 16 Budget and Management the sum of twenty million dollars (\$20,000,000) in nonrecurring funds 17 for the 2020-2021 fiscal year to be allocated to provide additional funds for the continuity of 18 State agency operations experiencing increased costs due to the COVID-19 pandemic. These 19 funds may be used (i) for incurred COVID-19 related expenses, (ii) to purchase needed supplies 20 and equipment to mitigate operational disruptions, (iii) to continue providing critical services, 21 and (iv) to ensure the safety of State employees and the public.

SECTION 1.2.(b) There is appropriated from the General Fund to the Office of State 22 23 Budget and Management the sum of ten million dollars (\$10,000,000) in nonrecurring funds for 24 the 2021-2022 fiscal year to be allocated to the Department of Agriculture and Consumer 25 Services, the Department of Environmental Quality, and the Department of Natural and Cultural 26 Resources to provide support for fee-supported activities and programs at each agency that has 27 experienced substantial declines in revenue due to the COVID-19 pandemic. These funds will 28 support continued delivery of current services at a minimal level and may also be used to continue 29 planning for post-pandemic resumption of normal service levels.

### LOCAL GOVERNMENT COMMISSION FINANCIAL ASSISTANCE

32 **SECTION 1.3.** Local Government Commission Financial Assistance. – There is 33 appropriated from the General Fund to the Office of the State Treasurer, Local Government 34 Commission, the sum of one million dollars (\$1,000,000) in nonrecurring funds for the 35 2020-2021 fiscal year for the purpose of supporting essential services provided by units of local 36 government whose control of financial affairs is fully assumed by the Local Government 37 Commission under Article 11 of Subchapter IV of Chapter 159 of the General Statutes.
