2	AN ACT ALLOWING LAW ENFORCEMENT, PROBATION/PAROLE, AND
3	CORRECTIONAL OFFICERS WHO HOLD AN ADVANCED LAW ENFORCEMENT
4	OR CORRECTIONS CERTIFICATE ISSUED BY THE NORTH CAROLINA CRIMINAL
5	JUSTICE EDUCATION AND TRAINING STANDARDS COMMISSION OR THE
6	ADVANCED LAW ENFORCEMENT CERTIFICATE ISSUED BY THE NORTH
7	CAROLINA SHERIFFS' EDUCATION AND TRAINING STANDARDS COMMISSION
8	TO PURCHASE AT FULL COST UP TO FOUR YEARS' CREDITABLE SERVICE IN
9	THE TEACHERS' AND STATE EMPLOYEES' RETIREMENT SYSTEM OR THE
10	LOCAL GOVERNMENTAL EMPLOYEES' RETIREMENT SYSTEM.
11	The General Assembly of North Carolina enacts:
12	<b>SECTION 1.</b> G.S. 135-4 is amended by adding a new subsection to read:
13	"(k2) Credit at Full Cost for Law Enforcement, Probation/Parole Officers, and Correctional
14	Officers Holding an Advanced Law Enforcement or Corrections Certificate Notwithstanding
15	any other provisions of this Chapter, a member who has completed at least five years of
16	membership service and who has been awarded the Advanced Law Enforcement Certificate or
17	the Advanced Corrections Certificate issued by the North Carolina Criminal Justice Education
18	and Training Standards Commission under the authority granted in Chapter 17C of the General
19	Statutes or the Advanced Law Enforcement Certificate issued by the North Carolina Sheriffs'
20	Education and Training Standards Commission under the authority granted in Chapter 17E of the
21	General Statutes may purchase up to a total of four years' creditable service at any time on or
22	after receipt of the certificate. Purchases of service under this subsection shall not be subject to
23	subsection (b) of this section. Purchases of service under this subsection shall not be associated
24	with any specific compensation or period of time. The member shall purchase this service by
25	making a lump sum amount payable to the Annuity Savings Fund equal to the full liability of the
26	service credits calculated on the basis of the assumptions used for purposes of the actuarial
27	valuation of the liabilities of the Retirement System. The calculation of the amount payable shall
28	take into account the retirement allowance arising on account of the additional service credit
29	commencing at the earliest age at which the member could retire on an unreduced retirement
30	allowance, as determined by the Board of Trustees upon the advice of the consulting actuary,
31	plus an administrative fee to be set by the Board of Trustees. Notwithstanding the foregoing
32	provisions of this subsection that provide for the purchase of service credits, the terms "full cost"
33	and "full liability" include assumed annual postretirement allowance increases, as determined by

1	the Board of Trustees, from the earliest age at which a member could retire on an unreduced
2	service allowance."
3	<b>SECTION 2.</b> G.S. 128-26 is amended by adding a new subsection to read:
4	"(z) Credit at Full Cost for Law Enforcement Officers Holding an Advanced Law
5	Enforcement Certificate Notwithstanding any other provisions of this Chapter, a member who
6	has completed at least five years of membership service and who has been awarded the Advanced
7	Law Enforcement Certificate issued by the North Carolina Criminal Justice Education and
8	Training Standards Commission under the authority granted in Chapter 17C of the General
9	Statutes or the North Carolina Sheriffs' Education and Training Standards Commission under the
10	authority granted in Chapter 17E of the General Statutes may purchase up to a total of four years'
11	creditable service at any time on or after receipt of the Advanced Law Enforcement Certificate.
12	Purchases of service under this subsection shall not be subject to subsection (b) of this section.
13	The purchased service shall not be associated with any specific compensation or period of time.
14	The member shall purchase this service by making a lump sum amount payable to the Annuity
15	Savings Fund equal to the full liability of the service credits calculated on the basis of the
16	assumptions used for purposes of the actuarial valuation of the liabilities of the Retirement
17	System. The calculation of the amount payable shall take into account the retirement allowance
18	arising on account of the additional service credit commencing at the earliest age at which the
19	member could retire on an unreduced retirement allowance, as determined by the Board of
20	Trustees upon the advice of the consulting actuary, plus an administrative fee to be set by the
21	Board of Trustees. Notwithstanding the foregoing provisions of this subsection that provide for
22	the purchase of service credits, the terms "full cost" and "full liability" include assumed annual
23	postretirement allowance increases, as determined by the Board of Trustees, from the earliest age
24	at which a member could retire on an unreduced service allowance."
25	<b>SECTION 3.</b> This act becomes effective July 1, 2021.
