2 AN ACT TO INCREASE THE PENALTIES FOR BREAKING AND ENTERING INTO 3 CERTAIN LAW ENFORCEMENT VEHICLES AND FOR THE THEFT OF CERTAIN 4

- 5 The General Assembly of North Carolina enacts: 6

SECTION 1. G.S. 14-56 reads as rewritten:

7 "§ 14-56. Breaking or entering into or breaking out of railroad cars, motor vehicles, 8 trailers, aircraft, boats, or other watercraft.

9 If any person, with intent to commit any felony or larceny therein, breaks or enters (a) 10 any railroad car, motor vehicle, trailer, aircraft, boat, or other watercraft of any kind, containing any goods, wares, freight, or other thing of value, or, after having committed any felony or 11 larceny therein, breaks out of any railroad car, motor vehicle, trailer, aircraft, boat, or other 12 13 watercraft of any kind containing any goods, wares, freight, or other thing of value, that person is guilty of a Class I felony. It is prima facie evidence that a person entered in violation of this 14 section if he is found unlawfully in such a railroad car, motor vehicle, trailer, aircraft, boat, or 15 16 other watercraft.

17	<u>(a1)</u>	If any person violates subsection (a) of this section, that person is guilty of a Class H
18	felony if b	oth of the following conditions are met:

19	<u>(1)</u>	The railroad car, motor vehicle, trailer, aircraft, boat, or other watercraft of
20		any kind is owned or operated by any law enforcement agency, the North
21		Carolina National Guard, or any branch of the Armed Forces of the United
22		States.

23 The person knows or reasonably should know that the railroad car, motor (2)vehicle, trailer, aircraft, boat, or other watercraft of any kind is owned or 24 operated by any law enforcement agency, the North Carolina National Guard, 25 26 or any branch of the Armed Forces of the United States.

27 It shall not be a violation of this section for any person to break or enter any railroad (b) car, motor vehicle, trailer, aircraft, boat, or other watercraft of any kind to provide assistance to 28 29 a person inside the railroad car, motor vehicle, trailer, aircraft, boat, or watercraft of any kind if 30 one or more of the following circumstances exist:

The person acts in good faith to access the person inside the railroad car, motor 31 (1)vehicle, trailer, aircraft, boat, or watercraft of any kind in order to provide first 32 33 aid or emergency health care treatment or because the person inside is, or is 34 in imminent danger of becoming unconscious, ill, or injured.
