SENATE BILL DRS45286-MKa-124

Short Title: Interdisciplinary Health Ed Teaching Pilot. (Public)

Sponsors: Senator Woodard (Primary Sponsor).

1 A BILL TO BE ENTITLED  
2 AN ACT TO DIRECT THE NORTH CAROLINA AREA HEALTH EDUCATION CENTERS  
3 PROGRAM TO ESTABLISH INTERDISCIPLINARY HEALTH EDUCATION  
4 TEACHING HUBS AND TO STUDY IMPEDIMENTS TO THE AVAILABILITY OF  
5 COMMUNITY-BASED PRECEPTORS FOR STUDENTS IN RURAL AND  
6 UNDERSERVED AREAS.

7 Whereas, North Carolina's health care workforce is maldistributed based on  
8 geography (urban vs. rural) and specialty (inpatient vs. outpatient); and

9 Whereas, health care professional trainees taught in rural and underserved areas are  
10 more likely to practice in similar settings upon graduation; and

11 Whereas, most clinical rotations in rural and underserved areas occur in outpatient  
12 community clinics; and

13 Whereas, most health professionals are compensated based on productivity; and

14 Whereas, training, specifically precepting, students requires time which reduces a  
15 health professional's productivity; and

16 Whereas, most health professionals in community settings receive little or no  
17 compensation or protected time to teach; and

18 Whereas, the lack of compensation or protected time to teach combined with lost  
19 productivity has made it increasingly and persistently difficult for health professionals in rural  
20 outpatient settings to teach; and

21 Whereas, health professional schools (medical, nursing, physician assistant, and  
22 others) have expressed concerns about an insufficient number of sites and that community  
23 teachers limit their ability to accept qualified applicants or sustain their program growths; and

24 Whereas, the need for more community teaching sites is coming at the exact time as  
25 the move to more care in lower-cost outpatient settings as health care moves from a system of  
26 payment based on fee-for-service to one based on value; Now, therefore,  
27 The General Assembly of North Carolina enacts:

28 **SECTION 1.** Pilot Program Established. – The North Carolina Area Health  
29 Education Centers (NC AHEC) Program shall develop a two-year pilot program (Pilot Program)  
30 to establish interdisciplinary health education teaching hubs in at least three safety net health care  
31 clinics, such as Federally Qualified Health Centers and rural health centers, to teach health  
32 professional students from at least three different disciplines, including medical students, nurse  
33 practitioner students, physician assistant students, pharmacy students, dental students, or nursing  
34 students. NC AHEC, in conjunction with the North Carolina Association of Health Centers, shall  
35 issue a request for proposal to select the three teaching sites for the Pilot Program. NC AHEC  
36 shall provide technical assistance, evaluate the results of the Pilot Program, and provide funds



1 for significant clinical teaching time in the selected settings as provided for in Section 3 of this  
2 act. By December 1, 2023, NC AHEC shall submit a report to the Joint Legislative Education  
3 Oversight Committee and the Joint Legislative Oversight Committee on Health and Human  
4 Services on the findings of the Pilot Program.

5 **SECTION 2.** Study. – NC AHEC shall also study the availability of community  
6 preceptors, or community health care professional teachers, in North Carolina and the demand  
7 for those preceptors, including factors that influence the supply for those preceptors in rural  
8 communities, and barriers that community-based outpatient clinicians face in teaching health  
9 care professional students. NC AHEC shall report its findings on the study to the Joint Legislative  
10 Education Oversight Committee and the Joint Legislative Oversight Committee on Health and  
11 Human Services no later than December 1, 2022. NC AHEC shall consult with other health care  
12 professional organizations on the study of the supply of and demand for preceptors in North  
13 Carolina, including, but not limited to, the North Carolina Academy of Family Physicians, the  
14 North Carolina Academy of Physician Assistants, the North Carolina Healthcare Association, the  
15 North Carolina Independent Colleges and Universities, the North Carolina Medical Society, the  
16 North Carolina Nursing Association, the North Carolina Pediatric Society, and The University  
17 of North Carolina.

18 **SECTION 3.** Appropriation. – There is appropriated from the General Fund to the  
19 Board of Governors of The University of North Carolina the sum of one million one hundred  
20 thousand dollars (\$1,100,000) in nonrecurring funds for the 2021-2022 fiscal year and one  
21 million dollars (\$1,000,000) in nonrecurring funds for the 2022-2023 fiscal year to be allocated  
22 to the University of North Carolina at Chapel Hill for the North Carolina Area Health Education  
23 Centers Program to fund the Pilot Program established in accordance with Section 1 of this act.

24 **SECTION 4.** This act becomes effective July 1, 2021.
