Short Title: Protect Those Who Serve and Protect Act. (Public)

A BILL TO BE ENTITLED 1 2 AN ACT TO INCREASE THE PUNISHMENT FOR DISCHARGING OR ATTEMPTING TO 3 DISCHARGE A FIREARM AT OR INTO AN UNOCCUPIED EMERGENCY VEHICLE 4 AND TO INCREASE THE PUNISHMENT FOR POINTING A LASER DEVICE AT A 5 LAW ENFORCEMENT OFFICER OR OTHER EMERGENCY PERSONNEL WHEN 6 THE PERSON OR ANIMAL IS IN THE PERFORMANCE OF HIS OR HER DUTIES. 7 The General Assembly of North Carolina enacts: 8 **SECTION 1.** This act shall be known as the "Protect Those Who Serve and Protect 9 Act." 10 **SECTION 2.** Article 8 of Chapter 14 of the General Statutes is amended by adding 11 a new section to read: 12 "§ 14-34.1A. Discharging certain barreled weapons or a firearm at or into certain unoccupied emergency vehicles. 13 14 Definition. – For purposes of this section, the term "emergency vehicle" means any (a) 15 of the following: 16 (1) A law enforcement vehicle. 17 A fire department vehicle. (2) A public or private ambulance. 18 (3) 19 (4) A rescue squad emergency service vehicle. A vehicle owned or operated by the North Carolina National Guard. 20 (5) 21 A vehicle owned or operated by any branch of the Armed Forces of the United (6) 22 States. 23 A vehicle owned or operated by the Division of Adult Corrections and (7) 24 Juvenile Justice of the Department of Public Safety. 25 Offense. – It is unlawful to willfully or wantonly discharge or attempt to discharge any firearm or barreled weapon capable of discharging shot, bullets, pellets, or other missiles at 26 a muzzle velocity of at least 600 feet per second at or into any unoccupied emergency vehicle. 27 28

(c) <u>Punishment.</u> – <u>Unless the conduct is covered under some other provision of law providing greater punishment, any person who violates subsection (b) of this section is guilty of a Class H felony."</u>

SECTION 3. G.S. 14-34.8 reads as rewritten:

"§ 14-34.8. Criminal use of laser device.
