9	PART I. STATEWIDE ANALYSIS OF DOULA SUPPORT SERVICES				
10	SECTION 1.(a) In order to inform the development of coverage and reimbursement				
11	policies for doula support services in North Carolina, the Department of Health and Human				
12	Services shall conduct a statewide landscape analysis of doula support services. At a minimum,				
13	the following shall be assessed in the analysis:				
14	(1) The availability of doulas and doula services across the State.				
15	(2) The demographic and training background diversity of providers of doula				
16	services.				
17	(3) The standards for the attestation, training, and certification of doulas.				
18	(4) Practical options for health benefit plan policies to include coverage for, or				
19	incentivize the use of, doula support services during pregnancy, labor,				
20	delivery, and the postpartum period as part of value-based payments,				
21	enhanced reimbursements, or as value-added services.				
22	In conducting the analysis, the Department shall convene focus groups with				
23	individuals performing doula support services across the State to further inform and acquire input				
24					
25	No later than November 1, 2026, the Department shall submit a report of its analysis,				
26	including any recommendations requiring legislative action, to the Joint Legislative Oversight				
27	Committee on Health and Human Services.				
28	SECTION 1.(b) Upon the completion of the analysis and the submission of the				
29	report required under this section, the Department of Health and Human Services, Division of				
30	Public Health, shall do all of the following:				
31	(1) Partner with doula training programs and childbirth education organizations,				
32	such as Birth Arts International, Childbirth and Postpartum Professional				
33	Association, DONA International, and the International Childbirth Education				
34	Association, to help set standards for the attestation, training, and certification				
35	of doulas in North Carolina.
