2	AN ACT TO PROVIDE FOR PARTISAN ELECTIONS FOR MEMBERS OF THE			
3	MCDOWELL COUNTY BOARD OF EDUCATION.			
4	The General Assembly of North Carolina enacts:			
5	SECTION 1.(a) Section 1 of Chapter 322 of the 1987 Session Laws, as rewritten by			
6	Chapter 107 of the 1995 Session Laws, reads as rewritten:			
7	"Section 1. Notwithstanding the provisions of G.S. 115C-37, beginning with elections held			
8	in 2024, the McDowell County Board of Education shall be elected on a nonpartisan basis at the			
9	time set by G.S. 163-1 for the general election in 1996 and biennially thereafter. The names of			
10	the candidates shall be printed on the ballot without reference to any party affiliations. The			
11	nonpartisan plurality election method shall be used with the results determined as provided in			
12 13	G.S. 163-292 partisan basis as terms expire. Vacancies on the McDowell County Board of Education for positions elected on a poppartisan basis in 2020 and 2022 shell be filled by			
15 14	Education for positions elected on a nonpartisan basis in 2020 and 2022 shall be filled by appointment by the remaining members of the Board, in accordance with the PLAN FOR
