5	<b>SECTION 1.(a)</b> There is appropriated from the General Fund to the Department of				
6	Commerce (the "Department") the sum of three million one hundred seventy-five thousand				
7	dollars (\$3,175,000) in nonrecurring funds for the 2023-2024 fiscal year to allocate to the East				
8	Market Street Development Corporation, a nonprofit organization, to be used for projects that				
9	stimulate economic growth and small business development and education in East Greensboro

SECTION 1.(c) Fund Disbursement Requirements. – The Department shall award				
funds to EMSDC pursuant to this section within 10 days of the receipt of the preliminary				
statement required under subsection (b) of this section.				
SECTION 1.(d) Allocation Reporting Requirements. – By September 1, 2023, and				
-	eptember 1, 2024, the Department of Commerce shall report to the chairs of the House of			
	Appropriations Committee on Agriculture and Natural			
Resources; the chairs of the Senate Appropriations Committee on Agriculture, Natural, and				
Economic Resources; the chairs of the Joint Legislative Economic Development and Global				
Engagement Oversight Committee; and the Fiscal Research Division on the use of the funds				
appropriated pursuant to this section. The report shall include the following:				
(1)	A discussion of each of the allowable purposes for the use of	of funds pursuant		
	to this section.			
(2)	Information on the number of projects and the type of project	s for which funds		
	were used.			
(3)	The total dollar amount of funds used per project and the to	tal dollar amount		
	of funds used for all projects.			
SECTION 2. Notwithstanding G.S. 143C-6-23(f), funds appropriated by this ac				
shall be held by the Department of Commerce and the allocations to the East Market Street				
Development Corporation shall be released in accordance with the provisions of this act. Funds				
not spent or encumbered by June 30, 2025, shall be returned by the East Market Street				
Development Corporation to the Department of Commerce and revert to the General Fund.				
<b>SECTION 3.</b> Section 1 of this act is effective July 1, 2023. The remainder of this act				
is effective when	1 it becomes law.
