compliance, the Board of Directors of the Authority shall review the criminal history provided 1 2 under subdivision (2) of subsection (a) of this section to ensure that the person has not been 3 convicted of any crime listed in G.S. 115C-332. The Board shall determine through this review 4 whether the nonpublic private school is noncompliant with this section. The Board shall make 5 written findings with regard to how the criminal history information was used when making the 6 compliance determination. The Board of Directors may delegate any of the duties in this 7 subsection to the Executive Director of the Authority. As part of its review, the Board shall 8 determine whether the results indicate that the staff member has any of the following 9 disqualifying characteristics: 10 (1)Poses a threat to the physical safety of students or personnel. (2)Demonstrates that he or she does not have the integrity or honesty to fulfill his 11 12 or her duties in overseeing State funds and the requirements of the scholarship 13 grant program. 14 (3) Has not fully satisfied the criminal sentencing obligations imposed following 15 his or her conviction by a court of competent jurisdiction." 16 **SECTION 1.(e)** G.S. 115C-562.6 reads as rewritten: 17 "§ 115C-562.6. Scholarship endorsement. 18 The Authority shall remit, at least two times each school year, scholarship grant funds 19 awarded to eligible students to the nonpublic school school. Scholarship grant funds awarded to 20 eligible students to a private school shall be remitted for endorsement by at least one of the 21 student's parents or guardians. The parent or guardian shall restrictively endorse the scholarship 22 grant funds awarded to the eligible student for deposit into the account of the nonpublic private 23 school to the credit of the eligible student. The parent or guardian shall not designate any entity 24 or individual associated with the nonpublic private school as the parent's attorney-in-fact to 25 endorse the scholarship grant funds. A parent's or guardian's failure to comply with this section 26 shall result in forfeit of the scholarship grant.
