4 The General Assembly of North Carolina enacts:

6 **PART I. LEGALIZATION OF POSSESSION AND SALE OF CANNABIS**

7 **SECTION 1.1.** The General Statutes are amended by adding a new Chapter to read:

8 "**Chapter 18D.**

9 "**Regulation of Cannabis.**

10 "Article 1.

11 "General Provisions.

12 "**§ 18D-100. Findings.**

13 The General Assembly finds all of the following:

- 14 (1) Cannabis prohibition, like alcohol prohibition before it, has been a wasteful
15 and destructive failure. About half of Americans admit to having used
16 cannabis despite more than eight decades of prohibition.
- 17 (2) Regulating cannabis similarly to alcohol will replace the uncontrolled illicit
18 market with a well-regulated system. Legalization allows regulation and
19 control to protect consumers, workers, communities, and the environment.
- 20 (3) The prohibition of cannabis has had an unfair, disparate impact on persons
21 and communities of color. A 2020 report by the American Civil Liberties
22 Union found black individuals are three and six-tenths times as likely as white
23 individuals to be arrested for cannabis possession, despite nearly identical use
24 rates.
- 25 (4) The prohibition of cannabis diverts law enforcement resources from violent
26 and property crimes and subjects civilians to unnecessary police interactions.
- 27 (5) Keeping cannabis illegal deprives the State of thousands of legal jobs and
28 hundreds of millions of dollars in tax revenue.
- 29 (6) The use of cannabis should be legal for persons 21 years of age or older and
30 subject to taxation and regulation in a manner that does all of the following:
- 31 a. Controls the production and distribution of cannabis under a system of
32 licensing, regulation, and taxation.
- 33 b. Includes lab testing, potency labeling, secure packaging, restrictions
34 on advertising, and education about responsible use and risks.

- 1 c. Fosters a responsible industry, whereby businesses will only be
2 allowed to expand if they prioritize diversity, good wages,
3 sustainability, and community investment.
4 d. Promotes the participation of individuals most impacted by cannabis
5 prohibition in the legal, regulated industry.
6 e. Generates needed revenue, including to reinvest in communities that
7 have been disproportionately impacted by prohibition, for substance
8 abuse treatment and education, and to train more law enforcement
9 officers to detect impaired driving.

- 10 (7) It is necessary to ensure consistency and fairness in the application of this
11 Chapter throughout the State and that, therefore, the matters addressed by this
12 Chapter are, except as specified herein, matters of statewide concern.

13 **§ 18D-101. Definitions.**

14 Unless the context requires otherwise, the following definitions apply in this Chapter:

- 15 (1) Cannabis. – All parts of the plant of the genus cannabis, the seeds thereof, the
16 resin extracted from any part of the plant, and every compound, manufacture,
17 salt, derivative, mixture, or preparation of the plant, its seeds, or its resin,
18 including cannabis concentrate. "Cannabis" does not include hemp, nor does
19 it include fiber produced from the stalks, oil or cake made from the seeds of
20 the plant, or sterilized seed of the plant, which is incapable of germination.
21 (2) Cannabis accessories. – Any equipment, products, or materials of any kind
22 that are used, intended for use, or designed for use in planting, propagating,
23 cultivating, growing, harvesting, composting, manufacturing, compounding,
24 converting, producing, processing, preparing, testing, analyzing, packaging,
25 repackaging, storing, vaporizing, or containing cannabis, or for ingesting,
26 inhaling, or otherwise introducing cannabis into the human body.
27 (3) Cannabis cultivation facility. – An entity registered to cultivate, prepare, and
28 package cannabis and sell cannabis to other cannabis establishments but not
29 to consumers. A cannabis cultivation facility may not produce cannabis
30 concentrates, tinctures, extracts, or other cannabis products unless it is also
31 licensed as a cannabis product manufacturing facility.
32 (4) Cannabis delivery service. – An entity registered to deliver cannabis to
33 consumers.
34 (5) Cannabis establishment. – A cannabis cultivation facility, a cannabis delivery
35 service, an on-site consumption establishment, a cannabis testing facility, a
36 cannabis product manufacturing facility, a cannabis transporter, a retail
37 cannabis store, or any other type of cannabis business authorized and
38 registered by the Department.
39 (6) Cannabis product manufacturing facility. – An entity registered to purchase
40 cannabis; manufacture, prepare, and package cannabis products; and sell
41 cannabis and cannabis products to other cannabis establishments but not to
42 consumers.
43 (7) Cannabis products. – Products that are comprised of cannabis, cannabis
44 concentrate, or cannabis extract and other ingredients and are intended for use
45 or consumption, such as, but not limited to, edible products, ointments, and
46 tinctures.
47 (8) Cannabis testing facility. – An entity registered to test cannabis for potency
48 and contaminants.
49 (9) Cannabis transporter. – An entity registered to transport cannabis between
50 cannabis establishments.

- 1 (10) Consumer. – A person 21 years of age or older who purchases cannabis or
 2 cannabis products for personal use by persons 21 years of age or older, but not
 3 for resale.
 4 (11) Department. – The Department of Public Safety.
 5 (12) Hemp. – The plant of the genus cannabis and any part of such plant, whether
 6 growing or not, with a delta-9 tetrahydrocannabinol concentration that does
 7 not exceed three-tenths percent (0.3%) on a dry weight basis of any part of the
 8 plant cannabis, or per volume or weight of cannabis product, or the combined
 9 percent of delta-9 tetrahydrocannabinol and tetrahydrocannabinolic acid in
 10 any part of the cannabis plant regardless of moisture content.
 11 (13) Locality. – A city or county.
 12 (14) Office. – The Office of Community Reinvestment.
 13 (15) On-site consumption establishment. – An entity registered to sell cannabis or
 14 cannabis products for on-site consumption.
 15 (16) Possession limit. – Any of the following amounts:
 16 a. Two ounces of cannabis in a form other than concentrated cannabis or
 17 cannabis products.
 18 b. Fifteen grams of concentrated cannabis.
 19 c. Cannabis products containing no more than 2,000 milligrams of
 20 tetrahydrocannabinol.
 21 d. Six cannabis plants.
 22 e. Any additional cannabis produced by the person's cannabis plants
 23 provided that the possession of any amount of cannabis in excess of 2
 24 ounces of cannabis, 15 grams of concentrated cannabis, and cannabis
 25 products containing no more than 2,000 milligrams of
 26 tetrahydrocannabinol must be limited to the same property where the
 27 plants were cultivated.
 28 (17) Public place. – Any place to which the general public has access. It does not
 29 include an on-site consumption establishment.
 30 (18) Retail cannabis store. – An entity registered to purchase cannabis from
 31 cannabis establishments and sell cannabis and cannabis products to
 32 consumers.

33 **"§ 18D-102. Applicability.**

34 This Chapter does not apply to medical cannabis regulated under Article 43 of Chapter 90 of
 35 the General Statutes.

36 "Article 2.

37 "Office of Community Reinvestment.

38 **"§ 18D-200. Creation of the Office of Community Reinvestment.**

39 There is established in the Department the Office of Community Reinvestment. The
 40 Governor shall appoint an Executive Director of the Office, who shall have at least five years of
 41 experience in civil rights advocacy, civil rights litigation, or social justice.

42 **"§ 18D-201. Establishment of funds.**

43 (a) The following funds are established in the Department:

44 (1) The Community Reinvestment and Repair Fund.

45 (2) The Cannabis Enterprise Opportunity Fund.

46 (3) The Cannabis Education and Technical Assistance Fund.

47 (b) No later than July 1 of each year, the Office shall produce and make publicly available
 48 a report on how the Community Reinvestment and Repair Fund, Cannabis Enterprise
 49 Opportunity Fund, and Cannabis Education and Technical Assistance Fund were allocated during
 50 the prior fiscal year.

1 (c) No later than November 1 of each year, the Office shall solicit public input on the
2 uses of the Community Reinvestment and Repair Fund, Cannabis Enterprise Opportunity Fund,
3 and Cannabis Education and Technical Assistance Fund. The Office of Community
4 Reinvestment shall publish a review of feedback received no later than December 15 of each
5 year.

6 **"§ 18D-202. Powers and duties of the Office.**

7 The Office shall promote and encourage full participation in the regulated cannabis industry
8 by people from communities that have previously been disproportionately harmed by cannabis
9 prohibition and enforcement in order to positively impact those communities. The Office shall
10 have all of the following powers and duties:

11 (1) Defining, by rule, the term "historically impacted applicant" and considering
12 whether the definition should include any or all of the following:

- 13 a. Individuals with past convictions for a cannabis offense.
14 b. Individuals whose parent had a prior conviction for a cannabis offense.
15 c. Individuals who have had a less than honorable discharge from the
16 military due to cannabis.
17 d. Individuals from census tracts or other geographic areas
18 disproportionately impacted by cannabis enforcement, poverty,
19 unemployment, cannabis prohibition, mass incarceration, or systemic
20 racism.
21 e. Racial and ethnic minorities that have been disproportionately
22 impacted by cannabis enforcement.
23 f. Racial and ethnic minorities that have been disproportionately
24 excluded from the legal cannabis industry.

25 (2) Administering the Community Reinvestment and Repair Fund to improve the
26 well-being of individuals and communities that have experienced a
27 disproportionate negative impact from poverty, unemployment, cannabis
28 prohibition and enforcement, mass incarceration, or systemic racism. Before
29 determining how funds from the Community Reinvestment and Repair Fund
30 will be allocated, the Office shall promote and hold public meetings in at least
31 10 of the census tract areas that have been significantly impacted by poverty,
32 unemployment, cannabis prohibition, mass incarceration, or systemic racism
33 to seek input on the communities' needs and priorities for the Community
34 Reinvestment and Repair Fund. The Office of Community Reinvestment shall
35 distribute funds from the Community Reinvestment and Repair Fund in a
36 manner that improves the well-being of communities and individuals that have
37 been significantly impacted by poverty, unemployment, cannabis prohibition,
38 mass incarceration, or systemic racism. Permissible uses of the fund include,
39 but are not limited to, grants to nonprofit organizations or allocations to
40 government agencies for any of the following:

- 41 a. Housing assistance, including to promote home ownership among
42 members of minority groups that are underrepresented in home
43 ownership due to redlining or discrimination.
44 b. Reentry services, including job training and placement.
45 c. Scholarship assistance for low-income students.
46 d. Grants to community-based organizations to provide services to
47 prevent violence, support youth development, provide early
48 intervention for youth and families, and promote community stability
49 and safety.
50 e. Legal or civic aid.

"§ 18D-301. Licensure and local control.

(a) An on-site consumption establishment shall only operate if the local regulatory authority in the locality where it is located issued a permit, license, or registration that expressly allows the operation of the on-site consumption establishment.

(b) Except as provided in this subsection, a locality may prohibit the operation of any or all types of cannabis establishments within its jurisdiction through the enactment of an ordinance. A locality's prohibition on cannabis establishments shall not prohibit transportation through the locality or deliveries within the locality by cannabis establishments located in other jurisdictions.

(c) A locality may enact ordinances or regulations not in conflict with this Chapter, or with rules enacted pursuant to this Chapter, governing the time, place, manner, and number of cannabis establishment operations. A locality may establish civil penalties for violation of an ordinance or regulations governing the time, place, and manner of a cannabis establishment that may operate in such locality.

(d) No locality may negotiate or enter into a host community agreement with a cannabis establishment or a cannabis establishment applicant. As used in this subsection, a "host community agreement" means an agreement that the cannabis establishment or applicant provide monies, donations, in-kind contributions, services, or anything of value to the locality.

"Article 4.**"Possession and Use of Cannabis.****"§ 18D-400. Personal use of cannabis.**

Notwithstanding any other provision of law, except as otherwise provided in this Chapter, the following acts are not unlawful and shall not be a criminal or civil offense under State law or an ordinance of any locality, or be a basis for seizure or forfeiture of assets under State law, for persons 21 years of age or older:

- (1) Possessing, consuming, ingesting, smoking, growing, using, processing, purchasing, or transporting an amount of cannabis that does not exceed the possession limit.
- (2) Transferring an amount of cannabis that does not exceed the possession limit to a person who is 21 years of age or older without remuneration.
- (3) Controlling property where actions described by this section occur.
- (4) Assisting another person who is 21 years of age or older in any of the acts described in this section.

"§ 18D-401. Restrictions on personal cultivation; penalty.

(a) It is unlawful to cultivate cannabis plants in any of the following ways:

- (1) Cannabis plants may not be cultivated in a location where the plants are subject to public view, including view from another private property, without the use of binoculars, aircraft, or other optical aids.
- (2) A person who cultivates cannabis must take reasonable precautions to ensure the plants are secure from unauthorized access and access by a person under 21 years of age. For purposes of illustration and not limitation, cultivating cannabis in an enclosed, locked space that persons under 21 years of age do not possess a key to constitutes reasonable precautions.
- (3) Cannabis cultivation may only occur on property lawfully in possession of the cultivator or with the consent of the person in lawful possession of the property.

(b) A person who violates subsection (a) of this section is guilty of an infraction, punishable by a fine of up to seven hundred fifty dollars (\$750.00) or up to 75 hours of community service.

"§ 18D-402. Public smoking prohibited; penalty.

(a) It is unlawful to smoke cannabis in a public place.

1 **(b) It is unlawful to smoke cannabis in an area of an on-site consumption establishment**
2 **where cannabis smoking is prohibited.**

3 **(c) A person who violates this section is guilty of an infraction, punishable by a fine of**
4 **up to fifty dollars (\$50.00) or up to five hours of community service.**

5 **"§ 18D-403. Consuming cannabis while operating a moving vehicle prohibited; penalty.**

6 **(a) No person shall consume cannabis while operating or driving a motor vehicle, boat,**
7 **vessel, aircraft, or other motorized device used for transportation.**

8 **(b) Unless the conduct is covered under some other provision of law providing greater**
9 **punishment, a person who violates subsection (a) of this section, and only consumed cannabis,**
10 **is guilty of an infraction, punishable as follows:**

11 **(1) For a first offense, any or all of the following:**

12 **a. A fine of not more than two hundred fifty dollars (\$250.00).**

13 **b. Not more than 25 hours of community service.**

14 **c. Suspension of the person's drivers license for up to six months.**

15 **(2) For a second or subsequent offense, any or all of the following:**

16 **a. A fine of not more than five hundred dollars (\$500.00).**

17 **b. Not more than 50 hours of community service.**

18 **c. Suspension of the person's drivers license for up to one year.**

19 **"§ 18D-404. False identification; penalty.**

20 **(a) A person who is under 21 years of age may not present or offer to a cannabis**
21 **establishment or the cannabis establishment's agent or employee any written or oral evidence of**
22 **age that is false, fraudulent, or not actually the minor's own for either of the following purposes:**

23 **(1) Purchasing, attempting to purchase, or otherwise procuring or attempting to**
24 **procure cannabis.**

25 **(2) Gaining access to a cannabis establishment.**

26 **(b) A person who violates this section is guilty of an infraction, punishable by a fine of**
27 **not more than one hundred fifty dollars (\$150.00) or up to 15 hours of community service.**

28 **"§ 18D-405. Unlawful cannabis extraction; penalty.**

29 **(a) No person, other than a cannabis product manufacturing facility complying with this**
30 **Chapter and Department rules, may perform solvent-based extractions on cannabis using solvents**
31 **other than water, glycerin, propylene glycol, vegetable oil, or food-grade ethanol.**

32 **(b) No person may extract compounds from cannabis using ethanol in the presence or**
33 **vicinity of open flame.**

34 **(c) A person who violates this section is guilty of a Class E felony, which shall include a**
35 **fine of not more than five thousand dollars (\$5,000).**

36 **"§ 18D-406. Cannabis accessories authorized.**

37 **(a) Except as provided in this section, notwithstanding any other provision of law, it is**
38 **not unlawful and shall not be an offense under State law or an ordinance of any locality, or be a**
39 **basis for seizure or forfeiture of assets under State law, for persons 21 years of age or older to**
40 **manufacture, possess, possess with intent to distribute, or purchase cannabis accessories or to**
41 **distribute or sell cannabis accessories to a person who is 21 years of age or older.**

42 **(b) Except as provided in this section, a person who is 21 years of age or older is**
43 **authorized to manufacture, possess, and purchase cannabis accessories and to distribute or sell**
44 **cannabis accessories to a person who is 21 years of age or older. This section is intended to meet**
45 **the requirements of section 863 of Title 21 of the United States Code by authorizing, under State**
46 **law, any person in compliance with this Chapter to manufacture, possess, or distribute cannabis**
47 **accessories.**

48 **(c) No person may manufacture, distribute, or sell cannabis accessories that violate rules**
49 **adopted by the Department. A first offense under this section is an infraction, punishable by a**
50 **fine of up to one thousand dollars (\$1,000) and forfeiture of the cannabis accessories. A second**
51 **or subsequent offense of this section is a Class A1 misdemeanor punishable by a fine of up to**

1 five thousand dollars (\$5,000), up to 180 days in jail, or both, and forfeiture of the cannabis
2 accessories.

3 **"§ 18D-407. Purchasing of cannabis or cannabis accessories unlawful in certain cases;**
4 **penalties; treatment and education programs and services.**

5 (a) No person to whom cannabis or cannabis accessories may not lawfully be sold under
6 this Chapter shall consume, purchase, or possess, or attempt to consume, purchase, or possess,
7 any cannabis or cannabis accessories.

8 (b) Any person 18 years of age or older who violates subsection (a) of this section is
9 guilty of an infraction, punishable by a fine of up to twenty-five dollars (\$25.00) or up to five
10 hours of community service. Additionally, the person shall be ordered to enter a substance abuse
11 treatment or education program or both, if available, that in the opinion of the court best suits the
12 needs of the person.

13 (c) Any juvenile who violates subsection (a) of this section is guilty of an infraction,
14 punishable by a fine of up to twenty-five dollars (\$25.00) or up to five hours of community
15 service. Additionally, the juvenile shall be ordered to enter a substance abuse treatment or
16 education program or both, if available, that in the opinion of the court best suits the needs of the
17 juvenile.

18 **"§ 18D-408. Nondiscrimination for personal use of cannabis.**

19 (a) A person shall not be subject to arrest, prosecution, or penalty in any manner, or be
20 denied any right or privilege, including, but not limited to, disciplinary action by a business,
21 occupational, or professional licensing board or bureau, solely for conduct permitted under this
22 Chapter.

23 (b) Except as provided in this section, neither the State nor any of its political
24 subdivisions may impose any penalty or deny any benefit or entitlement for conduct permitted
25 under this Chapter or for the presence of cannabinoids or cannabinoid metabolites in the urine,
26 blood, saliva, breath, hair, or other tissue or fluid of a person who is 21 years of age or older.

27 (c) Except as provided in this section, the State nor any of its political subdivisions may
28 deny a drivers license, a professional license, housing assistance, social services, or other benefits
29 based on cannabis use or for the presence of cannabinoids or cannabinoid metabolites in the
30 urine, blood, saliva, breath, hair, or other tissue or fluid of a person who is 21 years of age or
31 older.

32 (d) Notwithstanding any provision of law to the contrary, a person shall not be denied
33 custody of or visitation with a minor for acting in accordance with this Chapter, unless the
34 person's behavior is such that it creates an unreasonable danger to the minor that can be clearly
35 articulated and substantiated.

36 (e) Except as provided in this section, neither the State nor any of its political
37 subdivisions may deny employment or a contract to a person for engaging in conduct permitted
38 under this Chapter for a prior conviction for a nonviolent cannabis offense that does not involve
39 distribution to minors, or for testing positive for the presence of cannabinoids or cannabinoid
40 metabolites in the urine, blood, saliva, breath, hair, or other tissue or fluid of the individual's
41 body.

42 (f) For the purposes of medical care, including organ and tissue transplants, the use of
43 cannabis does not constitute the use of an illicit substance or otherwise disqualify a person from
44 needed medical care and may only be considered with respect to evidence-based clinical criteria.

45 (g) Notwithstanding any provision of law to the contrary, unless there is a specific finding
46 that the individual's use, cultivation, or possession of cannabis could create a danger to the
47 individual or another person, it shall not be a violation of conditions of parole, probation, or
48 pretrial release to do either of the following:

49 (1) Engage in conduct allowed by this Chapter.

50 (2) Test positive for cannabis, delta-9 tetrahydrocannabinol, or any other
51 cannabinoid or metabolite of cannabis.

1 (h) This section does not do any of the following:

2 (1) Prevent a government employer from disciplining an employee or contractor
3 for ingesting cannabis in the workplace or for working while impaired by
4 cannabis.

5 (2) Apply to the extent that they conflict with a governmental employer's
6 obligations under federal law or regulations or to the extent that they would
7 disqualify the entity from a monetary or licensing-related benefit under federal
8 law or regulations.

9 (3) Authorize any person to engage in, and does not prevent the imposition of any
10 civil, criminal, discipline, or other penalties, including discipline or
11 termination by a governmental employer, any task while under the influence
12 of cannabis, when doing so would constitute negligence or professional
13 malpractice.

14 **"§ 18D-409. Lawful operation of cannabis-related facilities.**

15 (a) Notwithstanding any other provision of law, engaging in any activities involving
16 cannabis, cannabis accessories, or cannabis products, if the person conducting the activities has
17 obtained a current, valid registration to operate a cannabis establishment or is acting in his or her
18 capacity as an owner, employee, or agent of a registered cannabis establishment and the activities
19 are within the scope of activities allowed by the Department for that type of cannabis
20 establishment, is not unlawful and shall not be an offense under State law or be a basis for seizure
21 or forfeiture of assets under State law.

22 (b) Nothing in this section prevents the imposition of penalties for violating this Chapter
23 or rules adopted by the Department or localities pursuant to this Chapter.

24 **"§ 18D-410. Verifying the age of cannabis consumers.**

25 (a) A cannabis establishment or an agent or staffer of a cannabis establishment may not
26 sell, deliver, distribute, give, transfer, or otherwise furnish cannabis to a person under the age of
27 21.

28 (b) Except as otherwise provided in this section, in a prosecution for selling, transferring,
29 delivering, distributing, giving, or otherwise furnishing cannabis, cannabis products, or cannabis
30 accessories to any person who is under 21 years of age, it is a complete defense if both of the
31 following requirements are met:

32 (1) The person who sold, gave, or otherwise furnished cannabis, cannabis
33 products, or cannabis accessories was a retail cannabis store or on-site
34 consumption establishment or was acting in his or her capacity as an owner,
35 employee, or agent of a retail cannabis store or on-site consumption
36 establishment at the time the cannabis, cannabis products, or cannabis
37 accessories were sold, given, or otherwise furnished to the person.

38 (2) Before selling, giving, or otherwise furnishing cannabis, cannabis products,
39 or cannabis accessories to a person who is under 21 years of age, the person
40 who sold, gave, or otherwise furnished the cannabis or cannabis accessories,
41 or a staffer or agent of the retail cannabis store, was shown a document that
42 appeared to be issued by an agency of a federal, state, tribal, or foreign
43 sovereign government and that indicated that the person to whom the cannabis
44 or cannabis accessories were sold, given, or otherwise furnished was 21 years
45 of age or older at the time the cannabis or cannabis accessories were sold,
46 given, or otherwise furnished to the person.

47 (c) Subsection (b) of this section does not apply if both of the following requirements are
48 met:

49 (1) The document that was shown to the person who sold, gave, or otherwise
50 furnished the cannabis, cannabis products, or cannabis accessories was
51 counterfeit, forged, altered, or issued to a person other than the person to

1 whom the cannabis, cannabis products, or cannabis accessories were sold,
2 given, or otherwise furnished.

- 3 (2) Under the circumstances, a reasonable person would have known or suspected
4 that the document was counterfeit, forged, altered, or issued to a person other
5 than the person to whom the cannabis, cannabis products, or cannabis
6 accessories were sold, given, or otherwise furnished.

7 **"§ 18D-411. Occupational licensing.**

8 (a) A holder of a professional or occupational license may not be subject to professional
9 discipline for providing advice or services related to cannabis establishments or applications to
10 operate cannabis establishments on the basis that cannabis is illegal under federal law.

11 (b) An applicant for a professional or occupational license may not be denied a license
12 based on previous employment related to cannabis establishments operating in accordance with
13 State law.

14 **"§ 18D-412. Private property and tenant rights.**

15 (a) Except as provided in this section, the provisions of this Chapter do not require any
16 person, corporation, or any other entity that occupies, owns, or controls a property to allow the
17 consumption, cultivation, display, sale, or transfer of cannabis on or in that property.

18 (b) Except as provided in this section, a landlord or property manager may not refuse to
19 rent to a tenant, or otherwise discriminate against the tenant, based on a past conviction for a
20 cannabis offense.

21 (c) Except as provided in this section, in the case of the rental of a residential dwelling,
22 a landlord or property manager may not prohibit the possession of cannabis or the consumption
23 of cannabis by nonsmoked means.

24 (d) Subsections (a) through (c) of this section do not apply if any of the following
25 requirements are met:

26 (1) The tenant is not leasing the entire residential dwelling.

27 (2) The residence is incidental to detention or the provision of medical, geriatric,
28 educational, counseling, religious, or similar service.

29 (3) The residence is a transitional housing or sober living facility.

30 (4) Failing to prohibit cannabis possession or consumption would violate federal
31 law or regulations or cause the landlord to lose a monetary or licensing-related
32 benefit under federal law or regulations.

33 (e) After a warning, a landlord or property manager may take action against a tenant if
34 the tenant's use of cannabis creates an odor that interferes with others' peaceful enjoyment of
35 their home or property.

36 **"§ 18D-413. Contracts enforceable.**

37 It is the public policy of this State that contracts related to the operation of a cannabis
38 establishment registered pursuant to this Chapter should be enforceable. It is the public policy of
39 this State that no contract entered into by a cannabis establishment or its employees or agents as
40 permitted pursuant to a valid registration, or by those who allow property to be used by a cannabis
41 establishment, its employees, or its agents as permitted pursuant to a valid registration, shall be
42 unenforceable on the basis that cultivating, obtaining, manufacturing, distributing, dispensing,
43 transporting, selling, possessing, or using cannabis or hemp is prohibited by federal law.

44 **"§ 18D-414. Respecting State law.**

45 (a) No law enforcement officer employed by an agency that receives State or local
46 government funds shall expend any State or local resources, including the officer's time, to effect
47 any arrest or seizure of cannabis, or conduct any investigation, on the sole basis of activity the
48 officer believes to constitute a violation of federal law if the officer has reason to believe that
49 such activity is in compliance with this Chapter, nor shall any such officer expend any State or
50 local resources, including the officer's time, to provide any information or logistical support
51 related to such activity to any federal law enforcement authority or prosecuting entity.

1 **(b) No agency or political subdivision of the State may rely on a violation of federal law**
2 **related to cannabis as the sole basis for taking an adverse action against a person.**

3 **(c) For the purposes of State law, actions related to cannabis are considered lawful as**
4 **long as they are in accordance with this Chapter.**

5 **"§ 18D-415. Rulemaking.**

6 **(a) Not later than 180 days after the effective date of this Chapter, the Department shall**
7 **adopt rules necessary for implementation of this Chapter. Such rules shall not prohibit the**
8 **operation of cannabis establishments, either expressly or through application, nor require such a**
9 **high investment of risk, money, time, or any other resource or asset that the operation of a**
10 **cannabis establishment is not worthy of being carried out in practice by a reasonably prudent**
11 **businessperson. Such regulations shall include all of the following:**

12 **(1) Procedures for the issuance, renewal, suspension, and revocation of a**
13 **registration to operate a cannabis establishment, with such procedures subject**
14 **to all requirements of Chapter 150B of the General Statutes.**

15 **(2) Rules, procedures, and policies to promote and encourage full participation in**
16 **the regulated cannabis industry by people from communities that have**
17 **previously been disproportionately harmed by cannabis prohibition and**
18 **enforcement and to positively impact those communities, which shall reflect**
19 **input from the Office of Community Reinvestment, including all of the**
20 **following:**

21 **a. Conducting necessary and appropriate outreach to diverse groups that**
22 **may qualify for participation in activities under this Chapter.**

23 **b. Requiring each cannabis establishment to establish and adhere to**
24 **policies that encourage diversity in employment, contracting, and**
25 **other professional opportunities.**

26 **c. Requiring any cannabis establishment with 25 or more employees to**
27 **retain a diversity officer.**

28 **d. Requiring each cannabis establishment to report on the diversity of its**
29 **workforce, management, contracts, and ownership by January 1 of**
30 **each year.**

31 **e. Issuing rules allowing historically impacted applicants to apply for,**
32 **and be licensed for, cannabis establishment registrations no less than**
33 **180 days prior to applicants that are not historically impacted**
34 **applicants.**

35 **(3) A Race to the Top scoring system to make the expansion of a cannabis**
36 **establishment to more than two locations contingent on the cannabis**
37 **establishment's contributions to equity and to benefiting the community. The**
38 **system must reflect input from the Office of Community Reinvestment and**
39 **shall include, but need not be limited to, considerations of diversity in the**
40 **cannabis establishment's ownership and workforce, including in management;**
41 **employment of reentering citizens with prior convictions; minority**
42 **ownership; compensation packages and benefits for workers; investing in**
43 **economically disadvantaged areas; whether the cannabis establishment**
44 **incorporates principles of environmental resiliency or sustainability, including**
45 **energy efficiency; or whether the principals are historically impacted**
46 **applicants.**

47 **(4) A limit on the number of cannabis establishments a major investor may invest**
48 **in, unless each additional establishment is owned and operated by a**
49 **historically impacted applicant.**

50 **(5) A schedule of reasonable application, registration, and renewal fees, provided**
51 **application fees shall not exceed five thousand dollars (\$5,000), with this**

- 1 upper limit adjusted annually for inflation, unless the Department determines
2 a greater fee is necessary to carry out its responsibilities under this Chapter.
- 3 (6) Qualifications for registration that are directly and demonstrably related to the
4 operation of a cannabis establishment and that may not disqualify applicants
5 solely for cannabis offenses prior to the effective date of this Chapter.
- 6 (7) Security requirements.
- 7 (8) Requirements for the transportation and storage of cannabis and cannabis
8 products by cannabis establishments.
- 9 (9) Requirements for the delivery of cannabis and cannabis products to
10 consumers, including a prohibition on business names, logos, and other
11 identifying language or images on delivery vehicles and a prohibition on
12 delivering to any address located on land owned by the federal government or
13 any address on land or in a building leased by the federal government.
- 14 (10) Employment and training requirements, including requiring that each
15 cannabis establishment create an identification badge for each employee or
16 agent. These requirements may not disqualify applicants solely for cannabis
17 offenses prior to the effective date of this Chapter.
- 18 (11) Requirements designed to prevent the sale or diversion of cannabis and
19 cannabis products to persons under the age of 21.
- 20 (12) Requirements for cannabis and cannabis products sold or distributed by a
21 cannabis establishment, including prohibiting any misleading labeling and
22 requiring cannabis product labels to include all of the following:
- 23 a. The length of time it typically takes for the product to take effect.
24 b. A disclosure of ingredients and possible allergens.
25 c. A nutritional fact panel.
26 d. Requiring opaque, child-resistant packaging, which must be designed
27 or constructed to be significantly difficult for children under 5 years
28 of age to open and not difficult for normal adults to use properly as
29 defined by 16 C.F.R. § 1700.20.
30 e. Requiring that edible cannabis products be clearly identifiable, when
31 practicable, with a standard symbol indicating that they contain
32 cannabis.
- 33 (13) Health and safety regulations and standards for the manufacture of cannabis
34 products and both the indoor and outdoor cultivation of cannabis by cannabis
35 establishments.
- 36 (14) Restrictions on advertising, marketing, and signage, including, but not limited
37 to, a prohibition on mass-market campaigns that have a high likelihood of
38 reaching minors.
- 39 (15) Rules to create at least six tiers of cannabis cultivation facilities, based on the
40 size of the facility or the number of plants cultivated and whether the
41 cultivation occurs outdoors, indoors, or in a greenhouse. Security regulations
42 and licensing fees must vary based on the size of the cultivation facility.
- 43 (16) Restrictions or prohibitions on additives to cannabis and cannabis-infused
44 products, including, but not limited to, those that are toxic or designed to make
45 the product more addictive.
- 46 (17) Prohibitions on products that are designed to make the product more appealing
47 to children, including prohibiting the use of any images designed or likely to
48 appeal to minors, including cartoons, toys, animals, or children, and any other
49 likeness to images, characters, or phrases that are popularly used to advertise
50 to children.
- 51 (18) Restrictions on the use of pesticides that are injurious to human health.

- 1 (19) Regulations governing visits to cannabis cultivation facilities and cannabis
2 product manufacturing facilities, including requiring the cannabis
3 establishment to log visitors.
- 4 (20) A definition of the amount of delta-9 tetrahydrocannabinol that constitutes a
5 single serving in a cannabis product.
- 6 (21) Standards for the safe manufacture of cannabis extracts and concentrates.
- 7 (22) Requirements that educational materials be disseminated to consumers who
8 purchase cannabis-infused products.
- 9 (23) Requirements for random sample testing to ensure quality control, including
10 by ensuring that cannabis and cannabis-infused products are accurately
11 labeled for potency. Unless the Department determines that remediation or
12 treatment is sufficient to ensure product safety, the testing analysis shall
13 include testing for residual solvents, poisons, or toxins; harmful chemicals;
14 dangerous molds or mildew; filth; and harmful microbials such as E. coli or
15 salmonella and pesticides.
- 16 (24) Standards for the operation of cannabis testing facilities, including
17 requirements for equipment and qualifications for personnel.
- 18 (25) Civil penalties for the failure to comply with rules made pursuant to this
19 Chapter.
- 20 (26) Procedures for collecting taxes levied on cannabis establishments.
- 21 (27) Requirements for on-site consumption establishments, including for security,
22 ventilation, odor control, and consumption by patrons. These rules may
23 include a prohibition on smoking indoors.

24 (b) After consulting with researchers knowledgeable about the risks and benefits of
25 cannabis and providing an opportunity for public comment, the Department shall develop a
26 scientifically accurate safety information label, handout, or both, which shall be available to each
27 adult-use cannabis consumer. The label or handout shall include both of the following:

- 28 (1) Advice about the potential risks of cannabis, including all of the following:
 - 29 a. The risks of driving under the influence of cannabis and the fact that
30 doing so is illegal.
 - 31 b. Any adverse effects unique to younger adults, including related to the
32 developing mind.
 - 33 c. Potential adverse events and other risks.
 - 34 d. Risks of using cannabis during pregnancy or breastfeeding.
- 35 (2) The need to safeguard all cannabis and cannabis products from children and
36 pets.

37 (c) The Department shall review and update the safety information materials at least once
38 every two years to ensure they remain accurate. The review period shall include soliciting input
39 from researchers knowledgeable about the risks and benefits of cannabis and an opportunity for
40 public comment.

41 (d) In order to ensure that individual privacy is protected, the Department shall not require
42 a consumer to provide a retail cannabis store with personal information other than
43 government-issued identification to determine the consumer's age and a retail cannabis store shall
44 not be required to acquire and record personal information about consumers.

45 "Article 5.

46 "Taxation and Use of Revenue.

47 **"§ 18D-500. Cannabis Regulation Fund.**

48 The Cannabis Regulation Fund is established in the Department. The Fund shall consist of
49 fees collected under this Chapter and appropriations made by the General Assembly to the Fund.
50 The Department shall administer the Fund, and funds in the Fund are hereby appropriated for the
51 purposes set forth in this Article.

"§ 18D-501. Cannabis excise tax.

(a) There is imposed a cannabis excise tax equal to thirty percent (30%) of the sales price of each sale of cannabis and cannabis products to a consumer. Sales to registered medical cannabis patients pursuant to applicable law are exempt from the tax imposed under this section.

(b) The tax imposed by this section shall be paid by the consumer to the cannabis establishment. Each cannabis establishment shall collect from the consumer the full amount of the tax payable on each taxable sale.

(c) On the fifteenth day of each month, every cannabis establishment that sells cannabis to consumers shall pay the excise taxes due on the cannabis that the cannabis establishment sold in the prior calendar month.

(d) The cannabis excise tax shall be separately itemized from the cannabis excise tax on the receipt provided to the purchaser.

"§ 18D-502. Cannabis local option tax.

(a) Any municipality may collect a cannabis local option tax of two percent (2%) of the sales price on each sale of cannabis and cannabis products to a consumer in the municipality. Sales to registered medical cannabis patients pursuant to applicable law are exempt from the tax imposed under this section.

(b) The cannabis local option tax may be adopted by a municipality that has provided (i) notice of the imposition and (ii) the amount to the Department of Revenue at least 90 days prior to the first day of the tax quarter when the cannabis local option tax will be collected.

(c) The tax imposed by this section shall be paid by the consumer to the cannabis establishment. Each cannabis establishment shall collect from the consumer the full amount of the tax payable on each taxable sale.

(d) On the fifteenth day of each month, every cannabis establishment that sells cannabis to consumers shall pay the local option taxes due on the cannabis that the cannabis establishment sold in the prior calendar month.

(e) The tax imposed by this section is separate from and in addition to the cannabis excise tax authorized under G.S. 18D-501. The tax imposed by this section shall not be part of the sales price to which the cannabis excise tax applies. The cannabis local option tax shall be separately itemized from the cannabis excise tax on the receipt provided to the purchaser.

"§ 18D-503. Apportionment of revenue.

Revenues generated in excess of the amount needed to implement and enforce this Chapter by the cannabis excise tax shall be distributed every three months as follows:

(1) Twenty-five percent (25%) shall be distributed to the Community Reinvestment and Repair Fund established by this Chapter.

(2) Ten percent (10%) shall be distributed to the Cannabis Enterprise Opportunity Fund established by this Chapter.

(3) Three percent (3%) shall be distributed to the Cannabis Education and Technical Assistance Fund established by this Chapter.

(4) Seven percent (7%) shall be distributed to the Department of Health and Human Services for use in evidence-based, voluntary programs for the prevention or treatment of substance abuse.

(5) Two percent (2%) shall be distributed to the Department of Health and Human Services for a scientifically and medically accurate public education campaign educating youth and adults about the health and safety risks of alcohol, tobacco, cannabis, and other substances, including the risks of driving while impaired.

(6) Two percent (2%) shall be distributed to the Department of Health and Human Services to fund diverse scientific, academic, or medical research on cannabis or endocannabinoids, including research exploring the benefits of cannabis, provided that all funded research data, results, and papers shall be released

1 into the public domain and shall be published for free and open access by the
2 public and by other researchers.

3 (7) Up to one percent (1%) shall be distributed to the Department of Public Safety
4 to fund Advanced Roadside Impaired Driving Enforcement and drug
5 recognition expert training.

6 (8) Any remaining funds shall be deposited in the General Fund."

7 **SECTION 1.2.** This Part becomes effective January 1, 2028, and applies to offenses
8 committed on or after that date.

10 **PART II. AUTOMATIC EXPUNCTION OF MARIJUANA OFFENSES**

11 **SECTION 2.1.** Article 5 of Chapter 15A of the General Statutes is amended by
12 adding a new section to read:

13 **"§ 15A-145.8B. Automatic expunction of certain marijuana offenses.**

14 (a) If a person was charged with an offense involving marijuana or hashish that is legal
15 under Chapter 18D of the General Statutes, and such person was convicted, such conviction shall
16 be ordered to be automatically expunged no later than July 1, 2028, in the manner set forth in
17 this section.

18 (b) The Administrative Office of the Courts shall determine which offenses meet the
19 criteria for expunction set forth in subsection (a) of this section. Upon completing the
20 determination required under this subsection, the Administrative Office of the Courts shall
21 provide an electronic list of the offenses to the clerk of each superior court. Upon receipt of the
22 electronic list required under this subsection, the clerk of each superior court shall prepare an
23 order of expungement for each case that meets the criteria set forth in subsection (a) of this section
24 and was finalized in his or her court. Upon completion of the order of expungement, the court
25 shall order the expunction. Upon order of expungement, the clerk shall forward the petition to
26 the Administrative Office of the Courts.

27 (c) No person as to whom such an order has been entered under this section shall be held
28 thereafter under any provision of any law to be guilty of perjury, or to be guilty of otherwise
29 giving a false statement or response to any inquiry made for any purpose, by reason of the
30 person's failure to recite or acknowledge any expunged entries concerning apprehension, charge,
31 or trial.

32 (d) The court shall also order that the conviction ordered expunged under this section be
33 expunged from the records of the court and direct all law enforcement agencies bearing record
34 of the same to expunge their records of the conviction. The clerk shall notify State and local
35 agencies of the court's order as provided in G.S. 15A-150.

36 (e) Any other applicable State or local government agency shall expunge from its records
37 entries made as a result of the conviction ordered expunged under this section. The agency shall
38 also reverse any administrative actions taken against a person whose record is expunged under
39 this section as a result of the charges or convictions expunged. This subsection shall not apply to
40 the Department of Justice for DNA records and samples stored in the State DNA Database and
41 the State DNA Databank."

42 **SECTION 2.2.** The Administrative Office of the Courts shall provide the list
43 required under G.S. 15A-145.8B(b), as enacted by this Part, by October 1, 2027.

44 **SECTION 2.3.** This Part becomes effective January 1, 2026.

SECTION 3.9. G.S. 105-113.108(b)(1) is repealed.

SECTION 3.10. G.S. 106-134(4) reads as rewritten:

"(4) If it is for use by man and contains any quantity of the narcotic or hypnotic substance alphaeucaine, barbituric acid, betaeucaine, bromal, ~~cannabis~~, carbromal, chloral, coca, cocaine, codeine, heroin, ~~marijuana~~, morphine, opium, paraldehyde, peyote, or sulphonmethane; or any chemical derivative of such substances, which derivative has been by the Board after investigation, found to be, and by regulations under this Article, designated as, habit forming; unless its label bears the name and quantity or proportion of such substance or derivative and in juxtaposition therewith the statement "Warning – May be habit forming.""

SECTION 3.12. G.S. 90-94.1 is repealed.

SECTION 3.13. This Part becomes effective January 1, 2028, and applies to offenses committed on or after that date.

PART IV. SAVINGS CLAUSE, SEVERABILITY CLAUSE, AND EFFECTIVE DATE

SECTION 4.1. Prosecutions for offenses committed before the effective date of this act are not abated or affected by this act, and the statutes that would be applicable but for this act remain applicable to those prosecutions.

SECTION 4.2. If any provision of this act or its application is held invalid, the invalidity does not affect other provisions or applications of this act that can be given effect without the invalid provisions or application and, to this end, the provisions of this act are severable.

SECTION 4.3. Except as otherwise provided in this act, this act is effective when it becomes law.
