SENATE BILL DRS45136-MGa-29

Short Title: Expand Sickle Cell Disease Programs & Svcs. (Public)

Sponsors: Senators Robinson and Lowe (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT APPROPRIATING FUNDS TO THE DEPARTMENT OF HEALTH AND HUMAN  
3 SERVICES, DIVISION OF PUBLIC HEALTH, TO EXPAND PROGRAMS AND  
4 SERVICES FOR NORTH CAROLINIANS WITH SICKLE CELL DISEASE.

5 Whereas, recent findings from the North Carolina Sickle Cell Data Collection  
6 Program funded by the Centers for Disease Control and Prevention (CDC) estimate that the  
7 number of individuals living with sickle cell disease in our State has risen to at least 7,000; and

8 Whereas, this represents a twenty-five percent (25%) increase from the previously  
9 estimated 5,578 persons living with sickle cell disease in our State from 2004-2008, based on the  
10 North Carolina Registry and Surveillance System for Hemoglobinopathies funded by the CDC;  
11 and

12 Whereas, the Department of Health and Human Services, Division of Public Health,  
13 requires additional State funds to ensure that essential services are available statewide to support  
14 the growing number of North Carolinians affected by sickle cell disease; Now, therefore,  
15 The General Assembly of North Carolina enacts:

16 **SECTION 1.** There is appropriated from the General Fund to the Department of  
17 Health and Human Services, Division of Public Health, the sum of one million six hundred  
18 seventy-eight thousand four hundred dollars (\$1,678,400) in recurring funds and six hundred  
19 twenty-nine thousand eight hundred seventy-three dollars (\$629,873) in nonrecurring funds for  
20 the 2025-2026 fiscal year; and the sum of one million six hundred seventy-eight thousand four  
21 hundred dollars (\$1,678,400) in recurring funds and six hundred thirteen thousand two hundred  
22 fifty dollars (\$613,250) in nonrecurring funds for the 2026-2027 fiscal year to be allocated and  
23 used as follows:

- 24 (1) Funds for comprehensive sickle cell medical centers. – The sum of one million  
25 three hundred sixteen thousand three hundred sixty-four dollars (\$1,316,364)  
26 in recurring funds for each year of the 2025-2027 fiscal biennium to be  
27 distributed in the following amounts to the following comprehensive sickle  
28 cell medical centers each fiscal year to support the multifaceted needs of  
29 individuals with sickle cell disease, including social and behavioral health  
30 services and assistance for young adults transitioning from pediatric to adult  
31 care:
- 32 a. Atrium Health. – The sum of two hundred three thousand seven  
33 hundred thirteen dollars (\$203,713).
  - 34 b. Duke University Medical Center. – The sum of two hundred forty-four  
35 thousand nine hundred ninety-nine dollars (\$244,999).



- 1 c. East Carolina University School of Medicine. – The sum of two  
2 hundred thirty-five thousand five hundred thirty-six dollars  
3 (\$235,536).
- 4 d. Mission Hospitals. – The sum of one hundred thirty-seven thousand  
5 six hundred one dollars (\$137,601).
- 6 e. The University of North Carolina at Chapel Hill School of Medicine.  
7 – The sum of two hundred eighty-one thousand thirty-one dollars  
8 (\$281,031).
- 9 f. Wake Forest University Baptist Medical Center. – The sum of two  
10 hundred thirteen thousand four hundred eighty-four dollars  
11 (\$213,484).
- 12 (2) Funds for one Transition Coordinator position at each comprehensive sickle  
13 cell medical center. – Of the funds allocated in subdivision (1) of this section,  
14 the sum of seventy-five thousand dollars (\$75,000) in recurring funds for each  
15 year of the 2025-2027 fiscal biennium shall be used by each comprehensive  
16 sickle cell medical center to create one full-time, permanent Transition  
17 Coordinator position at each medical center to conduct transition readiness  
18 assessments and other coordination activities to ensure a seamless referral  
19 process for individuals with sickle cell disease who are transitioning from  
20 pediatric to adult care.
- 21 (3) Funds to provide directed grants to community-based organizations. – The  
22 sum of three hundred fifty-three thousand two hundred fifty dollars  
23 (\$353,250) in nonrecurring funds for each year of the 2025-2027 fiscal  
24 biennium to award grants to one or more nonprofit corporations to provide  
25 services to individuals with sickle cell disease. In selecting grantees, the  
26 Department of Health and Human Services, Division of Public Health, shall  
27 prioritize community-based, nonprofit organizations that provide a  
28 comprehensive array of services to individuals with sickle cell disease, their  
29 families, and the surrounding community in counties that are lacking these  
30 services. Each grantee shall use a portion of their grant award to facilitate the  
31 transition of individuals with sickle cell disease from pediatric to adult care at  
32 the local level.
- 33 (4) Funds to support North Carolina Sickle Cell Syndrome Program operations. –  
34 The following amounts to the Women, Infant and Community Wellness  
35 Section of the Division of Public Health within the Department of Health and  
36 Human Services to support the operations of the North Carolina Sickle Cell  
37 Syndrome Program authorized by G.S. 130A-129:
- 38 a. The sum of three hundred sixty-two thousand thirty-six dollars  
39 (\$362,036) in recurring funds for each year of the 2025-2027 fiscal  
40 biennium to create additional full-time, permanent positions to support  
41 the work of the North Carolina Sickle Cell Syndrome Program.
- 42 b. The sum of sixteen thousand six hundred twenty-three dollars  
43 (\$16,623) in nonrecurring funds for the 2025-2026 fiscal year to  
44 purchase office equipment and furniture to support any positions  
45 created under sub-subdivision (4)a. of this section.
- 46 c. The sum of two hundred sixty thousand dollars (\$260,000) in  
47 nonrecurring funds for each year of the 2025-2027 fiscal biennium to  
48 disseminate an evidence-based sickle cell disease toolkit to emergency  
49 department providers throughout the State and to facilitate their  
50 implementation of the toolkit in order to improve emergency  
51 department care for patients with sickle cell disease.

**SECTION 2.** This act becomes effective July 1, 2025.
